Vermont Statutes Annotated

19 V.S.A. § 305. Measurement and inspection

§ 305. Measurement and inspection

(a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.

(b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.

(c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.

(d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.

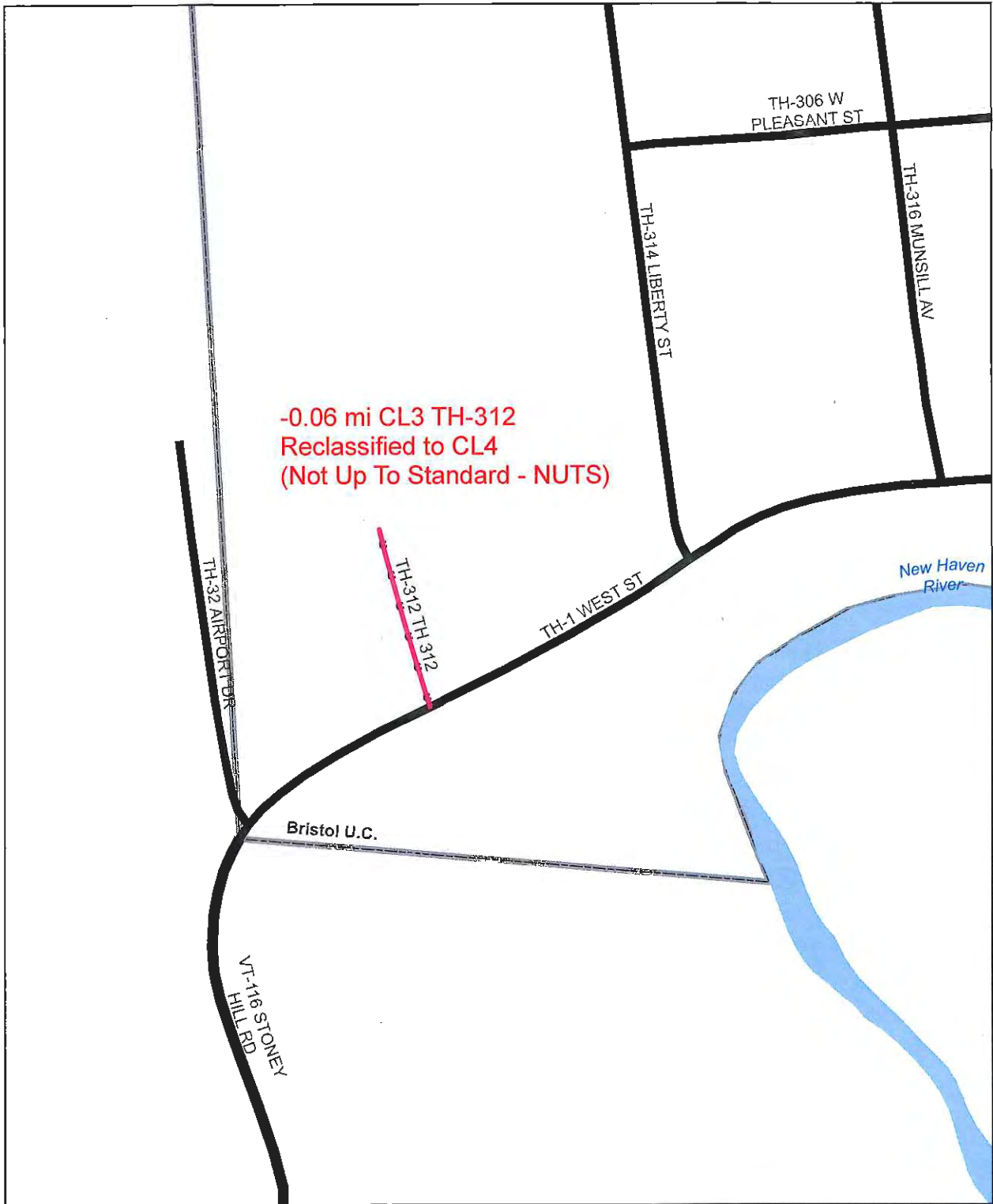
(e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.

(f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description, or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.

(g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate

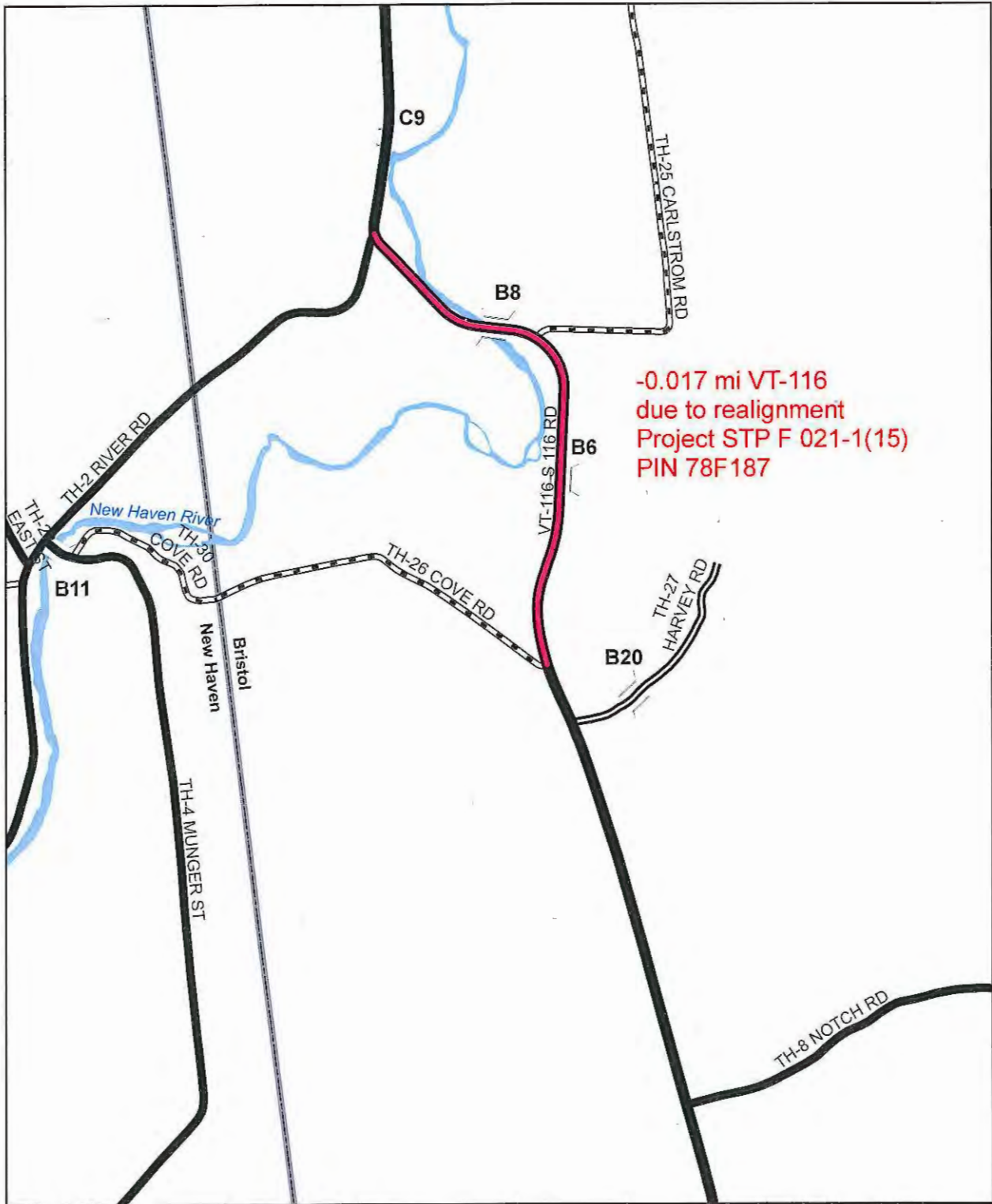


Mileage Certificate Change 2016

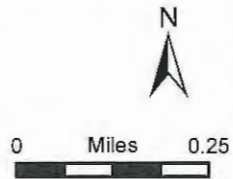


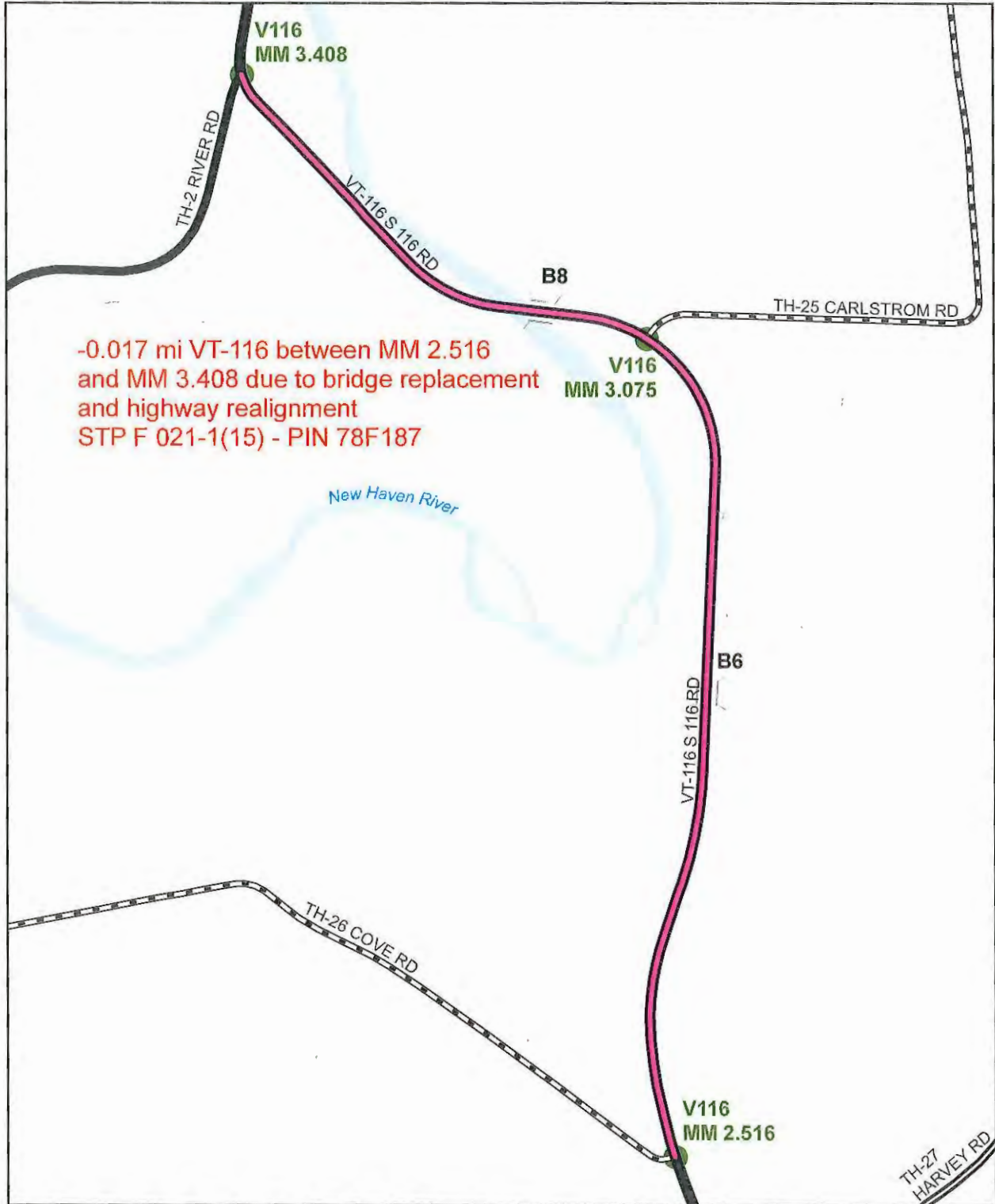

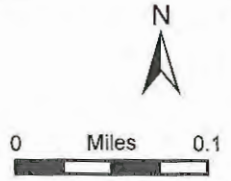

Good morning Sara,

We need to make another change in Bristol, as my prorating of mileage on VT-116 has improved the AOTMILES to ARCMILES correlation, but it has added 0.006 miles to the class 1 mileage. Looking at the data, I believe this issue can be solved by moving the class 1 – state highway break on the east side of Bristol UC to the west by 0.006 miles and have it better located to the signs in the field. This would then require an adjustment in the UC boundary to have it match the class 1 break.

We should chat about this change and potential ramifications.

Good afternoon Sara,

VT-116 in Bristol has been updated in the RDS geometry and had the AOTMILES updated. This is due to the update from the Bristol Flats project, STP F 021-1(15) 78F187. The route was reduced by 60 feet or -0.011 miles.

This project also affected the locations of B7 and B8 on VT-116, and I think that B7 has been effectively eliminated through the extension of B8. You can access the CADD plan sheets in the following directory, or add the following DGN to your file to see the bridge abutments and mainline:

Dear Ms. Compagna,

It has been brought to the attention of the VTrans Mapping Section that TH-312 (0.06 miles) in the Town of Bristol is not being maintained to class 3 town highway standards and I seek clarification from the Selectboard regarding this highway's classification. TH-312 is currently included in the class 3 town highway mileage and shown on the 2015 Bristol Urban Compact Map as class 3 by the Mapping Section, as can be seen on the attached maps.

On October 15, 2015, Michael Trunzo of Mapping performed a review of this highway and found that it is not being maintained to the class 3 standard defined in 19 V.S.A. § 302.

19 V.S.A. § 302. Classification of town highways**(3) Class 3 town highways:**

(A) Class 3 town highways are all traveled town highways other than class 1 or 2 highways. The selectmen, after conference with a representative of the Agency shall determine which highways are class 3 town highways.

(B) The minimum standards for class 3 highways are a highway negotiable under normal conditions all seasons of the year by a standard manufactured pleasure car. This would include but not be limited to sufficient surface and base, adequate drainage, and sufficient width capable to provide winter maintenance, except that based on safety considerations for the traveling public and municipal employees, the selectboard shall, by rule adopted under 24 V.S.A. chapter 59, and after following the process for providing notice and hearing in section 709 of this title, have authority to determine whether a class 3 highway, or section of highway, should be plowed and made negotiable during the winter. However, a property owner aggrieved by a decision of the selectboard may appeal to the transportation board pursuant to subdivision 5(d)(9) of this title.

(C) A highway not meeting these standards may be reclassified as a provisional class 3 highway if within five years of the determination, it will meet all class 3 highway standards.

I seek clarification from the Bristol Selectboard regarding the classification of TH-312 and whether it has been reclassified to trail or class 4, or if it has been discontinued. If neither has occurred and the Town does not plan to bring this highway back to class 3 town highway standards, I recommend that we deem this highway as "Not Up To Standard" and remove the stated aid funding in the upcoming 2016 Mileage Certificate.

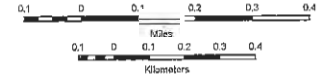

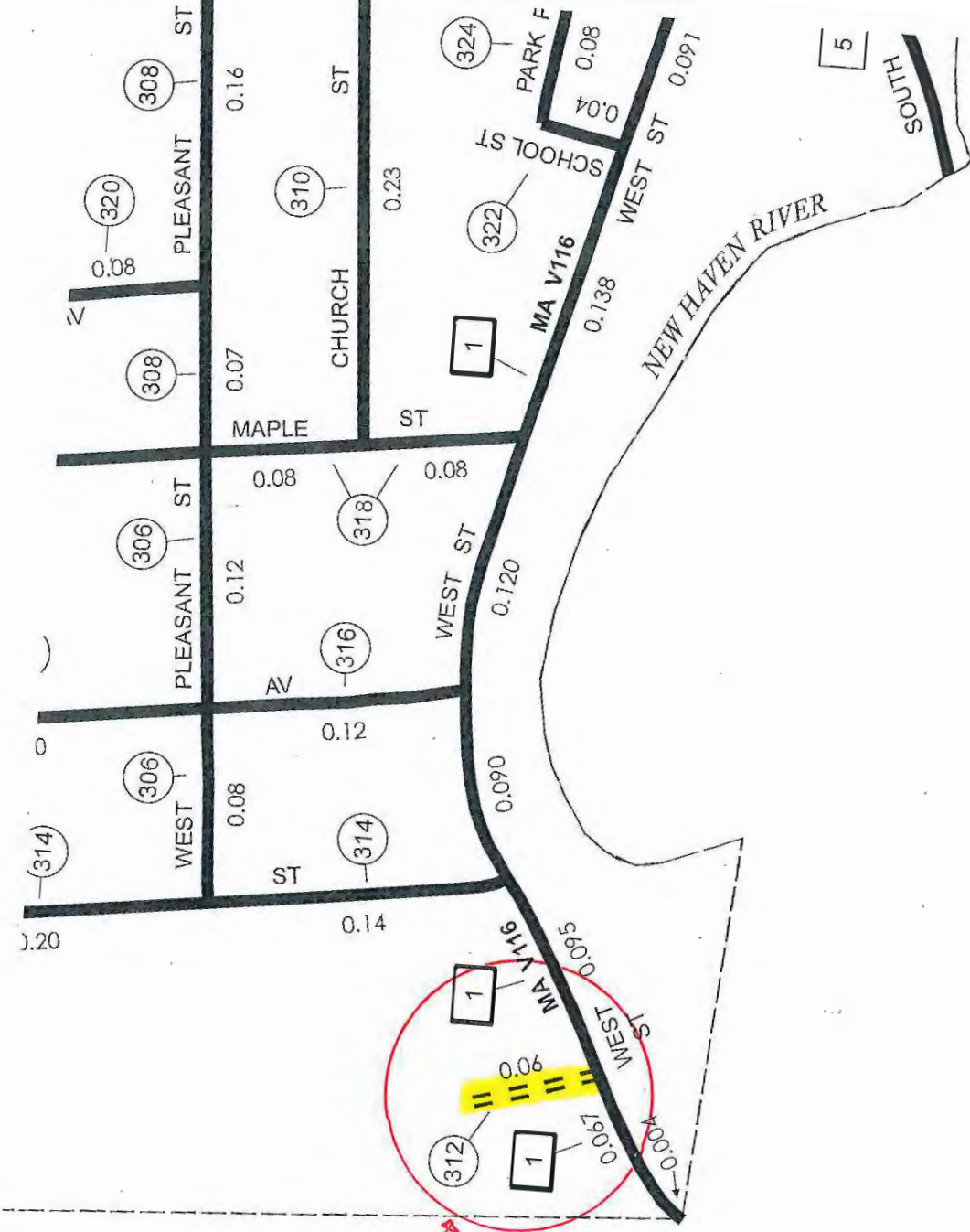
