

Below is a table summarizing the information on Legal Trails that is on file in the Mapping Unit. Act 178 of 2006 requires the measurement of trails be included on the sworn statement, the Mileage Certificate. To assist in this, we are providing a summary of the information we have on the trails that are shown on the Town Highway Maps, including mileage and former town highway number. The majority of trails were created by the reclassification of a town highway into a trail, thus the legal trail inherited an official measurement. The former town highway number is included in the FORMER_RTNAME column, and the former town highway mileage is in the AOTMILES column for each trail. VTrans has assigned a trail number, such as LT-1, to make the trails distinct. If the AOTMILES column is zero, the municipality will need to provide a mileage. The column ARCMILES contains the mileage as generated by the geometry of the trail, as digitized in the Geographic Information System (GIS). The mileages included in this table should be used as approximate mileages and the municipality should measure or verify the mileage of these trails.

A map showing the Legal Trail numbers and mileage has been included with this packet to further assist in this project. Any additional trails that exist should be added to the Mileage Certificate, as defined in the provided guidelines. 

SUBJECT: Proposed Glastenbury Road Classification Change

We have contacted DTA Joe Talbot concerning the proposed reclassification of Town Roads 1 and 2 in Glastenbury from Class 4 to Class 3. After a field inspection on September 15, 1994 with Mr. Talbot, we agree with his assessment that these roads are in better condition than some other Class 3 roads in his District, and with the addition of turnouts, guardrail, and brush cutting, could be plowed, although snow would have to be pushed one side or the other in some cases.

Attached is the paperwork for the 1982-1983 reclassification of these roads, which shows the procedures which have to be followed to make this change, and finally Highway Board approval.

If you read through the attached information, you will find that all of the property owners in 1983 were in favor of these roads being Class 4, and I wonder if they would back a change to Class 3 now.

Mr. Talbot will contact Ms. Mary N. Geannelis, the Glastenbury Supervisor, and discuss these changes with her and explain the procedure necessary to change these roads from Class 4 to Class 3, but the final decision to start the proceedings will be up to her.

Glastenbury is an unorganized town in District 1. There are several miles of public highway, all of which are designated as Class IV highways; however, the highways are all maintained and trafficable throughout the year.

In consideration that the bulk of these roadways are maintained in Class III condition, I suggest that we institute action to reclassify the roadways to Class III. This will have the effect of channeling some state revenue funds into the account so that maintenance will not be entirely supported by taxes paid by the property owners. This seems to be equitable in my view.

Please have your people work with DTA Joe Talbot on the remeasurement.

RECLASSIFICATION OF GLASTENBURY TOWN HIGHWAYS

Pursuant to the request presented to the Board, and after notice as required by Statute, a Hearing was conducted in the Shaftsbury Town
Office by Board Member Merton E. Snow, on December 15, 1982, at 7:30 P.M.

FINDINGS

- 1) There are no residents in the town which became unorganized by Act of the 1937 Legislature. There is one seasonal residence and one unoccupied residence.
- 2) There are two town highways; TH 1 which is 1.33 miles in length and TH 2 which is 1.56 miles in length.
- 3) TH 1 supplies access to a residence in the Town of Shaftsbury, adjacent to the Glastenbury town line. There is no other highway access to this residence.
- 4) TH 2 is used primarily by Glastenbury Timberlands Trust, a logging firm, which for several years has maintained the highway to the level required for its purposes.
- 5) Maintenance on TH 1 has been performed for several years by Transportation District #1. This has consisted of two weeks of work annually, limited to grading, graveling, ditching and installation of culverts.
- 6) The road is not plowed in the Winter. An exception to this practice occurred in the Winter of 1981-1982, when the highway was plowed to accommodate a pregnant woman who resided in the Shaftsbury residence described in Finding 3.
- 7) Property owned by the eight landowners in the Town is assessed at a total of \$1,195,478. Revenue received from the tax rate

of .50 on a dollar of the Grand List equalled \$5,977.39 in 1980.

8) Improvement of TH 1 to permit the operation of standard snow plowing equipment would involve an expenditure of from \$200,000 to \$300,000.

CONCLUSIONS

1) ".....the minimum standards for class 3 highways are a highway negotiable, under normal conditions, all seasons of the year by a standard manufactured pleasure car. This would include but not be limited to sufficient surface and base, adequate drainage and sufficient width capable to provide winter maintenance".

Section (a) (3) (B), Title 19, V.S.A.

2) "Class 4 highways may be maintained to the extent required by the necessity of the town, the public good and the convenience of the inhabitants of the town....."

Section 931 (2), Title 19, V.S.A.

3) "As the convenience of the inhabitants and the public good require, selectmen shall lay out, alter and discontinue highways. Pent roads and trails shall be deemed highways. Alteration includes a change in the order of a highway, as between open highways, pent roads and trails."

Section 292, Title 19, V.S.A.

4) "A town shall not be liable for the construction, maintenance or repair of a trail laid out under the provisions of Section 292 of this title."

Section 293, Title 19, V.S.A.

- 5) Glastenbury landowners and area residents at the Hearing unanimously agreed that minimal maintenance as conducted in the past should be continued on TH 1 and that this highway should be classified Class 4 over its entire length.
- 6) Similarly, it was agreed that a short section of TH 2 in the vicinity of a seasonal residence be reclassified Class 4 and that the remainder of TH 2 be classified as a trail with the full width of the right-of-way retained.

RECOMMENDATION

1) It is recommended that TH 1 in the Town of Glastenbury be classified as Class 4 over its entire length.

It is further recommended that the Transportation Board direct Transportation District No. 2 to continue maintenance on this highway at past levels to include grading, graveling, ditching and installation of culverts, such maintenance activities to be conducted in consultation with the supervisor.

2) It is recommended that TH 2 in the Town of Glastenbury be classified Class 4 from its intersection with TH 1 for a distance of 0.06 miles and that the remainder of TH 2 be reclassified as a trail with the full width of the right-of-way retained.

Board Member Merton Snow has concluded Hearing proceedings resulting from the proposal to reclassify town highways in Glastenbury. It was initially represented in submissions to the Board that the intention of the proposers was to reclassify a section of Town Highway 1 from its present-Class 3 status to Class 4 and to designate a segment of Town Highway 2 as a trail.

The Hearing process revealed that alternatively, the intention of the Glastenbury interests was to designate all of Town Highway 1 as Class 4, to reclassify a short segment of Town Highway 2 as Class 4, and the balance of Town Highway 2 to be designated as a trail.

It is the intention of Mr. Snow to submit Findings to the Board proposing Board approval of these changes.

This process has revealed that the Transportation Board is responsible for all Title 19 highway actions in gores and unorganized towns which are otherwise assigned to selectmen.

This includes among other things the reclassification process and the Section 15 requirement for measurement of town highways and the February 10 statement of description and condition of town highways.

The action to be taken by the Board in connection with the Glastenbury process will be effected formally by the Board's execution of the Certificate of Highway Mileage which must be filed by February 10.

I am not aware of the Agency's scheduling process for these forms. It would be helpful if the appropriate certificates for Glastenbury and the other unorganized towns and gores could be supplied for Board action at its next scheduled meeting on January 11.
