REPORT OF DOINGS

The Selectmen of the Town of Ryegate propose to discontinue Town Highway #50, and layout Town Highway #92 in the Town of Ryegate.

A copy of said Notice was posted in the Ryegate Town Clerk's Office on 100, 1997 and remained so posted until after March 24, 1997.

At 7:00 P.M. in the afternoon on Monday, March 24, 1997, the undersigned Selectmen of the Town of Ryegate met at the Ryegate Town Clerk's Office and immediately adjourned and reconvened at the site, at which time they examined the premises of the Highways proposed to be dicontinued and laid out. Following the examination, their meeting reconvened at the Town Office at 7:35 P.M. with the undersigned Selectmen and Town Clerk present as well as Rick Clough, Carmen Jordan, Allison Smith, Linda Rosa, and Clark Bogie, Town Road Commissioner. The Selectmen, after hearing all who indicated they wished to be heard and considering the matter decided that the public good, necessity and convenience of the inhabitants of the Town of Ryegate require that the highways in question be discontinued and laid out as hereinafter specified.

ORDER OF DISCONTINUANCE

I. DISCONTINUANCE OF TOWN HIGHWAY #50

Accordingly, it is hereby ordered that the following described Town Highway #50 be discontinued, with the discontinued land and premises thereof reverting to the land owner that abuts said discontinued road, namely, Ricky and Kelly Clough.

Being all of Town Highway #50 described as follows:

Commencing at the northerly end of Town Highway #50 at its intersection with the southerly right-of-way limits of U. S. 302; thence proceeding southerly through premises of Ricky Clough and Kelly Clough an approximate distance of .47 miles and crossing the Wells River to the southerly terminus of Town Highway #50 near the builings of Ricky and Kelly Clough.

II. LAYING OUT OF TOWN HIGHWAY #92

Accordingly, it is hereby ordered that the following described highway be laid out with the right-of-way being the width of the former railroad right-of-way upon which it is located and which is now owned by the Town of Ryegate:

Commencing on the northerly right-of-way limits of Town Highway #53 at its point of intersection with the southeasterly terminus of the former Montpelier and Wells River Railroad right-of-way now belonging to the Town of Ryegate; thence turnning northwesterly along the former railroad right-of-way adjacent to premises of Elsworth Frost Michael and Sarah Hobbs, Rodney and Carmen Jordan, the State of Vermont and Ricky and Kelly Clough to the Town line between the Towns of Groton and Ryegate for a total distance of approximately 5315 feet, more or less, or approximately 1.007 miles.

DAMAGE AWARD

No damages are awarded.

It is further ordered that the Town Highway maps be altered in accordance with this Order and that a copy of this Order be recorded in the Town Records.
