



FARLEY, husband and wife, both of East Ryegate, Vermont, Grantors, in consideration of One Dollar and Other Good and Valuable Consideration paid to our full satisfaction by the TOWN OF RYEGATE, a municipal corporation, in the County of Caledonia and State of Vermont, Grantee, have REMISED, RELEASED, AND FOREVER QUITCLAIMED unto the said Grantee, the TOWN OF RYEGATE, a municipal corporation duly organized and existing under the laws of the State of Vermont, and its successors and assigns, all right and title which we or our heirs have in and to a certain right-of-way for the purpose of maintaining and repairing certain public highways through certain lands in Ryegate, in the County of Caledonia and State of Vermont, described as follows, viz:

Being a certain right-of-way over and along Birchwood Drive held in common among the grantors herein, their heirs and assigns, to reach the land and premises of the grantors herein, from Town Highway #48.

For reference to same see Warranty Deed of Richard D. and Rebecca D. Nelson to David N. and Priscilla A. Longmoore dated December 12, 1965, and recorded in Book 27, Page 387 of the Ryegate Land Records.

Reference is also made to Quitclaim Deed of David L. Willis dated August 30, 1972, and recorded in Book 31, Page 58 of the Ryegate Land Records.

Said easement over said roadway is granted to a width of three (3) rods, the centerline of which shall be the centerline of said existing roadway.

There is also conveyed herein the right to layout, construct, maintain, operate, alter, repair, remove and replace at any time all culverts and ditches necessary and convenient for the proper maintenance of said road. AND FURTHERMORE, We, the said Grantors, do for ourselves and our heirs, executors and administrators, covenant with the said TOWN OF RYEGATE and its successors and assigns, that from and after the ensealing of these presents, the said Grantors will have and claim no right in or to the said quitclaimed right of way, except as aforesaid.

The said TOWN OF RYEGATE, for itself, its successors and assigns, by the acceptance hereof, agrees to exercise its rights hereunder without doing any unnecessary damage to the property of the Grantors. The Grantee shall, at the conclusion of each entrance or activity upon the property of the Grantors, restore the ground, to the extent not inconsistent with the rights herein granted, to a condition comparable to its condition before the work commenced. Any unnecessary damage done to the property of the Grantors, caused by the TOWN OF RYEGATE, or its agents or servants, shall be borne by the TOWN OF RYEGATE.
