

The Agency of Transportation was unable to approve the 2006 Mileage Certificate as submitted by the Town of Ryegate. There was not sufficient documentation supplied with the Certificate to show the Town followed the process defined in 19 V.S.A. § 701 – 819 – Chapter 7: Laying Out, Discontinuing and Reclassifying Highways. The core process is defined in 19 V.S.A. § 708 – 711 and covers the petition, public notice, hearing, survey, order of discontinuance, and Selectmen's return. This process defines several documents to be filed at the Town Clerks office related to the proceedings, including a survey of any newly laid out road and Selectmen's orders. The Agency requests copies of this documentation as evidence the process was followed. The section of statute that covers the Mileage Certificate process and the Agency's review and approval is listed below:

19 V.S.A.§ 305. Measurement and inspection

- (b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2 and 3 town highways, then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2 or 3 town highways are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.
- (c) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.
- (d) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description or classification of a town highway may appeal to the board by filing a notice of appeal with the executive secretary of the board.

The Selectmen's minutes of the meetings where action was taken provides an indication of the changes shown on the Mileage Certificate, but not enough detail is present to show the



requirements of Chapter 7 of V.S.A. Title 19 were followed. If the new section of highway was added through "dedication and acceptance", please provide information reflecting this.

The changes to mileage submitted by the Town are not reflected in the State of Vermont Highway Mileage Summary for 2006.

The Agency would like to work with the Town of Ryegate to have TH-17 noted as discontinued and all the changes to TH-70 and TH-71 reflected on the Mileage Certificate and map. Also, it seems that TH-69 was discontinued at some point when the paper mill expanded and it would be good to have this brought up to date as well.

The Agency will process the changes to the Ryegate highway mileage when the appropriate documentation has been submitted.





Fred will try to meet with him, some board members are willing to go. The crew had a report from Unifirst. They would like to buy new uniforms and pay a weekly fee to have them cleaned. This would cost: \$663 purchase x 3 men = \$1989 and \$3 a week to clean x 3men = \$9 a week. The board said to confirm the prices. Al moved having a field rep come and verify the contract in writing. Paul seconded the motion and it carried. Gordon asked about reimbursement for gas when he's pulling the culvert thawer behind his pick up. He will ask Heather how to handle it. Maybe the town can pay for rent of the truck by the hour. There was discussion on Jim Jones' recent letters to each board member. It was decided the road complaints don't reflect the true condition of the roads during a difficult year for plowing and maintenance. The Certificate of Highway Mileage was

discussed with .12 + .03 + .33 miles on TH # 70 and 71 being discontinued and 0.1 + 0.2 miles being added by the papermill. See the enclosed map. The motion was made by Albert Sponheimer, seconded by Paul Keenan and carried. The board feels this is housekeeping because most of this was changed around 1995 but maybe never sent in to the state. It was decided after advisement to take off .08 miles on TH # 17 as included on the map. The motion was made by Andrew Smith and seconded by Paul Keenan. The selectmen reviewed the Bridge Inspection Reports that recently arrived and signed the form to be returned to the Agency of Transportation. Fred will call Shanna Clifford at District #7 to see if someone can help the town will the Town Highway Class 2 Roadway Program. The road crew would like to go to a Small Tools Class in South Barre on February 23rd. The Board encouraged them to go and authorized a check being written for \$75 by the treasurer for enrollment.

Minutes of the January 23, 2006 meeting were read and approved with a motion from Paul seconded by Al that carried. The clerk will call a BCA meeting for Monday, February 27 at 7:00. Paul moved adjournment at 9:20 P.M. Al seconded the motion and it carried.





SELECTMEN'S MINUTES December 11, 1995

The meeting convened at 8:05 P.M. directly following the Board of Civil Authority Meeting. Members present: Theodore Clark, Gene Perkins, Andrew Smith. Also present: Lee Roy, Dwayne Hjulstrom, Linda Rosa, Marsha Nelson.

Treasurer's Report: The Selectmen viewed bills and signed orders. The town has received reimbursement from the Agency of Transportation for a paving project completed this summer.

Representatives from CPM were present to discuss the new road to the mill. They are anxious to use it as soon as possible. A list of what needs to be done was presented. The Selectmen are pleased with the road. The guardrails are all done. Stop signs will be added soon. The road can't be used before the town takes it over because an insurance company wouldn't cover an accident on it. While waiting for the road to be condemned the town is liable to maintain the road, afterwards its CPM's responsibility. The town can probably take care of the road this winter. CPM hopes to find an alternative to the boating access. Ted Clark moved and Andrew Smith seconded the motion that the Selectmen go ahead and accept the new town road with the town attorney's approval that all is finished. The motion carried.

The following people will be asked to serve on this year's budget committee along with the Selectmen, Dean Rowden, Elizabeth Beauvais, Bruce Stevens, Fremont Nelson, Wenda Hanson, Francis Collins. The budget meeting will be held January 15, 1996. The town received the proposed budget for Caledonia County. Minutes of the November 27, 1995 meeting were read and accepted as read on a motion from Andrew Smith, Seconded by Gene Perkins and carried.

Gene would like to see fuel supplies go out to bid on a yearly basis. The Clerk will check with several suppliers to see what the price per gallon would be for fuel oil, gasoline and diesel fuel. She will see how many gallons were used in 1994 or 1995 for budget purposes and call Jock Oil, Bradford Oil, Perry Oil and Gary's Fuels. This would cover the town clerk's office, There being no further business, the meeting adjourned at 9:25 P.M.
