
# 19 V.S.A. § 305. Measurement and inspection

## § 305. Measurement and inspection

- (a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.
- (b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.
- (c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.
- (d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.
- (e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.
- (f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description, or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.
- (g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate.



Hello Joy,

Thank you for calling to day to ask for clarification about my previous email below.

Could you ask the Selectboard Chair to confirm that he is aware that I am adding the notes (see below) to Hinesburg's 2019 Certificate of Highway Mileage? The notes are simply clarifying that the "Provisional" status that was placed on 0.10 mi of Mulberry Ln on the 2018 Certificate is no longer "Provisional". The Provisional status is what enabled us to process this segment of highway with the 2018 Certificate (so that the mileage was included in the 2018 annual mileage reports) before we had received the documentation demonstrating that it was legally established as a highway. My main reason for reaching out is so that the Town understands what the note means, has the opportunity to ask questions, and that I have correspondence to include in our records with the certificate that explains why the note was added. Essentially it's to help people digging through the records in the future understand what happened when.

Another example of a note added by me after receiving the Certificate can be seen on Hinesburg's 2018 Certificate, which can be viewed here:

Hello Joy,

I just realized that I should have added a note to Hinesburg's 2019 Certificate of Highway Mileage before sending it to the Town! But I think there is an easy solution to adding it...

Last year I received all the documentation needed to remove the "Provisional" status in our records from the first 0.10 mi segment of Mulberry Lane (class 3 TH-48). This does not change any mileage totals, as this segments mileage was already included with the class 3 totals. Adding the note to the Certificate (and removing the "Class 3 Provisional" note from the Town Highway Map) ensures that the clarification is officially documented in the appropriate records.

If you can pass this message on to the Select Board, and I receive a response saying it is ok with them, I can add the note with an explanation to the Certificate myself. I would also initial the note and attach copies of all email correspondence regarding it. A copy of the updated Certificate would then be returned to the Town once the updated Town Highway Map is complete and ready to send to you this summer.

After further discussions, I have confirmed that Mulberry Lane was first developed by Russell Barrone, DBA Mechanicsville LLC and sold to Bartlett Frisbie who further developed the addition of Mulberry Lane, Thorn Bush Road and Thistle Hill Road. All three roads (in totality) were turned over to the Town of Hinesburg on December 15, 2014 as was defined in the Selectboard Meeting Minutes. Furthermore there is no warranty deed for the Barrone portion of Mulberry Lane, so it appears we are at an end with this scavenger hunt.

I hope this helps and we can officially add the .46 miles to the Town of Hinesburg Highway mileage.

We are still working on discerning more information for the .56 miles of class 3 roads and .65 of class 4 road you asked about in your email yesterday along with continuing to work on the status of the NOTS.

In italics and bold is the answer to your first question and I'm still researching the 2<sup>nd</sup> question:

### IRREVOCABLE OFFER OF DEDICATION

This Irrevocable Offer of Dedication is made this day of d

#### WITNESSETH

WHEREAS, the Town's Development Review Board on August 30, 2002, issued final plat approval, and approval for development of a subdivision entitled "Ernest & Theresa Giroux 6-Lot Subdivision Mechanicsville Road—Mulberry Lane" consisting of a six-lot single family Planned Residential Development with two common areas of a 65-acre parcel located on the east side of the Mechanicsville Road;

WHEREAS, Mechanicsville, LLC, obtained title to Mulberry Lane by Warranty Deed of Ernest P. Giroux and Theresa D. Giroux dated October 18, 2002, and recorded on October 22, 2002, in Book 147 at Page 358 of the Town of Hinesburg Land Records. Hinesburg Hillside, LLC, obtained easements and rights of way over Mulberry Lane by Warranty Deed of Mechanicsville, LLC, dated December 21, 2007, and recorded on January 14, 2008, in Book 196 at Page 127 of the Town of Hinesburg Land Records;

WHEREAS, access to the Development is over a certain roadway designated as Mulberry Lane as shown on a final property survey entitled "Property Plat 7-Lot Subdivision" by George Bedard dated October 3, 2002, and recorded in Map Slide #46A of the Town of Hinesburg Land Records;

WHEREAS, said final approval from the Development Review Board obligates the Owners to make an Irrevocable Offer of Dedication of Mulberry Lane to the Town. When the Town of Hinesburg's Development Review Board approved the subdivision in 2002, it conditioned the approval on the Owners transferring Mulberry Lane to the Town; according to the August 22, 2002 minutes of the Development Review Board regarding the subdivision, "An Irrevocable Offer of Dedication shall be made to the Town of Hinesburg for the road serving this subdivision and included as part of this approval";

WHEREAS, the two owners intended to execute an Irrevocable Offer of Dedication several years ago but did not formally do so;

WHEREAS, the above described roadway right of way is hereby dedicated to the Town free and clear of all encumbrances pursuant to said final approval and as depicted on the Plan, except utility easements of record and access easements described in the attached Exhibit A.

**NOW, THEREFORE,** in consideration of the final approval of the Town's Development Review Board and for good and valuable consideration, the receipt of which is hereby acknowledged, it is covenanted and agreed as follows:

- 1. The Owners herewith deliver to the Town a deed of conveyance, an unexecuted copy of which is attached hereto as Exhibit A, said delivery constituting formal offer of dedication to the Town, to be held by the Town until the acceptance or rejection of such offer of dedication by the legislative body of the Town.
- 2. The Owners agree that said formal Offer of Dedication is irrevocable and can be accepted by the Town at any time.
- 3. The Owners agree that the maintenance of Mulberry Lane described herein shall be their responsibility prior to acceptance of ownership by the Town.
- 4. This Irrevocable Offer of Dedication shall run with the land and shall be binding upon the Owners and all assigns, grantees, successors, transferees and/or heirs of the Owners.
