19 V.S.A. § 305. Measurement and inspection

Policy. Planning & Intermodal Development Division

§ 305. Measurement and inspection

(a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.

(b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.

(c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.

(d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.


(e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.


(f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description, or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.

(g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate

NOTICE OF PUBLIC HEARING TO CONSIDE THE LAYING OUT OF AN EXTENSION OF PORRELL ROAD

Interested persons and persons owning or interested in lands through which the proposed extension of Porrell Road may pass or abut are hereby warned of a public hearing to be held by the Selectboard of the Town of Granby to consider the laying out of an extension of Porrell Road. Pursuant to 19 V.S.A. § 709, the proceedings will commence with an examination of the premises, convening at 1591 Porrell Road promptly at 6:00 pm. No testimony shall be accepted at the site visit. Immediately following the examination of the premises, the Selectboard of the Town of Granby will meet at the Town Office Building to receive testimony from any interested parties. The Selectboard shall issue a written decision within 60 days of the hearing.

Date of Hearing: December 29, 2015

Time of Hearing: 6:15 pm

Location of Hearing: Site visit at 1591 Porrell Road; immediately followed by public hearing at the Town Offices located at 9005 Granby Road, Granby, Vermont

Description of Highway: The proposed extension of Porrell Road (Town Highway #3) is to begin at the northerly terminus of the current town highway and extend approximately 1600 feet northerly to a granite monument at the northeasterly corner of the proposed three road (49.5') wide road.

The proposed extension of Porrell Road may be described more specifically as beginning at a 5/8 inch diameter reinforcing rod set in the ground on, or near, the easterly limits of the proposed extension of Town Highway #3 - Porrell Road. Said reinforcing rod being S 60°29′ E, 178.86 feet from a ½ inch diameter reinforcing rod marking the southeasterly corner of the Paul and Sylvia Laferriere property referenced in Book 17, Page 136-137 of the Granby Land Records, and being S 00°49′00″ W, 209.23 feet from a 5/8 inch diameter reinforcing rod with Vermont grid coordinates (NAD83 - 2011) N = 762090.27044 and E = 1834826.41564.

Thence N 28°54'45" E, along the proposed easterly limits of said Porrell Road extension, 121.24 feet to an unmarked point at the true point of beginning. Said unmarked point being N 85°11'35" E, 215.02 feet from the aforementioned ½ inch diameter reinforcing rod marking the southeasterly corner of the Paul and Sylvia Laferriere property.

Thence continuing N 28°54′45″ E, along the proposed easterly limits of said Porrell Road extension, 178.76 feet to an unmarked point.

Thence N 25°02'00" E, along the proposed easterly limits of said Porroll Road extension, 269.55 feet to a 5/8 inch diameter reinforcing rod set in the ground.

Thence N 22°56'05" E, along the proposed easterly limits of said Porrell Road extension, 362.00 feet to a 5/8 inch diameter reinforcing rod set in the ground.

Thence continuing N 22°56'05" E, along the proposed easterly limits of said Porrell Road extension, 537.00 feet to a 5/8 inch diameter reinforcing rod set in the ground.

Thence N 22°54'10" E, along the proposed easterly limits of said Porrell Road extension, 258.00 feet to a 9 inch x 10 inch x 5.5 foot granite post set in concrete with a 5/8 inch diameter reinforcing rod set in a drill hole. Said granite post marking the northeasterly corner of said Porrell Road extension and being S 39°39'35" E, 529.50 feet of a 5/8 inch diameter reinforcing rod with Vermont grid coordinates (NAD 83 – 2011) N = 763861.12319 and E = 1835195.32895.

Thence N 67°05'50" W, along the northerly end of the proposed Porrell Road extension, 49.5 feet to an unmarked point at the northwesterly corner of said road extension.

Thence S 22°54'10" W, along the proposed westerly limits of said Porrell Road extension, 257.98 feet to an unmarked point.

Thence S 22°56'05" W, along the proposed westerly limits of said Porrell Road extension, 898.08 feet to a ½ inch diameter reinforcing rod marking the southeasterly corner of the Glenn Roy property and the northeasterly corner of the Carl Borg property.

Thence S 25°02'00" W, along the proposed westerly limits of said Porrell Road extension, 267.0 feet to a one inch outside diameter iron pipe surrounded by stones at the southeasterly corner of said Carl Borg and the northeasterly corner of Paul and Sylvia Laferriere.

Thence S 28°54'45" W, along the proposed westerly limits of said Porrell Road extension, 177.04 feet to an unmarked point at the southwesterly corner of said Porrell Road extension and the northern terminus of the current Town Highway #3. Said unmarked point being N 76°12'40" E, 176.01 feet from the aforementioned ½ inch diameter reinforcing rod marking the southeasterly corner of the Paul and Sylvia Laferriere property.

Thence S 61°05'15" E, along the northerly terminus of said current Town Highway #3, 49.5 feet to the true point of beginning.
