

§ 305. Measurement and inspection

- (a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.
- (b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.
- (c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.
- (d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.
- (e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.
- (f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description, or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.
- (g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate

NOTICE OF PUBLIC HEARING TO CONSIDER THE DISCONTINUANCE OF A **PORTION OF TOWN HIGHWAY 34**

Interested persons and persons owning or interested in lands through which Town Highway 34 (also known as Overlook Lane) may pass or abut are hereby warned of a public hearing to be held by the Selectboard of the Town of Westmore to consider the discontinuance of the portion of Town Highway 34 past the 0.295-mile mark. Bill Perkins opened the Overlook Lane Hearing at 5:30 at Overlook Lane.

In attendance on-site were Bill Perkins, Burton Hinton, Dawn Wilcox, Ray LeBlanc and Jennifer Cleveland, *The Orleans Record*

The Board reviewed the section of Overlook Lane to be discontinued.

Upon returning to the Municipal Building, Burton moved and Bill seconded to discontinue Overlook Lane, Town Highway #34, at 0.295 miles from RT 5A and to sign the "Decision and Order of the Selectboard Upon Request for Discontinuance." Passed.

Burton moved and Bill seconded to adjourn the Overlook Lane Hearing.

Bill called the regular Selectboard meeting to order at 6:00.



On July_, 13, 2015, the Selectboard conducted a site visit and examined the premises at Town Highway #34, followed by a public hearing at the Westmore Town Office. Present at the site visit and at the public hearing were Selectboard members Bill Perkins and Burton Hinton. Town Highway 34 commences at the intersection of Route 5A and terminates at the .295 mile mark of Town Highway 34.
Based on the evidence presented at the site visit, the testimony at the hearing and pursuant to 19 V.S.A. § 710, the Selectboard hereby determines that the public good, necessity and convenience requires that Town Highway #34 be discontinued after the .295-mile mark as measured by a nu-metrics DMI Model #NS-5, Serial # D006557.
Any person interested who objects to this decision may appeal pursuant to 19 V.S.A. § 740 and Rule 74 of the Vermont Rules of Civil Procedure to the Vermont Superior Court, Orleans Unit, Civil Division within 30 days of the
