



Hello Pete,
I'm glad we had a chance to speak earlier today while we were looking at the same images. Pictures are worth a thousand words!
I've attached a map showing the corrected endpoints of the Class 3 and Class 4 portions of TH-30 (Old Cottage Ln, not Carriage Ln as I wrote above in the email subject line). The map lengths of the Class 3 and Class 4 sections (when rounded to the nearest 0.01 mi) are 0.52 mi and 0.06 mi, respectively. The lengths are based on the Class 3 portion ending at the far side of the turnaround, as you indicated during our conversation. The total map length of TH-30 also matches the 0.58 mi measure obtained in 1984 when VTrans conducted a field inventory (see attached inventory for TH-30) with Mr. Gosnell (Selectboard member at the time, I believe).
This change can be written on the 2021 Mileage Certificate as a remeasurement:
+0.02 mi CL3 TH-30 (Old Cottage Ln) remeasured

Good afternoon Peter,

I hope all is well so far this winter in Westmore. This has been a challenging year!

Could you answer a few questions for me that will help us make sure we are "on the same page" about whether the mileage added to TH-30 should be class 3 or class 4? Please also refer to the attached letter with map sent to the Selectboard along with the 2020 Mileage Certificate closeout letter for additional context for my questions.

The documentation for the reclassification of TH-30 processed by VTrans in 2007 indicates that it ends at an existing turnaround:

Selectboard Meeting November 17, 2006 Page 2

John brought up Al Brisard's request at the road re-classification hearing asking for a cost benefit analysis of the work needed on Old Cottage Lane. Whether it is Class III or Class IV, it will need about \$5,000.00 in culverts and drainage to improve the runoff issue.

David moved and John seconded the motion to reclassify the portion of Old Cottage Lane from Lakeview Road up to the existing turn-around (exact mileage to be determined at a later date) from a Class IV town highway to a Class III town highway. The motion passed unanimously.

Is the parking/turn-around area shown in the images below the one being referred to in the description above? This turn-around is also labeled on the map accompanying the attached letter. Does the class 3 highway end at the near (southern) or far (northern) side of the turnaround?





Can you tell me which line on either of the following two images best indicates the end of the public right of way for TH-30?





If the turn-around shown is indeed the end of the class 3 section of TH-30, then we will need to add class 3 mileage. Whether or not we need to add class 4 mileage also depends on where the end of the class 3 section is located.

Thanks again for your help making sure that our data accurately reflects the extent of TH-30, and feel free to reach out to me if you have additional questions,
