

Using the "Circle of Stones" as the center (or close) of the road would work. Hi Pam,

These maps (attached) from the E911 Viewer Maps might help. To locate them, I entered a search for 275 Chittenden Rd, Chittenden, VT. The E911 mappers may be able to help with distances.

Photo A gives a wider view of the intersection. The upper dot is the Civil War monument. If you look further south and a little to the east of that dot, over the bridge, along Mountain Top Road you will see another dot. That was a planter known as the Circle of Stones. In the reconfiguration of the road, that was eliminated as it became almost the center of the new section of road. In other words, Mountain Top Road continued from the east side of the monument, across the bridge (as before) and straight to the place of the Circle of Stones to join Dam Rd.

Before, the Dam Road/Chittenden Rd intersection started at the southernmost split slip of Mountain Top Road. I would assume that has now moved to the point of the intersection (the former Circle of Stones). Therefore, Chittenden Rd would be a smidgin longer, and Dam Rd would be likewise shorter.

I hope these maps help. I will continue to search for better maps.



Can you provide any guidance?


