

# TH 11 RECLASSIFICATION REPORT

A/K/A "SHORT CUT ROAD"

Select Board members Abbott, Powers, Haines and Bender met at the east end of Town Highway 11, a/k/a "Short Cut Road" at 8:30am on October 10, 2022 per Notice of Hearing published in the Vermont News Guide and sent by certified mail to all persons identified in paragraph 1 19 V.S.A.709.

The Board members walked the length of the road and observed extensive wash outs, and an active landslide that continues to wash toward Flower Brook.

Hearing was called to order at 9:30am at the Danby Town Office. Letters supporting the reclassification of TH11 from a Class 3 to a Class 4 road were received from Vermont Department of Forest, Parks & Recreation, Hauser Family Farm LLC, and Andrea Martin.

The Select Board members agreed unanimously in favor of reclassifying TH11 to a Class 4 Trail.

Motion to adjourn at 9:40 by Powers/Haines passed unanimously.

## TOWN OF DANBY, VERMONT DECISION ON RECLASSIFICATION OF SHORT CUT ROAD (TOWN HIGHWAY 11)

WHEREAS, on September 8, 2022, the Town of Danby Selectboard, on its own motion, initiated proceedings to consider reclassifying, from Class 3 to Class 4, Short Cut Road (T.H. 11) in its entire 0.20-mile length from Lilly Hill Road (T.H. 5) to Danby Pawlet Road (T.H. 1); and,

WHEREAS, notices of the time and date for examining the premises and hearing persons interested were sent in accordance with 19 V.S.A. §709, namely by mailing notice via certified mail to each interested person at least thirty days in advance, by giving notice to the Danby Planning Commission, by posting a copy of the notice in the office of the Danby Town Clerk, and by causing a copy of the notice to be published in the Vermont News Guide, a local newspaper of general circulation in the area, not less than ten days before the time set for the hearing; and,

WHEREAS, on October 10, 2022, the Selectboard conducted an examination of the premises and on October 16, 2022, held a public hearing where it took testimony regarding whether the reclassification of Short Cut Road would serve the public good, necessity, and convenience of the inhabitants of the Town of Danby;

NOW, THEREFORE, based upon the inspection and the evidence presented at the hearing, the Danby Selectboard makes the following findings of fact:

- 1. Short Cut Road (T.H. 11) is a Class 3 town highway running 0.20 miles from the intersection of Lilly Hill Road (T.H. 5) to Danby Pawlet Road (T.H. 1), as depicted on the plan titled "Vermont General Highway Map Town of Danby," prepared by the Vermont Agency of Transportation, and dated June 29, 2022.
- 2. Short Cut Road is minimally traveled and receives little public use. There are no bridges on Short Cut Road and no other infrastructure, such as retaining walls or box culverts, in which the Town has made any significant investment of public funds. No public resources or assets (e.g., state-owned land or town forest) are served by Short Cut Road.
- 3. Short Cut Road is adjacent to Flower Brook. The bank between Short Cut Road contains an active slide area. Continuing to maintain Short Cut Road to Class 3 standards while addressing the slide would require a significant investment of public funds. Reclassification of Short Cut Road from Class 3 to Class 4 would relieve the Town of Danby's obligation to provide summer and winter maintenance, reducing the burden on Danby taxpayers.
- 4. None of the abutting property owners or the Danby Planning Commission have provided any objection to the proposed reclassification of Short Cut Road.

WHEREFORE, based on these findings, and pursuant to 19 V.S.A. §710, the Selectboard concludes that the reclassification of Short Cut Road from Class 3 to Class 4 will serve the public good, necessity, and convenience of the inhabitants of the Town of Danby and hereby Orders that Short Cut Road (T.H. 11) be reclassified from Class 3 to Class 4 in its entire 0.20-mile length from Lilly Hill Road (T.H. 5) to Danby Pawlet Road (T.H. 1).

This Order and its incorporated findings, together with a copy of the minutes of the Selectboard's October 16, 2022 hearing, shall be filed with the Danby Town Clerk for recording. A copy of this Order shall also be mailed, via first-class mail, to each person who received written notice of the Selectboard's examination and hearing.
