



Notes for VTrans Certificate of Highway Mileage

- As previously reported to VTrans, the 0.13 mile portion of Class 4 TH #47 (Channing Lane) was thrown up by the Town in the summer/fall of 2016 and is now a private road. See attached Select Board minutes and correspondence sent to the State
- 2. CORRECTION: The westernmost 0.10 portion of TH # 32 (Hubbardton Road) is Class 4, while the other 0.37 section of TH #32 north of Fire Hill Road is Class 3 highway. This is not a re-classification. This short stretch of road has always been Class 4 and the Town does not maintain it.

Minor Points for Map Changes

- 3. The portion of TH #32 (Hubbardton Road) north of TH #31 (Fire Hill Road) is gravel (not dirt, as currently depicted on Map).
- 4. TH #11's (Sugar Hollow Road) northernmost section is gravel (not dirt, as currently depicted on Map). Indeed, all of TH # 11 is gravel.
- 5. TH #12 (Ager Road) is gravel (not dirt, as currently depicted on Map).
- 6. The central portion of TH # 38 (Goat Farm Road) is gravel (not dirt, as depicted on Map). Indeed, all of TH #38 is gravel.
- 7. The southernmost portion of TH # 31 (Fire Hill Road) is gravel (not dirt, as depicted on Map).

Meeting Minutes: Town of Pittsford Select Board Meeting July 6, 2016

Town of Pittsford Select Board Meeting July 6, 2016

The meeting was called to order at 6:30PM by Thomas "Hank" Pelkey, Chairman.

Select Board members present: David Trombley, Thomas Hooker, W. Joseph Gagnon, and Thomas "Hank" Pelkey. Absent: Jane Cornell. Also present: Bonnie Bourne, Mark Winslow, Ann Rademacher, Jim Rademacher, Bill Gallus, Jake Gallus, Jeff Biasuzzi, John Haverstock, and Kelly Giard – Recording Secretary.

J. Haverstock indicated that there was a need for Executive Session for a personnel issue. Motion by T. Pelkey and seconded by T. Hooker to enter into Executive Session for personnel. Motion passed unanimously 4 – 0.

Motion by T. Pelkey and seconded by T. Hooker to accept the agenda as printed. Motion passed unanimously 4 - 0.

MINUTES

The Select Board minutes from the June 15, 2016 Select Board meeting were signed, with no corrections.

ORDERS

The orders in the amount \$34,636.40 (FY 16); \$115,197.38 (FY 17) and \$16,006.09 (Payroll) were approved with the following discussion:

- J. Gagnon inquired about the expense for waste oil. J. Haverstock stated that this \$145 amount was an annual fee to haul the waste oil away from the Transfer Station.
- J. Gagnon inquired about the expense for police raptor radios. J. Haverstock explained that this was for cruiser upgrades and would be paid with grant funding.

TOWN MANAGER'S REPORT

J. Haverstock reported on the following:

- Both of the historical markers have now been received. The marker for Kendrick Dam will be installed by the Highway Department. The marker for the history of furnaces in Pittsford will be unveiled by the Historical Society at the Town Green in the near future.
- The Listers reported that 48 grievences were received with a majority being resolved. The deadline to grieve before the Board of Civil Authority is July 14. The
 Select Board will need to hold a brief special meeting to set the tax rates.
- There will be a staff meeting on July 7, 2016 at 9:00 AM. Members of the Select Board are invited to attend.
- There is an article in the packet from VLCT Atty. Garrett Baxter regarding fireworks sales.
- · Jason Davis, the Emergency Management Director, is encouraging Select Board members to attend an Incident Command Seminar on August 23, 2016 from 2:00 PM 4:00 PM in the Municipal Office Conference Room. This seminar is entitled ICS402.
- · Thank you to Select Board members for being available to sign fiscal year-end orders on June 29, 2016.
- The Planning Commission will be meeting on July 7, 2016 at 7:00 PM to vote on the Draft Zoning Ordinance, which will be formally received by the Select Board on July 20, 2016.
- The Town Manager will be on vacation for the week of July 25, 2016.
- J. Gagnon stated that he attended a recent Planning Commission meeting and feels that they are doing a good job on their projects.

PUBLIC COMMENT

Jim Rademacher was present to update the Select Board on the progress that the Trustees of Public Funds have made with regard to the Burditt Fund. The Trustees have sought the opinion and input of the Attorney General and all parties agree that the Select Board and the Pittsford residents that are serving on the Otter Valley Unified Board must agree unanimously to the expenses that occur with the fund.

Mr. Rademacher stated that in the research of the Burditt Fund, the Pittsford Fund and the Kelley Fund are administered by the Trustees of Public Funds, however, the Pinney Fund was discovered and has not been listed in Town Reports after 2010. J. Haverstock will discuss this with Helen McKinlay to find a status of the fund and will advise at a future meeting.

Mr. Rademacher and Mr. Rob Howland are currently seeking replacements for their positions on the Trustees of Public Funds and will not be seeking reelection.

The Select Board thanked the Trustees of Public Funds for working on the Burditt Fund and obtaining answers.

Jeff Biasuzzi, Zoning Administrator, stated that the Planning Commission would be working on a short questionnaire at their July 7, 2016 meeting to be included in the newsletter seeking input on the Town Plan.

OLD BUSINESS

Continued Discussion of Enacting an E911 Ordinance:

J. Haverstock included a newsletter information piece in the packet for review. The Select Board agreed to include the information in the next newsletter, in lieu of proceeding with adoption of an ordinance.

Updated on Pittsford Day Planning:

The Planning Commission will have an information booth set up at Pittsford Day. There will be a filer posted in the newsletter, on the website and around Town. T. Hooker stated that there is a need for Silent Auction items.

Update on Village Sidewalk Project:

- J. Haverstock stated that Markowski Excavating has addressed drainage issues and completed the subbase for the sidewalk. The soil tests for the retaining wall have been completed. Two catch basins needed to be moved due to conflicts with the water main.
- T. Hooker had raised questions, which were addressed by the design engineer. The retaining wall will be 2.7 feet above the sidewalk at its highest point; whoever is currently cutting the grass on the slope will continue to maintain; the catch basins issue was due to the submission drawings which did not show proper location of the water line.

Following much discussion on the height of the retaining wall, J. Haverstock will invite the design engineer and Markowski Excavating to the site to discuss the grade of the slope.

Consider Request of Mr. Gallus to Change Process for Handling Neighbor's Permit Application:

- J. Haverstock summarized the recent presentation by Mr. Gallus concerning a possible conflict of interest on the part of Zoning Administrator Jeff Biasuzzi.
- J. Haverstock stated that he met with Mr. Gallus and Mr. Biasuzzi and had a discussion with Ms. Wright-Garcia. Both Biasuzzi and Ms. Wright-Garcia deny any business relationship regarding her property.
- Mr. Gallus stated that he is just trying to protect his land. Mr. Gallus stated that he is looking for a stormwater study and stormwater plan for the property. Mr. Gallus felt that these discussions should have been in a closed meeting and not a public discussion.
- D. Trombley stated that he feels that the Select Board "owes" it to the residents to address any concerns that are brought to the Select Board.
- D. Trombley stated that Mr. Gallus is in need of answers and a resolution. However, the Select Board does not want to create a precedent of by passing the normal permit application procedure. Mr. Biasuzzi explained the statutory appeal process available to Mr. Gallus, if Mr. Gallus does not like the outcome of Mr. Biasuzzi's handling of the Kennedy's pending permit application.

The Select Board stated that there will be no further Select Board involvement in this matter, and with no motion, considered the issue "dead".

Mr. Bill Gallus and Mr. Jake Gallus exited at 7:12 PM.

The Select Board recessed and convened a Public Hearing at 7:12 PM.

Consider Throwing Up Class 4 Section of Channing Lane:

- J. Haverstock stated that the public hearing was to discuss the "throwing up" of 0.13 miles of Channing Lane at the request of Mark Winslow, in a document submitted on April 6, 2016.
- J. Haverstock explained that the required letters were sent to the property abutters, there was a Select Board site visit, newspaper postings and posting in 3 public places.
- J. Haverstock stated that there is no objection on behalf of the Town or the Highway Foreman, who stated that there has only been one occasion for maintenance on this road in the last 30 years.
- J. Haverstock read the provisions of the State Statute.
- D. Trombley inquired if there had been any communication from Jim and Beth Richards. Mr. Winslow stated that Ms. Richards was present at the initial meeting and stated no objection. Mr. Winslow currently maintains the road.

Motion by D. Trombley and seconded by T. Hooker to accept the abandonment of Channing Lane and instruct the Town Manager to follow through with communications to the State, as required in the Statute. The motion passed unanimously 4 – 0. J. Haverstock stated that he would be in contact with Dave Soulia, Chairman of the Planning Commission for their input on the matter.

The Public Hearing was adjourned at 7:18 PM.

The Select Board reconvened at 7:18 PM.

Mr. Winslow and Mr. Biasuzzi exited at 7:20 PM.

NEW BUSINESS

Review Final Inspection Report for Access/ROW Permit:

J. Haverstock stated that the initial Right of Way permit for the Wheelers was issued 10 years ago and now the project is finished. The Select Board agreed to authorize the Board Chair (T. Pelkey) to sign the permit.

Remarks from Bonnie Bourne Regarding Ownership of School Property:

Bonnie Bourne was present to discuss the ownership of the school properties in Town. Ms. Bourne stated that the Otter Valley Union Unified (OVUU) Board began legal operation on July 1, 2016 and conducted deed searches on the properties. The result of this research was that the Town owns the main building and land of the Lothrop school and the School District owns the Town Hall, blue house, parking lot and the Caverly property. The Lothrop School Board exists for one more year. However, it would be easier and more cost-effective to convey to the OVUU than to Lothrop then to the OVUU.

T. Pelkey stated that the Pittsford residents voted to combine under Act 46. However, the Haunted House is a concern as it is on the Caverly property, which is owned by the School District. Ms. Bourne will take this concern back to the OVUU for discussion. However, feels that there is no issue with the continuing of the Haunted House.

The Board unanimously agreed to convey the Lothrop School property to the OVUU.

J. Haverstock inquired what would happen with the snow removal at the school, once the Unified Board takes over. The Board agreed for the Town Manager to discuss this with the Superintendent and have the OVUU take over this task.

Ms. Rademacher inquired if Town Meeting would still occur at the Town Hall. T. Pelkey stated that this could be an included provision in any transfer.

Ms. Bourne exited at 7:35 PM.

OTHER BUSINESS

None presented at this time.

EXECUTIVE SESSION

T. Pelkey made a motion, and seconded by T. Hooker, to go into Executive Session for personnel and legal where premature knowledge would be damaging to the Town, and may be jeopardized by public disclosure.

In accordance with 1 VSA 312 (b), where premature general public knowledge would clearly place the Municipality or person the Board unanimously agreed to enter into Executive Session for the purpose of Personnel at 7:51PM, with Town Manager He Executive Session.	
The Select Board exited Executive Session at 8:03 PM, with no action taken.	
The meeting adjourned at 8:03 PM.	
The next regular meeting of the Select Board will be held on July 20, 2016.
