

Good afternoon Michael,

In completing the data update for the Town of Proctor, I realized there was a slight discrepancy in the mileage in the line work for the intersection change for TH-2, TH-20 and TH-52 (School and Cross St). When I removed the School St. Fork of 0.03 mi and recalculated the mileage for TH-2 at the intersection, it was only +0.2 miles and not +0.30 miles as I previously estimated. The section of TH-20 to be added to TH-2 was really only 0.01 mi, not 0.02 mi.

The mileage update will be as follows and I have attached the updated the attached certificate, which we will sign on our end and get back to you.

- -0.03 mi CL2 TH-2 (School St. Fork)
- +0.02 mi CL2 TH-2
- -0.01 mi CL3 TH-52 to be added to TH-2
- -0.02 mi CL3 TH-20: remeasured and 0.01 mi to be added to TH-2.

The total **Class 2** mileage will be **7.060 miles** and the **Class 3** mileage will be **11.85 miles**. Can you please share this update with the Selectboard for me and let me know if they approve?

Hi Celia and Michael,

I wanted to let you know that the VTrans mapping section has noticed a change in alignment for TH-2 due to an intersection reconfiguration. A section of road used to connect Cross St. and School St., but now there is a T intersection. We can update for the next Town Highway Map for Proctor in 2023.

The image below shows the 0.03 mile-long road section (highlighted in blue) that we will remove from our roads data, which will affect the total mileage for TH-2, TH-20, and TH-52. The 0.02 mile-long section of TH-20 south of the intersection and the 0.01 mile-long section of TH-52 both highlighted in yellow below, will become part of TH-2. Once I make the changes I will have a more accurate measure of the mileage change.

The following will be the approximate mileage changes:

TH-2: Most likely no change (6.600 mi - 0.03 mi + 0.02 mi + 0.01 mi= 6.600 mi)

TH-20: 0.27 miles to 0.25 miles **TH-52:** 0.1 miles to 0.09 miles



If you could please inform the selectboard of this change and let me know if you have any questions. We will be sending a mileage certificate in the new year that will show the mileage changes for yours and the selectboard signatures at that time.
