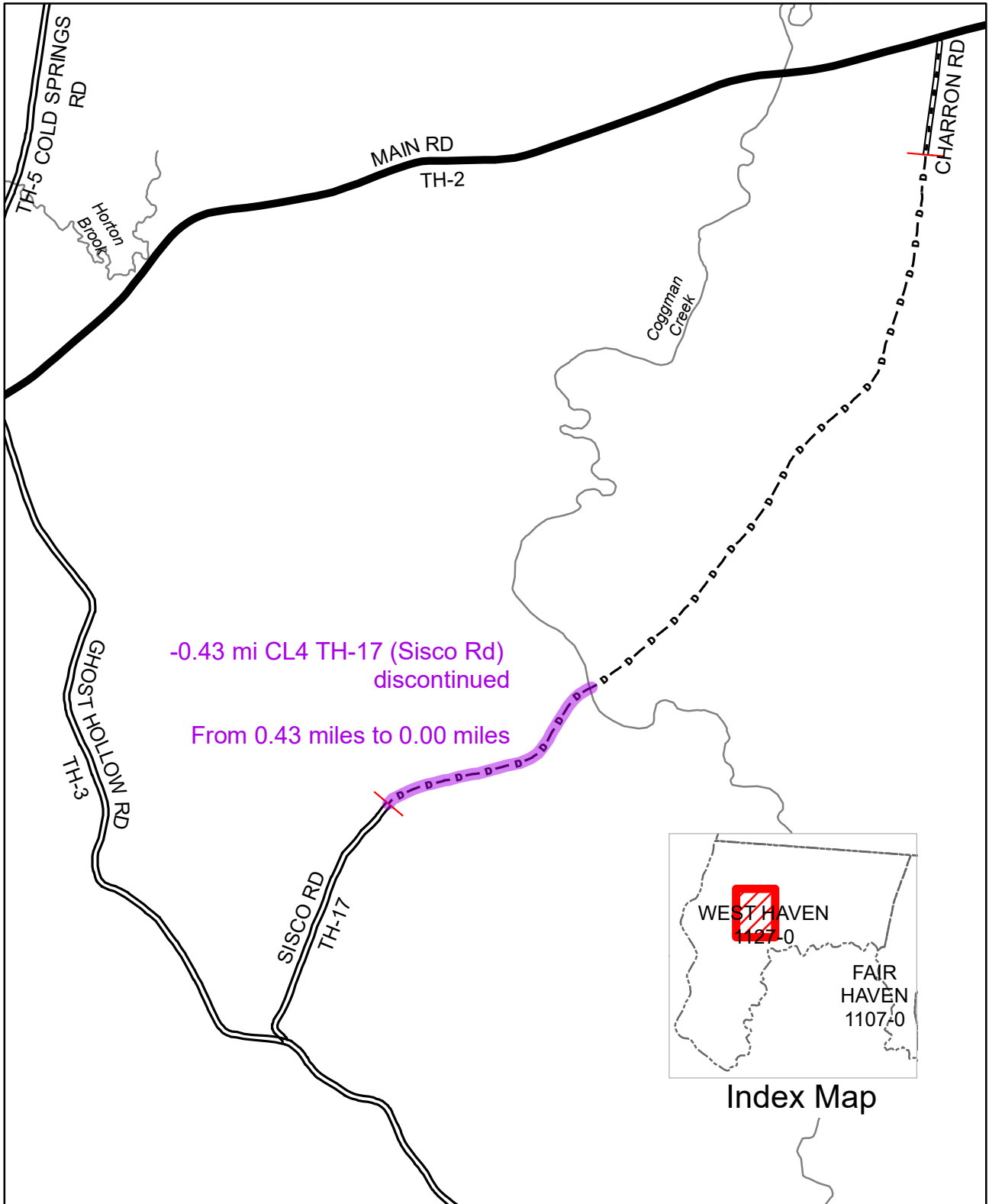

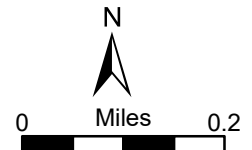

**TOWN OF WEST HAVEN VERMONT
DECISION AND ORDER OF THE SELECTBOARD TO DISCONTINUE
THE CLASS 4 PORTION OF TOWN HIGHWAY 17, SISCO ROAD**

Introduction. On April 12, 2022 at a Regular Meeting of the West Haven Selectboard a verbal request was received from five West Haven citizen or property owners to have the Selectboard discontinue the Class 4 portion of Town Highway 17 (Sisco road) north from the southern boundry of the Book Brothers property to the end of the existing highway and have it removed from the town highway map (AR-¹). The Board agreed by motion and vote to consider this request. (AR-²) By e-mail dated April 13, 2022, a letter dated April 12, 2022 was received “requesting the discontinuance of the portion of Sisco Road from the Book Brothers property boundary through Parcel ID Number (230) 180.145 to the end of the road and to remove the road from the West Haven Town Highway map (AR-³) This matter was further discussed at a Special Meeting on April 26, 2022 (AR-⁴) The Board noted the receipt of the written petition which was accepted for processing by motion and vote. It was provided that the property owners bordering that section of road would be notified of the petition. Further that a site visit (examination) and hearing would be scheduled for Friday June 3, 2022 (AR-⁵)

Procedure.

- 1) **Generally.** The Laying Out, Discontinuing, and reclassification of Highways is governed by Title 19, Chapter 7, Subchapter 2 of the Vermont Statutes.
- 2) **Petition.** Section 708 (19 V.S.A. 708) provides that a petition may be filed by, “persons who are either voters or landowners and whose number is at least five percent of the voters....” Section 708 also provides, “The Selectboard may also initiate these proceedings on its own motion.

Finding: Discontinuance of the Class 4 portion of Town Highway 17 (Sisco Road) is properly before the Selectboard for processing and decision.

- 3) **Notice and Hearing.** The requirements for Notice and Hearing in a Discontinuance Proceeding are set forth in 19 V.S.A. 709:
 - a) “The Selectboard shall promptly appoint a time and date both for examining the premises and hearing the persons interested...” This requirement was met by the Selectboard at their meeting on April 26, 2022
 - b) “...and give 30 days notice to the petitioners, and to persons owning or interested in lands through which the highway may pass or abut, of the time when they will inspect the site and receive testimony....” Petitioners and abutters were notified by Certified Mail of the date and time of the site inspection (examination) and hearing. AR-⁶
 - c) “The Selectboard shall also give notice to any municipal planning commission in the town,

post a copy in the office of the town clerk, and cause a notice to be published in a local newspaper of general circulation in the area not less than ten days before the time set for the hearing.” The West Haven Planning Commission was notified by copy of the letter (AR-⁶) that was sent to petitioner and abutters on April 29, 2022. An appropriate notice (AR-⁷) was posted in the office of the Town Clerk on April 28, 2022. A notice was also published in a local newspaper on May 13, 2022. (AR-⁸)

Finding: The procedural requirements of 19 V.S.A. 709 have been met.

4) Examination and Hearing. At 9:00 a.m. on June 3, 2022 the West Haven Selectboard met at the intersection of TH-17 (Sisco Road) and TH-3 Ghost Hollow Road to examine the road. Thereafter TH-17 was examined. At the completion of the examination, the proceeding was recessed to the West Haven Town Office for hearing. (AR-⁹)

5) Findings of Fact.

a) Location. On the 2017 Vermont Agency of Transportation Highway Map, TH-17 is identified as a .52 mile Class 3 Highway starting at TH 3 (Ghost Hollow Road) and continuing North for .43 miles as a Class 4 Road. From the North TH 17 is a .16 mile class 2 road known as Charron Road. The remainder of TH-17 between the Northern section and the southern section is shown as discontinued. This depiction is consistent with historical maps that show the loss of the TH-17 road sometime between 1901 and 1947. Petitioners have submitted a copy of a document filed on January 13, 1976 which confirms the discontinuance of TH-17 from a point .16 miles south of the intersection of TH 2 to the former location of the Arthur Sisco place. (AR-¹⁰)

b) Characteristics of Town Highway 17 (Sisco Road). As shown on the Robert N. Tinker Survey of the Southern portion of TH-17 (Sisco Road) (AR-¹¹), the Class 3 portion of river road begins at the intersection of TH-3 (Ghost Hollow Road) and proceeds towards the north to the Jackson/Book boundry line. This boundary as set forth in the survey are two pins on either side of the road. Based on two site visits made to this location on June 2, 2022 and June 4, 2022, Pin #1 on the Tinker Survey is located on the east side of Sisco Road at GPS coordinates N 43.6373, W 073.3833.(TH-¹²) Pin # 2 is located on the west side of Sisco Road to the north of Pin #1 at GPS coordinates N 43.6374, W 073.3831.(TH-¹³) The remainder of the road to the north of these two pins is identified on the Survey as a Class 4 road.

6) Conclusion and Decision.

1. Based on the evidence and exhibits presented at the examination and hearing, and as otherwise documented in the Administrative Record, the board finds that Town Highway #17 also known as Sisco Road is a Class 3 Town Highway which extends from TH-3 (Ghost Hollow Road) North to a boundry line located by reference to two pins set on either side of the road. Pin #1 being located on the east side of TH-17 at GPS coordinates N 43.6373, W 073.3833, and Pin # 2 being located on the west side of the road to the north of Pin #1 at GPS coordinates N 43.6374, W 073.3831.

2. That TH-17 continues north from this boundry line as a Class 4 road to the end of the road.


3. That the remainder of TH-17 from the end of the current class 4 portion of the road North to a point .16 miles South of the intersection of TH-2 and TH-17 TH-2, was lawfully discontinued by action of the West Haven Selectboard on January 13, 1976. (AR-10)

ORDER: Wherefore the Selectboard of the Town of West Haven finds that the public good, necessity and convenience of the inhabitants of the municipality require that the Class 4 portion of TH-17 should be and hereby is discontinued effective this 15th day of June, 2022, and the right-of-way which lies on the road is hereby returned to the owners of the property upon which the right-of way lies.

Introduction. On June 15, 2022 the West Haven Selectboard discontinued the Class 4 portion of Sisco Road. The Board’s decision contained several substantive mistakes which are corrected below.

Corrections are keyed to the line of the Board’s original decision:

55 a) Location. On the 2017 Vermont Agency of Transportation Highway Map, TH-17 is
56 identified as a Class 3 Highway starting at TH 3 (Ghost Hollow Road), travelling north for

58 shown as a .16 mile class 3 road known as Charron Road. The remainder of TH-17 between
59 the northern section and the southern section is shown as discontinued. This depiction is
60 consistent with historical maps that show the loss of the central portion of TH-17 sometime
61 between 1901 and 1947. Petitioners have submitted a copy of a document filed on January
62 13, 1976 which confirms the discontinuance of TH-17 from a point .16 miles south of the
63 intersection of TH 2 to the former location of the Arthur Sisco place. (AR-¹⁰)


65 b) Characteristics of Town Highway 17 (Sisco Road). As shown on the Robert N. Tinker
66 Survey of the Southern portion of TH-17 (Sisco Road) (AR-¹¹), the Class 3 portion of Sisco
67 Road begins at the intersection of TH-3 (Ghost Hollow Road) and proceeds towards the
68 north to the Jackson/Book boundry line. This boundary as set forth in the survey are two
69 pins on either side of the road. Based on two site visits made to this location on June 2, 2022
70 and June 4, 2022, Pin #1 on the Tinker Survey is located on the east side of Sisco Road at
71 GPS coordinates N 43.6373, W 073.3833.(TH-¹²) Pin # 2 is located on the west side of Sisco
72 Road to the north of Pin #1 at GPS coordinates N 43.6374, W 073.3831.(TH-¹³) The
73 remainder of the road to the north of these two pins is identified on the Survey as a Class 4
74 road.




Line 66 & 67. Sisco Road is correct.

ORDER: Wherefore the Selectboard of the Town of West Haven finds that the public good, necessity and convenience of the inhabitants of the municipality required that the Class 4 portion of TH-17 should be and was discontinued effective the 15th day of June, 2022, and the Town’s right-of-way thereto was lawfully returned to the owners of the property upon which the right-of way lied. These errata changes are to clarify the record in this matter and have no other effect in law or in fact as to the discontinuance of the Class 4 portion of Sisco Road.

Call to Order: The Examination of Sisco Road was called to order by Chairman Ethier at 9:15am. The proceeding was then turned over to the designated hearing official, Jon Dodd

The Hearing Official read the petition to discontinue the Class 4 portion of Sisco Road, and take it off the town highway map. The Hearing Official made a brief statement as to the purpose of the road examination and invited those present to make comments as appropriate.

Discussion:

- If the decision is made to discontinue the Class 4 portion of Sisco Road, the town will continue to plow snow up to the end of the Jackson property line. The snow will be pushed to the side of the road and the town truck will back up and turn around. This is the current process followed by the road crew.
- David Charron would like an agreement that he will be able to access his back land for logging if desired. The potential purchaser agrees to that and a written agreement will be completed by and between the two of them. The Town will have no interest or participation in such an agreement.

The Examination was recessed at 10:00 am to immediately convene for the Sisco Road Hearing at the Town Office.

Sisco Road Discontinuance Hearing. The Hearing was convened at the Town Office and called to order at 10:06 am by Jon Dodd, Hearing Official.
