Dear Mr. Harvey,

Please find the enclosed copy of the 2022 Certificate of Highway Mileage for the Town of West Rutland. The VTrans Mapping Section has not accepted the addition of TH-45 that was provided with the 2022 Certificate of Highway Mileage for the Town of West Rutland, due to some remaining questions regarding the legal establishment of this road as a town highway. Based on information that we have received so far, the extension to TH-45 was subject to the Transportation Board decision (TB-432) for break in limited access in 2016 and a subsequent Section 1111 access permit (Permit ID 41124). There were stipulations for the submittal of documentation to the Mapping Section showing the acceptance and establishment of this town highway. Here are excerpts from those documents:


(Excerpt from T-Board Order TB-432, Conclusion of Law, Item 8)

 The portion of the new access road located within the Route 4 limited access highway right-of-way must be accepted by the Town of West Rutland as a town highway.

(Excerpt from VTrans Permit ID 41124, Special Conditions)

As a condition of this permit, the portion of roadway constructed within the limited access highway (US4) shall be accepted by the Town of West Rutland as a town highway. All appropriate forms and submittals shall be prepared and submitted to the Agency of Transportation's Mapping Section upon completion of the construction of the new highway.

Based on the project plans for the construction of US-4, project West Rutland–Rutland (F 020-1(10), the extension of TH-45 that intersects TH-5 (Boardman Hill Road) was noted at parcel 7B and was owned at that time by the Town as access to the sewer plant. This parcel seems to have been acquired by the AOT for the construction of US-4 and then relinquished back to the Town of West Rutland. This provides us with insight that the underlying parcel is town property, but the information that we seek is the establishment of the highway that is the extension of TH-45 from the former terminus of TH-



45 in the parking lot of the ball field for approximately 215 feet (0.04 miles) to the intersection of TH-5 (Boardman Hill Road).

Since there was a break in limited access and Transportation Board decision, as well as the 1111 access permit, there must be some level of documentation regarding the construction and acceptance of this road as a highway by the Town of West Rutland. We are seeking any Selectboard minutes, construction plans for the extension, and documentation showing the legal establishment of this road as a highway. Once we have received this documentation, we will be able to add the 0.04 miles of TH-45 extension to the mileage certificate and town highway map for West Rutland.

We have reached out to some folks here at VTrans and have gathered some information regarding the access from Boardman Hill Rd. (TH-5) to TH-45 near Route 4 in West Rutland. We understand that there was a Transportation Board decision in 2016 to approve the access point from TH-5 and that there was a ROW permit was issued in 2016 (Permit ID 41124) with the special condition to send necessary paperwork regarding the construction of the road to the Mapping Section. If you could please send us this documentation by early next week, we could perhaps add the road segment to the 2022 Mileage Certificate. This would include any construction plans and legal documentation of the building, laying out and acceptance of the road on behalf of the selectboard. Hi Mary Ann,

Thank you for understanding and we will look into this a bit more. Yes those are the measures I have for TH-45 (CL3 = 0.15 and CL4 = 0.28). I am still not clear however on the measure to add for next year. 0.005 miles is only 26.4 feet. The distance from the end of TH-45 as it is now on the town highway map to TH-5 as shown below from Google Maps is approximately 215 feet or about 0.04 miles according to my measurements. Once we would know more accurately what the layout of the road is, we could get a better measure. You would want to

clarify the measure with the Selectboard as well.

Hi again Mary Ann,

I wanted to follow up with you on the change you added to the 2022 Mileage Certificate for West Rutland. I looked back through maps starting in the 1940s, and we do not have a record of this portion of TH-45 as a Town Highway. We are trying to close out the 2022 certificates this week so we are thinking of waiting to possibly add this to the certificate next year if the Town can provide us with the necessary documentation that the process of adding this section of road was followed. I will make the adjustment on the 2022 certificate before we sign and send back to you.

One question I have also is the mileage you provided for the addition of TH-45. When I measure out the connection between the currently mapped end of TH-45 to TH-5, I get 0.05 miles, not 0.005 miles as you indicate on the certificate. Where did you get the 0.005 miles? That would be a very short addition to TH-45 if it was 0.005 miles.
