WHEREAS, pursuant to 19 V.S.A. 708(a), the Selectmen initiated proceedings to consider the reclassification of the following Town Highways:

T.H. #52 - Colson Road

T.H. #10 - Clausen/Register Road

T.H. #64 - Murphy Road

T.H. #44 - Shaneburger Road

WHEREAS, the Selectmen appointed a public hearing for this purpose to be held on November 22, 1993 at 7:00PM at the Municipal Building, 26 South Main Street, Northfield, Vermont, to consider this reclassification and gave due notice thereof as required by 19 V.S.A. 709;

ORDER OF DISCONTINUANCE

NOW COME the Trustees of the Village of Northfield, Vermont, pursuant to 19 V.S.A. §771:

WHEREAS, pursuant to 19 V.S.A. §708(a), the Trustees initiated proceedings to consider the discontinuance of a portion of Maple Street as a public street;

- (b) On October 21, 1993, notice in the form annexed as Exhibit C was hand delivered to the Joint Planning Commission of the Town and Village of Northfield.
- (c) On October 21, 1993, notice in the form annexed as

WHEREAS, the scheduled public hearing and site inspection having concluded and the Trustees having determined that the public good, necessity, and the convenience of the inhabitants of the municipality so require;

IT IS HEREBY ORDERED as follows:

- 1. That all of Maple Street is hereby discontinued as a public street along it's entire length starting at the intersection of Cross Street and thence running Easterly approximately 133' to the end also being 33' wide, water lines, sewer line, and drainage lines, and all electric power lines are reserved and shall remain unimpaired by this discontinuance, and further, EXCEPT that the Village shall retain the right to drain and flow surface water drainage from Cross Street and adjacent sidewalks and related drainage facilities onto the area formerly occupied by Maple Street and thence onto adjoining properties.
- The discontinued Street shall not be designated as a trail pursuant to 19 V.S.A. §775.

- No person or property owner having sustained damage by this discontinuance, no damage shall be paid.
- 4. This Order shall be recorded forthwith by the Town Clerk in the Northfield Land Records.
