Title 19. V. S. A. Section 15 Amended 1973 Act No. 63

SEC. IS. MEASUREMENT OF HIGHWAYS

THE THE SELECTION OF THE PROPERTY OF THE

- (a) A representative of the board in the presence of the selectmen or their designee shall measure the class 1, 2, and 3 town highways at least once every ten years.
- (b) Annually, an or before February 10, the selectmen shall, after review by a representative of the board, file with the town clerk a sworn statement of the description and measurements of all class i, 2, and 3 town highways, then in existence. When class i, 2 and 3 town highways are discontinued or re-classified by statutory procedure, a copy of the proceedings shall be filed in the clerk's office and forwarded to the board. When new class i, 2 or 3 town highways are built or added pursuant to the statutes, a copy of the town records as filed in the clerk's office showing the selectmen's certificate of completion containing a detailed description of said highways shall be forwarded to the board.

(c) No mileage shall be accepted for the purpose of this chapter until the records required to be filed in the clerk's office by this section are received by the board.

Title 19, V. S. A. Section 1019 Act No. 58 of 1977

Sec. 1019. TOWN SCENIC ROADS; DESIGNATION AND DISCONTINUANCE

- (a) On recommendation of the planning commission of a municipality, or on the initiative of the legislative body of a municipality, such a legislative body may, after one public hearing duly warned for such a purpose, designate or discontinue any town highway or portion thereof as a town scenic highway. Such action by the legislative body may be petitioned by the registered voters of the municipality pursuant to the provisions of section 1973 of Title 24.
- (b) A town scenic road may be reconstructed or improved in a manner consistent with the standards established by the transportation board, pursuant to section 425 of Title ID. A class I. 2 or 3 scenic highway shall be eligible to receive aid pursuant to the provisions of section I7 of this title.
- (c) The legislative body of a municipality may appeal for a variance from standards promulgated by the transportation board. In such appeals the board's decision shall be final.
