





Town Highway 39 - (which is not recognized by the Selectmen as a Town Highway but is being noticed for discontinuance hereunder pursuant to landowner petition rights and to legally clarify the status of said road) - a portion thereof; commencing at a point along the westerly side of said road where dwelling buildings owned by and located on lands of Peter and Lynn Stuart are currently erected; thence northeasterly along the general contour of said road a distance of 1200 feet, or an estimated .23 miles, to a point on said road, which extends to the northerly boundary of the said Stuart land.

Further notice is hereby given that on the 11th day of March, 1987 we shall examine the aforesaid premises through which said roads pass and at 7:00 p.m. of said day at the Town Clerk's office in said Town, shall hear all parties interested on the question of the public necessity or convenience for the discontinuance of said roads, or portions thereof.

REPORT AND ORDER OF ROAD DISCONTINUANCES

We, the undersigned Selectmen for the Town of Woodbury, County of Washington and State of Vermont, pursuant to 19 VSA Section 344, having conducted a hearing this date, at 7:00 p.m. at the Town Clerk's office in Woodbury, Vermont, after due notice to all parties entitled to be heard thereon, and after hearing and giving due consideration to the statements of all parties who appeared, including a letter request by the Vermont Department of Forest, Parks and Recreation requesting designation of that portion of Town Highway #39 being discontinued to TRAIL status, hereby issue the following report and order concerning the following Town Roads:

Town Highway 53 - in its entirety, beginning at its junction with Town Highway 33, thence westerly an estimated distance of .10 miles, to its end point easterly of Town Highway 6, said Highway 53 being bordered on both sides by Carol G. Handy only.

Town Highway 39 - (which is not recognized by the Selectmen as a Town Highway but is being noticed for discontinuance hereunder pursuant to land owner petition rights and to legally clarify the status of said road) - a portion thereof; commencing at a point along the westerly side of said road where dwelling buildings owned by and located on lands of Peter and Lynn Stuart are currently erected; thence northeasterly along the general contour of said road a distance of 1200 feet, or an estimated .23 miles, to a point on said road, which extends to the northerly boundary of said Stuart land.

WHEREAS, we, the said Selectmen:

1. were properly petitioned to discontinue the aforesaid Town Roads, pursuant to 19 VSA Section 341;

2. served proper and timely notice of said petition and a hearing date thereon, pursuant to 19 VSA Section 342a, to all interested parties, by posting copies of said notice in two public places, sending copies of said notice by certified mail to the Woodbury Town Clerk, The Woodbury Planning Commission, the Vermont Board of Recreation, all adjacent land owners, and published a copy of said notice in the Times-Argus, a local paper generally circulating in the area;

3. and, examined said roads and held hearings on the discontinuance thereof in accordance with the provisions of 19 VSA Section 342a and 343.

WHEREFORE, being of the opinion that the discontinuance of the aforesaid roads is in the interest of the public good, necessity and convenience and that no damages have been incurred by any party for said discontinuance, it is hereby ordered that the above described roads, or portions thereof, shall and are hereby discontinued, with title to all lands encompassed thereby to hereby pass by quitclaim only to the parties bordering the same, pursuant to 19 VSA Section 535.
