





REPORT ON THE DISCONTINUANCE OF A PORTION OF UPPER HANDLE ROAD AND HIGH ROADD

We, the Selectmen of the Towns of Dover and Stratton, Vermont, and the Supervisor of the unorganized Town of Somerset hereby report on our doings concerning the discontinuance of a portion of a public highway known as Upper Handle Road located within the Towns of Dover (Town Highway No. 6) and Stratton (Town Highway No. 21), and a public highway (pent road) located in the Towns of Dover, Stratton and the unorganized Town of Somerset, known as the "High Road." Pursuant to resolution adopted at a regular meeting of the Board of Selectmen of the Town of Stratton on the 27th day of November, 1989 and at a regular meeting of the Board of Selectmen of the Town of Dover on the 28th day of November, 1989, notices of the proposed discontinuance of Upper Handle Road and High Road were caused to be posted in the offices of the Town Clerks of the Towns of Dover and Stratton and published in the Brattleboro Reformer on December 13, 1989. In accordance with said notice, a copy of which is attached hereto, the Selectmen of the Towns of Dover and Stratton met at the site at 3:30 p.m. on the afternoon of Monday, January 8, 1990, to examine the premises. Present at that time were Dover

Selectmen Linda Kersten, William Sargent, and Philip Bartlett;

Administrative Assistant Doris Knechtel and Zoning Administrator

Carol Cooper; and Stratton Selectmen Arne Lauren.

Thereafter, a hearing was held by the Selectmen of the Towns of Dover and Stratton and the Supervisor of the Town of Somerset at 7:00 p.m. on Tuseday, the 9th day of January, 1990, in the Dover Town Offices to consider the following:

- The discontinuance of a portion of the public highway known as the Upper Handle Road located in the Towns of Dover and Stratton, Vermont.
- 2. The discontinuance of a public highway (pent road) located in the Towns of Dover and Stratton and the unorganized Town of Somerset, known as High Road.

Present at the hearing were Dover Selectmen Linda Kersten, William Sargent, Philip Bartlett, and Paul Mendelsohn;
Administrative Assistant Doris Knechtel and Secretary Kelley
Patrick; Stratton Selectmen Arne Lauren, Al Dupell and Diana
Stugger; Stratton Town Attorney Robert Pu; Supervisor of the
Town of Somerset Douglas Wilson; the following interested
parties: Edward Griffith of the U.S. Forest Service; Kenneth V.
Fisher, Jr., Virginia Fisher, Gary Carruthers, Ann Hickey, Janet
Greene, Raymond Perra, Esquire, Chris Adams, Gilbert Boyd, Craig
Wenk, Esquire and Mark Sprague; and Bonney Prince and Susan
Johnson of the press.

Testimony was taken from Kenneth V. Fisher, Jr., Raymond
Perra, Edward Griffith, Craig Wenk, Janet Greene, and Ann
Hickey. Also read into the record were letters from John Redd

on behalf of Mount Snow and Mark Sprague on behalf of the Valley Stump Jumpers. The proceedings were electronically recorded.

In consideration of the testimony and official town records, the Boards and Supervisor make the following findings of fact, conclusions of law and order:

Findings of Fact

- 1. The landowners abutting the public highways being considered for discontinuance do not have any objections to their discontinuance.
- 2. Mount Snow would like the Green Mountain National Forest to be granted a twenty-foot (20') right-of-way for the entire length of the roads proposed for discontinuance.
- 3. The Valley Stump Jumpers would like to have access to the snowmobile trails in Somerset.
- 4. The Green Mountain National Forest would like a fifty-foot (50') right-of-way reserved for them to that portion of the road which leads from the junction of Route 100 and Stratton

 Town Highway No. 21 southwesterly for a distance of 508 feet to their existing sixty-six-foot (66') right-of-way which leads westerly over lands now owned by the Town of Stratton.
- 5. The northerly spur of the High Road leads through lands of Fisher and Bills to an unknown location. The other part of the High Road leads westerly through lands of Fisher to lands of Hickey located in the Towns of Stratton and unorganized Town of Somerset.

Conclusions of Law

- 6. The Board of Selectmen has the authority to lay out, alter and discontinue highways, subject to the public good, necessity, and convenience.
- 7. When a highway is discontinued, the right-of-way may be continued at the same width by the Board of Selectmen by designating the right-of-way as a trail.
- 8. If a discontinued highway is not designated as a trail, the right-of-way shall belong to the owners of the adjoining lands. If it is located between the lands of two different owners, it shall be returned to the lots to which it originally belonged, if they can be determined; if not, it shall be equally divided between the owners of the lands on each side.
- 9. A trail is not considered as a highway and a town is not responsible for its maintenance.
- 10. All of the property owners potentially affected by the possible discontinuance of the Upper Handle Road and the High Road, with the exception of the Green Mountain National Forest, Fisher, and Hickey have access to their property from Route 100.
- 11. If a right-of-way of ingress and egress is reserved for the Green Mountain National Forest, Fisher, and Hickey over the Upper Handle Road and High Road, the public good, necessity, and convenience of the inhabitants of the Towns of Dover, Stratton and the unorganized Town of Stratton are best served by the discontinuance of the Upper Handle Road and High Road.

Order

THEREFORE, the following public highways:

- 1. A portion of Dover Town Highway No. 6, also known as the Upper Handle Road, which begins at the junction of Dover Town Highway No. 41, which is also known as the Greene Road, and runs northerly to the Dover-Stratton Town line for a distance of approximately eight-tenths (0.8) of a mile;
- 2. Stratton Town Highway No. 21 (the northerly end of Upper Handle Road) which runs southwesterly from Vermont Route 100 to the Stratton-Dover Town Line a distance of 0.38 miles;
- 3. A portion of the High Road which commences in the Town of Dover at a point on the above-described Upper Handle Road being discontinued which point is approximately 2500 feet from the intersection of Dover Town Highway No. 41 (the Greene Road) and the said Upper Handle Road (Town Highway No. 6); thence running in a northerly and westerly direction through lands of Greene and the Green Mountain National Forest in the Town of Dover and through lands of the Town of Stratton, Hickey, Gildea and Fisher in the Town of Stratton and Hickey and Gildea in the Town of Somerset. On lands of Fisher the said High Road pent road then splits and a section of said pent road leads northerly through lands of Fisher and the Green Mountain National Forest to

the old Somerset-Stratton Town Line. A second section of the said High Road pent road leads westerly through lands of Fisher to lands of Hickey and Gildea in the Town of Stratton and the unorganized Town of Somerset. Said

highway consists, in total, of approximately 2.5 miles; are hereby DISCONTINUED and the existing highways are hereby set to the owners of the adjoining lands subject to a right-of-way of ingress and egress to each of the landowners abutting or adjoining the public highways being discontinued described as follows:

Commencing at the intersection of the Upper Handle Road (Dover Town Highway No. 6) and the Greene Road (Dover Town Highway No. 41) in the Town of Dover; thence leading northerly a distance of approximately 2500 feet along a portion of the Upper Handle Road being discontinued herein to the intersection of the Upper Handle Road and the High Road pent road described above; thence leading northerly and westerly a distance of approxitately 1.7 miles along the above-described High Road pent road through lands of Greene, Green Mountain National Forest in the Town of Dover and through lands of the Town of Stratton, Hickey, Gildea and Fisher in the Town of Stratton to lands of Hickey and Gildea located in the Town of Somerset.

Said right-of-way is limited to twenty feet (20') in width together with appropriate and necessary slope and drainage rights and the right to repair and maintain said right-of-way for all affected landowners. Also reserving a fifty-foot (50')

right-of-way for ingress and egress to the Green Mountain National Forest which leads from the junction of Route 100 and Stratton Town Highway No. 21 southwesterly for a distance of 508 feet to the Green Mountain National Forest's existing sixty-sixfoot (66') right-of-way which leads westerly over lands now owned by the Town of Stratton.



Below is a table summarizing the information on Legal Trails that is on file in the Mapping Unit. Act 178 of 2006 requires the measurement of trails be included on the sworn statement, the Mileage Certificate. To assist in this, we are providing a summary of the information we have on the trails that are shown on the Town Highway Maps, including mileage and former town highway number. The majority of trails were created by the reclassification of a town highway into a trail, thus the legal trail inherited an official measurement. The former town highway number is included in the FORMER_RTNAME column, and the former town highway mileage is in the AOTMILES column for each trail. VTrans has assigned a trail number, such as LT-1, to make the trails distinct. If the AOTMILES column is zero, the municipality will need to provide a mileage. The column ARCMILES contains the mileage as generated by the geometry of the trail, as digitized in the Geographic Information System (GIS). The mileages included in this table should be used as approximate mileages and the municipality should measure or verify the mileage of these trails.

A map showing the Legal Trail numbers and mileage has been included with this packet to further assist in this project. Any additional trails that exist should be added to the Mileage Certificate, as defined in the provided guidelines. Please feel free to contact us with any questions or comments regarding the above information, or the Mileage Certificates in general.



Hi Johnathan,

Working on the Dover town plan maps and noticed an error on the Dover Town Highway map. Valley View Road and Cooper Hill Road (TH 15/65) is totally paved, and I may have passed this on to your shop a couple years ago. But in one place it looks like the wrong arc got updated on the map. Apparently a section of TH 15 is a Class 4 town highway known as Valley View Trail, and this is unpaved. Valley View Road, paved, Class 3, follows TH 65 for a ways. This section is paved and should be marked as such on the map (it now shows as unpaved). The segment of TH 15 that's Class 4 (1.19 miles) is I don't know what--impassable or nearly so, but it shows as being paved. Hope that makes sense. Fairly obvious on the orthos. (I think what happened is all of TH 15 got updated as paved as it was assumed that all of TH 15 was Valley View Road). I never knew Valley View changed TH numbers in the middle.
