The road reclassification/discontinuance hearings held on June 6th, 13th, and 20th reconvened at the Town Office in Dummerston Center at 7 P.M.

Members Present: Tom Johnson, Chairman; Shorty Forrett, Vice-Chairman; Bill Ash, Clerk; Judy Davidson and Jack Manix.

Also Present: Garvan Murtha, Town Attorney; Paul and Jody Normandeau, Roger and Joy Aquadro, Dorothy and Gene Rostov, Bill and Mary Lou Schmidt, Bob Munn, Mark Whitaker, John Houghton, Scott Bertram, Paul and Gladys Brown, David, Alvan and Pauline Ryan, Gordon and Elizabeth Stacy, John Whener, Mark and Elizabeth Richards, Sally and Fred Perry, Sally Pieksen, Ken Carpenter, Beverly Knapp and Road Foreman Wayne Emery.

Bill Ash asked Town Attorney Gar Murtha if the Selectboard had an option to modify a reclassification. Gar responded "Yes".

TH #74: From the junction of US Route 5 easterly 0.07 miles, known as Tarbox Road: Discontinuance. On site hearing was held on June 6, 1994. A letter was received from Anthony Cersosimo stating that this road should not be discontinued. A motion was made and passed that this road be discontinued. Vote: YES: Judy Davidson and Jack Manix. ABSTAINED: Bill Ash and Shorty Forrett. Tom Johnson voted YES: motion passed.

TH #29: From the junction of TH #28, known as Tucker Reed Road, westerly 0.44 miles or to drive leading to home of Robert Munn: Reclassification from Class 3 to Class 4. On site hearing was held on June 6, 1994. Letters were received from Bill and Mary Lou Schmidt and Paul and Jody Normandeau asking that a portion of this be used for recreational purposes: (from the blue flag marker on Schmidt property to Schmidt property boundary marker on southwest corner). A motion was made and passed to reclassify TH #29 from Class 3 to Class 4. Vote: NO. A meeting will be scheduled to discuss and consider a deed restriction by the Schmidt's at a later date.

Pauline Ryan submitted a letter to the Board requesting that the discontinuance be delayed by one year to allow time to relocate the existing road. A motion was made to discontinue this road. This meeting was called to order at 7:30 P.M. at the Town Office in Dummerston Center, Vermont.

Members Present: Tom Johnson, Chairman; Shorty Forrett, Vice-Chairman; Bill Ash, Clerk; Judy Davidson and Jack Manix.

Also Present: Fire Department representatives Steve Gallup and Allen Pike; David Brooks, Jean Momaney, Nelson Jillson, Wayne Emery and Beverly Knapp.

A motion was made and passed to approve the minutes of January 18th and 25th and to pay Warrants 16 & 16P.

The Fire Department requested input on zoning application permits for development, new houses, apartments, and steep and narrow drives. They discussed their concerns with Jean Momaney, Zoning Administrator, and Jean will make sure they are aware of these permits. An addendum regarding curb cut permits for Wayne's review is given out separately at the present time but will be included on the application permit when new ones are printed. Steve also mentioned that the Fire Department may be requesting a new truck after the present one is paid off, possibly in 1998. Estimate \$150,000 - \$180,000.

David Brooks spoke on E-911 and informed the Board of progress; he noted that any naming or re-naming of roads will have to be authorized by the Selectboard.

Wayne submitted a list of highway equipment to the Board and also noted that the air compressor is now at the Town Garage. This compressor is large enough to do sand blasting.

A motion was made and passed to sign the Warning for Town Meeting to be held on March 7th, and a Group Agreement with the Community Health Plan. There will be five full time employees included in this Agreement at the present time.

Bill Ash had spoken with AOT regarding the covered bridge and AOT is reviewing plans and drafts from Fay, Spofford and Thorndike, Inc.; hopefully the Town will receive information in a few weeks. Re the Iron Bridge and AOT letter of 9/21: AOT verified that there must be a dollar amount listed ("not to worry"), and they are waiting for the engineering report.

Jack reported on the organizational meeting of the Vermont Community Development Program on January 31st, and there is a need for more applicants for this program. Another meeting is scheduled for February 21. Jack also stated that Mary Lafayette, Health Officer, issued an emergency health order regarding a rented mobile home owned by Arthur Phaneuf. Shorty is beginning work on a dog census; he will also pursue a second estimate on

the alarm system. Bill noted that Windham Regional Commission has conditionally approved the Dummerston Town Plan.

The July 1, 1995-June 30, 1996 budget was discussed with emphasis on the Windham Solid Waste assessment. A motion was made to support the assessment of \$22,100. VOTE: YES: Judy Davidson, Bill Ash, Tom Johnson. NO: Shorty Forrett and Jack Manix. MOTION CARRIED. The Town budget for the coming year is finalized: \$603,614.

A motion was made and passed to deduct .13 mile from Class 3 mileage: Re Town Highway 64 known as Riverside Drive in West Dummerston. This is a result of research.
