Meeting called to order by Bruce Chapin at 7:30 P.M.

Selectboard Present: Bob O'Brien, Arnold Young, David Hamilton, Bruce Chapin, Clara Robinson.

Public Present: Bonnie West, Cate Kelly, Elaine Beckwith, Glenn &ibson, Greg Joly, Beth Meachem, Bill Uptegrove, Morty Fink, Ralph Coleman, Mora Gerhing, Charlie Peck.

- 1. Motion made by Clara Robinson to approve the minutes of January 10,2000, regular meeting with correction, and January 12,2000 Public Hearing, with correction of letters deleted from the Planning Commissions packet on Pikes Falls Land Issue, requested by Elaine Beckwith; this motion seconded by Bob O"Brien, and so moved.
