SEC. 305. MEASUREMENT OF HIGHWAYS

(a) A representative of the agency in the presence of the selectmen or their designed shall measure and inspect the class 1,2 and 3 town highways in each town at least once every ten years. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town falls, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.

(b) Annually, on or before February IO, the selectmen shall, after review by a representative of the agency, file with the town cierk a sworn statement of the description and measurements of all class I. 2 and 3 town nighways, then in existence, including any special designation such as a throughway or scenic highway, when class I, 2 or 3 town highways are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town cierk's office and a copy shall be forwarded to the agency.

(c) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency.

(d) The selectmen of any town who are agarleved by a finding of the agency concerning the measurement, description or classification of a town highway may appeal to the board by filing a notice of appeal with the executive secretary of the board.

Title 19, V. S. A. Section 2502 Added 1985

Soc. 2502. TOWN SCENIC ROADS: DESIGNATION AND DISCONTINUANCE

* 16 M. . .

(a) On recommendation of the planning commission of a municipality, or, on the infiliative of the legislative body of a municipality, a legislative body may, after one public hearing warned for the purpose, designate or discontinue any town highway or portion of a town highway, as a town scenic highway. Such action by the legislative body may be petitioned by the registered voters of the municipality pursuant to the provisions of section 1973 of Title 24.

(b) A town scenic road may be reconstructed or improved in a manner consistent with the standards established by the transportation board, pursuant to section 425 of Title 10. A class 1, 2 or 3 scenic highway shall still be eligible to receive aid pursuant to the provisions of this title.

(c) The legislative body of a municipality may appeal for a variance from standards promulgated by the transportation board in these appeals the board's decision shall be final.

The selectmen of the Town of Putney, at a duly warned veiving and public hearing on April 25 considered the alteration of three town highways, TH 31, TH 17 and TH 54. TH 31 was viewed at 6:00PM. No abutting property owners or interested citizens were present during the viewing. Th 17 was viewed at 6:30 PM. Danny Hutchins, an abutting property owner was present and expressed no opposition to the proposed alteration of the road. TH 50 was viewed at 7:00 PM. Steve Bain, J. Cacos and Ronald Apuzzo abutting property owners were present.

The public hearing was called to order at 7:30 PM, April 25, 1988. Present were: Peter Shumlin, Greg wilson, Jeanette White, Anita Coomes, Robin Burke, Sue Caviola, Steve Bain, Evan Darrow, Miranda Fisk, Ronald Appuzo, Ellis Derrig, Robert Parrish and David Hannum.

Shurnlin stated that the selectmen were trying to make the work of the highway department move efficiently by eliminating the maintenance of short dead end roads which in effect were drive ways.

Evan Darrow represent Green Mountain Orchards stated they objected to the alteration of TH 17. The town has maintained the road for many years and serves one of their farm units as well as four housing units, three currently occupied. He expressed fear of the inability of the fire department to reach the buildings in the winter in case of a fire if the town did not plow the road. While he acknowledged that they routinely do some plowing in the area, their plow is not large enough to handle a major storm. He stated they had paid over \$200,000 in taxes over the last decade. He regretted that if the town ceased maintenance on the road they would have to maintain it until possibly some one beyond their buildings developed property. He expressed real concern over fire department being able to reach the buildings if the town did not continue maintenance of the road.

Several persons spoke to TH . Robin Burke stated many swimmers used the road in the summer. Steve Cacos, the only person presently with a house on the road, expressed concern over the town not grading the road. Steve Bain, an abuttor would like continued access to his property. Ronald Appuzo expressed concern that if the road was not maintained he would loose partial access to his building at the intersection with Falls Road. Miranda Fish stated she has less concern with the lack of plowing than with loss of grading.

Pulney

There being now further comment, the public hearing adjourned at 7:58 Pm. The selectmen took the viewing and comments heard under advisement and will render a decision at their meeting on May 11, 1988.

David B. Hannum Jr Town Manager Minutes of the May 11, 1988 meeting of the Putney Board of Selectmen. Those present: Peter Shumlin, Greg Wilson, Jeanette White, Susan Ells, J. Cacos, M. Forte, Miranda Fisk, Ronald Appuzo, Terry Mann, Paul Buffarn, Robin Burke, Sue Caviola, Geoffrey Faddis, Ivlichael Pattavina, Steve Johnson, Vicki Coomes, Ed Burke, Bob Mansfield, Bill Weston, and David Hannum.

The meeting was called to order at 7:00 PM. Minutes of the April 25, 1988 meeting and Public Hearing were read. Wilson moved and White seconded acceptance of the minutes as amended.

Steve Johnson, Windham County Solid Waste Management District outlined the district's plans to establish a recycling activity this summer at the District Landfill with satelite collection sites in member towns. He explained that while recycling costs money, it is less expensive than burying in a landfill. He stated the satelite sites should be in a prominent place in the community, not hidden. He suggested a contract with the local school for students to police the site in return for a fee. He stated a site or sites should be selected and a local committee established. He said the program could be set up by August. He concurred with Westminister West working with Putney but felt they should obtain a letter of concurrence from their solid waste district to overcome possible future problems. Susan Ells expressed further interest in participating with Putney and volunteered to work on the committee as chair person. Miranda Fisk and Ronald Appuzo also volunteered for the committee.

Bids were opened for repaving highways. Two bids were received, Lane Construction Corp., \$28.35 per ton and Whitcomb Construction Corp., \$30.24 per ton. On motion of Wilson and second of White, Lane's bid was accepted. Passed unanimously.

Gaddis stated he wanted to discuss the operation of the sewer pump station at Landmark college. He stated that at the present time Landmark College paid the electric bill for the pump station. He stated the pumps appear to be pumping an excessive amount of time. Based on the hours the pumps are running they should be pumping more sewerage than is being treated at the sewer plant. Hannum explained that in the past the sewer bill for Landmark was based on gallons of flow determined from hours of pump operation. He suggested that the college have a flow meter installed in the line to meter their flow. He stated in keeping with other meter installations, the college should bear the cost of meter and installation. Hannum directed to work with Gaddis to develop some recommendations to bring back to selectmen. Gaddis would

like to reduce to writing the relationship between the town and the college concerning the sewerage. This issue to be placed on agenda for next meeting. Shumlin abstained from this discussion because of possible conflict of interest.

As there was no objection to altering T.H. 17, White moved and Wilson seconded altering the section from the Millbrook Road intersection to the end of the currently maintained section to a trail. Passed unanimously. The possible alteration of T.H. 31 was discussed at length. Shumlin stated that if the road was up to standards it would meet the requirement of having three residences and could be taken into the highway system. On motion of White and second of Shumlin, the road was retained in the town system. Passed unanimously. Considerable discussion took place concerning alteration of T.H. 45. Forte and Cacos expressed concern over inability to maintain the road in the summer. Others expressed the same concern. Shumlin explained that this road was clearly a long drive way. Shumlin moved to alter to a trail and Wilson seconded. White voted against.

On motion of Wilson and second of White, Steve King's proposal to do the concrete work for the handicapped access ramp for \$4500 to \$5000 was accepted. Passed unanimously. Hannum directed to advertise for proposals for the required earth work and landscaping to go with the project.

Weston presented a proposed capital budget for the fire department. Shumlin reviewed the recent history of funding and major expenses of the fire department. Weston stated he had been approached on possible fire works display on July 3 at the ball field. He stated if done, he would strictly enforce state rules. He stated he wanted selectmen's approval to use fire prevention funds to work with Putney Cares to put smoke detectors in needy family homes. The fire department would provide and install the detectors. The selectmen approved and applauded this action. Weston stated he wanted to purchase a set of Jaws of Life for the fire department as Rescue Inc. has a long way to go to many parts of Futney and they have had equipment problems on several recent calls. He proposed purchasing the equipment with donations and Fire Department funds. Shumlin expressed strong objections about the fire department getting into the rescue business particularly in light of the large sum of money provided each year to Rescue Inc. by Putney and Putney people. He suggested meeting with Rescue Inc. to discuss the issues. The selectmen will discuss further at a later meeting.

Hannum stated he could not determine the status of Spaulding Hill Road other than the portion that was altered to a trail in 1955. In his opinion, except for the .04 mile included in annual highway mileage reports it should be considered a trail however he could not document that. Hannum directed to invite Ellis Derrig to next meeting to discuss the issue.

Hannum presented a letter from the listers outlining three properties which had been listed as tax exempt in the past year but had not been so voted by the town's voters. The selectmen directed the property to be placed on the tax rolls and a letter sent to the owners. A copy of the listers letter attached to these minutes.

Hannum stated the town's attorney had stated the selectmen were within their authority to enter a net lease with the Recreation Club Inc. for the swimming pool. He stated the attorney suggested the pool consider operating without insurance. The pool board members had considered this but found it socially unacceptable. On motion of Wilson and second of White, the town will enter into a lease for one year on the the pool and it will be included in the town's insurance. The pool will bear all costs of insurance for the pool. The pool board will run the pool. Funds will be paid to the town and the town will pay bills from pool funds. Burke to draw up a lease agreement.

Shumlin reported the selectmen have been invited to meet with the Planning Commission for a work session on the town plan at 7:00 PlM on IMay 18, 1988 in the town offices.

Hannum directed to contact Norman Runnion at the Brattleboro Reformer concerning a reporter to cover the Town of Putney.

Hannum reported a letter had been received from the Town of Brattleboro requesting help in finding fields on which to spread sewage sludge.

The next meeting of the selectmen will be at 7:00 PM, May 23, 1988.
