## REPORT OF SELECTMEN ON RECLASSIFICATION OF AD BROOKS ROAD AND LILLIS PASTURE ROAD FROM CLASS IV HIGHWAYS TO TOWN TRAILS

WHEREAS, at Vernon aforesaid, on the 6th day of December, 1990, the Selectmen of the Town of Vernon did decide to institute proceedings pursuant to Title 19, Vermont Statues Annotated, Chapter 7, for the purposes of reclassifying the following described portions of public highway in the Town of Vernon.

- 1. Portion of public highway known as Ad Brooks Road
- Portion of public highway known as Lillis Pasture Road

WHEREUPON, the said Selectmen did order and appoint that on the 12th day of January, 1991 they would examine the premises at Ad Brooks Road at 10:00 a.m., they would examine the premises at Lillis Pasture Road at 11:00 a.m. and would meet at the Town Hall at 12:00 p.m. for the purpose of hearing all persons interested in the reclassifications, and did give notice of such examination and meeting to:

persons owning or interested in lands abutting upon or lands through which said highways pass, all by written notices delivered by mail to each of said named persons at least thirty (30) days before the time fixed for hearing, and did also give notice of such hearing to the Town Planning Commission of the Town of Vernon and did also cause a written notice of such meeting to be posted in the office of the Town Clerk of Vernon, Vermont at least ten (10) days before the time set for hearing, and did also cause a copy of such notice to be published on the 27th, 28th and 31st days of December, 1990 in the Brattleboro Reformer, a daily newspaper having a circulation in Vernon, Vermont, copies of such notices as mailed, posted, published and delivered being attached hereto and being incorporated herein by reference.

There was a discussion by the Selectmen with those persons appearing at the hearing about the roads to be reclassified, their location, the effect of reclassification upon the abutting landowners and other questions raised by those appearing at the hearing.

Based upon the testimony given at the public hearing, the Selectmen, do then find and order that the public good,

necessity and convenience of the inhabitants of the Town of Vernon require that the following Class IV highways in the Town of Vernon shall be reclassified as town trails:

- Being that portion of the public highway in Vernon, Vermont known as Ad Brooks Road which T-14 runs off West Road a distance of 0.4 miles, 0.40 more or less;
- Being that portion of the public highway in Vernon, Vermont known as Lillis Pasture Road, T-9 being shown on Vernon Property Maps #39 and #33. 0.63
