

ORDER OF ROAD DISCONTINUANCE

Re: Town Highway #67 Barnard, Vermont

This matter came on for hearing and site review on February 16, 1984 at 2 p.m. on the town road in question, pursuant to a petition of DavEstates, Inc., dated January 18, 1984 requesting that the said Town Highway #67 be discontinued pursuant to 19 V.S.A. §531 et seq.

Based upon a review of the road and the arguments and evidence presented by the Petitioner, DavEstates, Inc., by and through its attorney Thomas P. Wright, the following findings and order are made:

 That Town Highway #67, which proceeds in a northeasterly direction from Town Highway #2, lies wholly within the town of Barnard and it not having been made to appear that said highway was laid out under authority of the County or Supreme Court;

2. That the Petitioner, DavEstates, Inc., owns the property located on both sides of the subject town highway and it serves
No other residence;

3. That neither the public good, necessity or convenience of the inhabitants of the Town of Barnard require that such roadway be continued as a town highway.

NOW THEREFORE, based upon the evidence presented and a review of the site as aforesaid, IT IS HEREBY ORDERED AS FOLLOWS:

1. That Town Highway #67, so-called, running in a northeasterly direction off of Town Highway #2 across a portion of the property now owned by DavEstates, Inc., formerly known as the "Webb Farm" is hereby DISCONTINUED as a town highway from and after the date of the within Order.
