IT IS HEREBY ORDERED:

- (1) A Class 3 Town Highway is established, conforming with the above referenced survey and described in location as: commencing at a point on the southerly side of Bethel Town Highway #7 at the edges of said highways' rights-of way, thence S30007'56"E21.33', thence S 40₀03'56"E24.43', thence S52₀53'10"E 117.39', thence 261.68' along an arc governed by a 50' radius swung from a radius point 50' removed S26₀33'41"E from the last noted point said arc ending at a point N86₀42'20"W 50' removed from the radius point thence N52₀53'10"W 96.08', thence N52₀53'10"W30.20', thence N40₀03'56"W 34.39' thence N30₀07'56"W25.13', thence easterly along the edge of the right-of-way of Town Highway #7 to the place and point of beginning; suitable monuments shall be set to mark the bounds of this survey.
- (2) Said highway shall hereafter be designated as Town Highway No.93.
- (3) The actions and proceedings hereby set forth shall also serve to discontinue that portion of the right-of-way laid out in 1842 which commences at the intersection of said 1842 roadway and Town Highway #7 and continues to the terminus of the road here laid out.
- (4) Per V.S.A. Title 19 Section 711, this "Report and Order", and the subject survey by Swanson, shall be submitted for recording by the Bethel Town Clerk.

WHEREAS the Bethel Board of Selectmen determined that a certain road which now leads from Bethel Town Highway #7 (Gilead Brook Road) to the home of Thomas and Barbara Pinello required an investigation as to its potential status and need as a public highway, a site inspection was thus made at 6:30 PM on Monday, August 23, 1999, and a Public Hearing to receive public comment on the subject was held subsequently on that same date at the Bethel Town Office, and WHEREAS notice of the site inspection and public hearing were provided to the Municipal Planning Commission and posted in the office of the Town Clerk in excess of ten days prior to the site inspection and public hearing, and said notice was also published in the "Valley News" on August 14, 1999 and in the "Herald of Randolph" on August 19, 1999, and notice was provided to all persons owning or interested in lands through which the highway may pass or abut by certified mail sent to the official residence of the person(s) required to be notified in excess of thirty days prior to the site inspection and public hearing, these persons being: Mr.&Mrs.Thomas Pinello, Dorothy Maruska, Frank Pinello, Thomas Fairchild, William Markle, Penelope Graham, Martha Pinello, Mascoma Savings Bank, Christine Pinello, Spencer Lewis, and

WHEREAS the following findings of fact have been made by the Board of Selectmen:

- (1) a bridge over Gilead Brook is situated on the subject road and the bridge has historically been a Town responsibility to maintain,
- (2) the Town's tax maps show two property ownerships between the Gilead Brook and Town Highway #7, neither of these being ownership by the Pinellos
- (3) the subject road appears to have been used in the past as a connection from Town Highway #7 to Town Highway #17,(the surveyor commissioned by the Town to survey the subject highway found in Volume 2 of the Town Proceedings on Page 411a that a road was laid out in 1842 and "clearly establishes a 3-rod wide highway right-ofway to the house of Thomas Fisher in 1842, which is presently owned by Pinello, et al." He notes that the exact location cannot be confirmed because record monuments have been destroyed, but that there does not appear to be any record of discontinuance of the highway.)
- (4) the grade of the road in the vicinity of the bridge and Town Highway #7 is very gradual; improvements could be made quite inexpensively to provide better ditching and a more perpendicular alignment at the intersection with TH#7, and
- (5) a turnaround area could be created for Town equipment at a point approximately100 feet southerly of the bridge on the opposite side of Gilead Brook from TH#7, and

WHEREAS the Board of Selectmen has determined that the public good, necessity and convenience of the inhabitants of the municipality require a highway to be newly laid out per a survey completed by Lawrence E. Swanson, licensed land surveyor No.621, dated October 4, 1999,
