TOWN OF SPRINGFIELD ORDER OF DISCONTINUANCE PURSUANT TO 19 V.S.A. CHAPTER 7



WHEREAS, pursuant to 19 V.S.A. Section 708(a), on its own Motion after a citizens request, the Selectmen commenced proceedings to discontinue a portion of Town Highway #75 also known as Boedtker Road, so-called, located in Springfield, Vermont and ending in front of the dwelling of Walter and Susan Richter. A viewing was held of such Road on December 1, 1999 at 7:15 a.m. with a Public Hearing held on December 13, 1999 at 7:00 p.m. at the Town Hall, 96 Main Street to consider testimony and take action. Notice of such viewing and Public Hearing was served on all persons owning or interested in lands through which such highway may pass or abut along with the Planning Commission and posting a copy in the office of the Town Clerk and further published in a local newspaper of general circulation in the area not less than 10 days before the time set for said Hearing. Said notices being sent to those individuals set forth on Exhibit A attached hereto. A copy of such notice is attached hereto and marked Exhibit B.

WHEREAS, after conducting the viewing of Town Highway 75 and taking testimony,

Paul Putnam moved and Donald Gurney seconded a Motion that the

portion of Town Highway 75 between Pleasant Valley Cemetary and the Richter home be

discontinued, giving back to the abutting property owners any right, title and interest that the

Town may have in said road subject however to the condition that the Richter's Deed to the

Town of Springfield the parcel depicted on the survey entitled "Subdivision of land in Springfield,

Windsor County Vermont for Walter & Susan Richter" prepared by Bruno Associates, Inc., P.C.,

Drawing No. 98-223/8223-1 dated December 17, 1998 for purpose of constructing a cul-de-sac.

This Motion was unanimously approved.

The portion of said discontinued highway reverting to the abutting land owners is more particularly described as set forth on the above-referenced Survey and therein described as follows:

To Walter D. and Susan B. Richter:

Said Richters, being the only abutting owners to the discontinued roadway, the entirety of said discontinued roadway hereby reverts to Walter D. Richter and Susan B. Richter, husband and wife, as more particularly described as follows:

Commencing at the point marking the centerline of the hereby discontinued portion of Town Highway #75. Said point being adjacent to the Richter dwelling and approximately halfway between points "C" and "F", as shown on the aforementioned Survey, thence in a generally northerly direction along said centerline 1271 feet to a rebar depicted as point "D" on said Survey.
