# Title 19. V. S. A. Section 305 - Added 1985

#### SEC. 305. MEASUREMENT OF HIGHWAYS

(a) A representative of the agency in the presence of the selectmen or their designee shall measure and inspect the class 1,2 and 3 town highways in each town at least once every ten years. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town falls, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.

(b) Annually, on or before February 10, the selectmen shall, after review by a representative of the agency, file with the town clerk a sworn statement of the description and measurements of all class 1, 2 and 3 town highways, then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2 or 3 town highways are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.

(c) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency.

(d) The selectmen of any town who are aggrieved by a finding of the agency concerning the measurement, description or classification of a town highway may appeal to the board by filing a notice of appeal with the executive secretary of the board.

### Title 19, V. S. A. Section 2502 Added 1985

#### Sec. 2502. TOWN SCENIC ROADS; DESIGNATION AND DISCONTINUANCE

(a) On recommendation of the planning commission of a municipality, or, on the inlitiative of the legislative body of a municipality, a legislative body may, after
one public hearing warned for the purpose, designate or discontinue any
town highway or portion of a town highway, as a town scenic highway. Such action by the
legislative body may be petitioned by the registered voters of the municipality pursuant to the provisions of section 1973 of Title 24.

(b) A town scenic road may be reconstructed or improved in a manner consistent with the standards established by the transportation board, pursuant to section 425 of Title IO. A class I, 2 or 3 scenic highway shall still be eligible to receive aid pursuant to the provisions of this title.

(c) The legislative body of a municipality may appeal for a variance from standards promulgated by the transportation board. In these appeals the board's decision shall be final.

Dear Mr. Hughes:

With your appearance at the Transportation Board Meeting of February 17, 1987 you are aware that the Town's request to transfer Back Mountain Road to the State Highway System received Board Approval with certain conditions. To implement the Board's approval the following needs to transpire.

1. The Town of Windsor will formally accept a section of Route VT 44 from the intersection of Back Mountain Road (TH 5) to the point where the State Highway (VT 44) currently becomes a Class I Town Highway. The Class I Town Highway will then extend from Back Mountain Road (TH 5) to US 5 in Windsor and will continue to be signed VT 44.

The increase in Town Highway Class I mileage will be from 1.303 miles to 3.335 miles. Concurrence for this trade off needs to be stated in a letter from the Selectmen.

- 2. The Town of Weathersfield must also formally request transfer of its portion of Back Mountain Road to the State System. They will be so requested and copied.
- 3. Transportation Board Policy also requires both towns to certify and transfer at least a three-rod right-of-way, in fee simple, to the Transportation Board. This will involve a resurvey which will be coordinated with the Office of the District Transportation Administrator.
- 4. When the above certification as to a three rod right-of-way has been completed the Governor will be requested to approve the transfer and a map indicating the transfer will be filed with the Town and Secretary of State's Office.

The issue of liability/responsibility for the private sever line along VT 44 will rest with its owner. Following the above activities the Agency will forward, to the sewer line owners, Connecticut River Development Corporation (CRDC) by certified mail, the change of ownership of the section of VT 44 in question. We are advancing, enclosed, a copy of the existing permit granted by the Agency to the CRDC.

The Town of Windsor's concern with the possibility of rebuilding BR#10 on VT 44 is addressed as follows: The bridge sufficiency rating is 70.5 points and the next inspection is due in 1987. If there is a need for improvements, the bridge will compete for Federal-aid funding based on statewide needs.

Your formal response to the conditions set forth in the Transportation Board action and this letter regarding the Back Mountain Road and VT 44 transfers is requested as soon as possible. This will enable us to expedite the required procedures to make these highway transfers effective.

Thank you for your cooperation in this matter.

SUBJECT: State Highway Transfer Request: Back Mountain Road

Weathersfield (TH 2, 0.50 mi.) Windsor (TH 5, 2.45 mi.)

Attached for Board review and action is a formal request from the Town of Windsor to transfer "Back Mountain Road" to the State Highway System (2.95 miles).

The Agency performed a study in accordance with Board Policy during September, 1986 and the results follows:

This road falls short (only 2.7 points) of meeting only the sufficiency rating criteria above. This was due to a 0.35 mile section of Back Mountain Road extending south from VT 44, which is very rough and narrow, thus in need of reconstruction.

Turning movements (1986) taken in the area (including the junction of VT 44 and TH 5 in Windsor) showed 13 percent of the traffic volume as trucks of which 12 percent were of the medium type.

The Town of Windsor has also petitioned the Transportation Board on January 21, 1987 (see attachment).

While the sufficiency rating criteria is not met, in the interest of controlling the ever increasing state highway mileage, the Agency is agreeable to accepting the Back mountain Road as a State Highway in exchange for reverting a section of VT 44 in Windsor to Class I Town Highway (2.032 mi.). DTA Tetreault has had positive discussion with local officials concerning this trade-off. (See attached DTA memo, 1/27/87). The town's concern with the possibility of rebuilding BR #10 on VT 44 is addressed as follows:

The bridge sufficiency rating is 70.5 points which makes it eligible for rehabilitation. The next inspection is due in 1987 and the bridge rating will be updated at that time. If there is a need for improvements, the bridge will compete based on statewide needs.

DTA Tetreault has indicated that no additional equipment and personnel will be required if the state highway trade-off occurs. The annual maintenance cost for the net increase in state highways of 0.92 mile would amount to only \$6,880. Without the trade-off, the annual maintenance cost would be \$22,000. One (1) additional truck fully equipped at \$41,000 and one (1) additional personnel would also be required.

To complete the transaction, the Town of Weathersfield needs to request the transfer of its portion of Back Mountain Road to the State.

The Agency therefore recommends Board action to transfer Back Mountain Road to the State as a State Highway with the two following conditions.

- 1. The Town of Windsor will accept VT 44 as a Class I Town Highway.
- 2. The Town of Weathersfield formally request the transfer of its portion of Back Mountain Road as a State Highway.
