


In answer to your letter of December 15, 1999 regarding highways #41, #79 and #80:


I have researched our records and have consulted Philip Sorrell, our road commissioner, to determine that highways #41 (known as the Stagecoach Rd) and #79 (known as Bradley Vale Rd) and #80 (known as the Wheaton Rd) do have duplicate mileage. Therefore I have subtracted .38 miles from class 3 roads and added .14 miles back to class 4 roads.

This letter is written in an effort to clear up some questions concerning town highways 41, 79 and 80, which according to our records may have duplicate mileage on them.

T-41 James Colter Road Reclassed
1994 +0.15 Class 3 and -0.15 Class 4
1999 +0.14 Class 3 and 0.14 Class 4
Error correction would be -0.14 Class 3 and +0.14 Class 4

T-79 Bradley Vale Road New Addition
1994 +0.10 Class 3
1997 -0.11 Class 3
Error correction would be -0.10 Class 3

T-80 Wheaton Road New Addition
1993 +0.14 Class 3
1994 +0.19 Class 3
Error Correction would be -0.14 Class 3

Total changes would be -0.38 Class 3 and +0.14 Class 4

Please check the enclosed mileage certificate and mileage summary and let us know if these changes are valid. If you do not agree, please let us know why. We would like to resolve these questions so the changes can be made on the mileage certificate for 2000 and when processed the new town map of Concord can be updated.
