

#### **Vermont Statutes Annotated**

### 19 V.S.A. § 305. Measurement and inspection



#### § 305. Measurement and inspection

(a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.

(b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.

(c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.

(d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.


(e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.

(f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description, or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.

(g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate.

# LUTHER ROBINSON ROAD Proposed 2015 Addition to Granville Highway Map Adds 0.32 Miles to Legal Trail #7

**Original Survey** 

Recorded 7/12/1834 Book 5 Page 267 Surveyed 6/15/1834 Width 6 Rods to be fenced 3 Rods wide Length 247 Rods = 0.77 Miles

This survey began at the "...dwelling house of Luther Robinson..." Robinson's house is shown on the 1857 Walling Map. From there the road ran southeast on various bearings until it hit the southerly lot line of Lot #183. The final 102 Rods follow that lot line southeast on a straight bearing to the end of the survey. A portion of this 102 Rod reach has been overlain and obliterated by the Green Mountain National Forest's Patterson Brook Road. No matter, the obliterated section of the original survey was Discontinued in 1882. See below.

## **Partial Discontinuance**

Recorded July 10, 1882 Book 12 Page 320

The Granville Selectboard, acting on a petition filed by four landowners, formally Discontinued that portion of the original 6/15/1834 survey from the "main road" (TH#12) westerly "... to a certain maple tree near C.R. Bagley's barn, where the survey of a new road was begun on the 16<sup>th</sup> day of June A.D. 1882."

The new road referred to above is now Bagley Barn Legal Trail #7 on Granville's Town Highway Map. It is one of the Ancient Roads re-established in 2010. The survey for LT#7 starts at a maple tree near C.R. Bagley's barn and runs southeast to connect with TH#12 near Granville School #4. Apparently, this new route (LT#7) was a shortcut to the school and the village. Thus, the easterly 144 Rods of the original Luther Robinson Survey were no longer needed and were Discontinued.

This Discontinuance left intact the northwesterly 103 Rods of the original Luther Robinson Road which connected to the Bagley Barn LT#7 at the old maple tree. The maple tree (which can be seen standing today) and the barn (the foundation remains) are cited in both the survey of LT#7 and the partial Discontinuance of Luther Robinson Road, so the connection is made.

# Description of Luther Robinson Road to be added to Mileage Certificate in 2015

The initial 1700 feet (0.32 miles) of the original Luther Robinson Road survey was never discontinued and remains valid today. From the site of the old Luther Robinson Homestead (later the Aaron Bagley home shown on the1871 Beers Map), this proposed addition runs southwest 1700 feet (see enclosed survey for bearings and distances), crossing the Patterson Brook Road, to join the northerly end of Bagley Barn LT #7 at the old maple tree.

# **Field Investigation**

The roadbed is clearly observable along its entire length. It provides recreational access to historic homesites, apple orchards and other evidence of agrarian use nearly 200 years ago. The National Forest is using it currently for a log skid road.

# Landowners

Luther Robinson Road lies entirely on public lands within the Green Mountain National Forest. The U.S. Forest Service has had no objections to re-establishment of proven town rights-of-ways as either Class 4 Highways or Legal Trails on Granville's Town Highway Map.

# Hear any Public Comments and Communications:

Vivian Valtri Burgess asked what the procedure was to open a shelter when the power goes out. After a lengthy discussion it was decided that individuals in need of a warm shelter that they contact Mark Belisle, Emergency Coordinator and/or Dan Sargeant, Fire Chief who will then coordinate with the Selectboard if a shelter is needed.

Sean Linsky advised the Selectboard that he cleared trees and brush along West Hill and West Hill Extension during the recent storm. The Selectboard thanked Sean for all of his efforts.

The topic of snowplowing came up and how it is not being done to everyone's satisfaction. Charles Smith addressed their concerns and will do better but we have to understand that it was a very difficult storm and there is still work to do. The Selectboard granted the continued clean up, brush and tree chipping and the use of a grader to help push snowbanks back and to get the roads wider. If you have any problems with trees in or across the town highways call Charles Smith to remove them.

# **Old Business**

**Discuss Design Phase Contract for CDBG Grant** - Cheryl Sargeant made the motion to approve the contract with DuBois & King, Inc. as written and Michelle Brown seconded. All in favor.

**Discuss Bagley Barn Trail Addition on West Hill Extension** – Norman Arseneault, Ancient Roads Committee requested that a 0.32 mile section of the Bagley Barn Trail which is a short cut at the maple tree to C.R. Bagley's Barn is observable, requires no maintenance of the Town, is within the US Forest Service lands and almost to the Patterson Brook Trail. It also includes 2 points of interest Luther Robinson homestead and the C.R. Bagley farm and it would be nice to be able to place historic markers. Sean Linskey spoke about the potential recreational benefits. The addition to the highway mileage map can be easily done by the Vermont Agency of Transportation during the updates coming up and before the deadline for ancient roads to be recognized. Michelle Brown made the motion to accept the addition of the Bagley Barn Trail to the town highway mileage map and Cheryl L. Sargeant seconded. All in favor.

**Discuss FEMA Alternate Projects Time Extension** – Norman Arseneault, FEMA Administrator advised the Selectboard to request a time extension from September 1, 2015 to December 31, 2016 along with asking for the 75% advanced funds of \$450,000.00 so that the Town can begin incurring costs. Also, to seek the Line of Credit which has already been done and is waiting to be used. The money shall be deposited into a non-interest bearing account. Douglas Newton is willing to continue with the survey and design phase but will not be able to help with the construction phase. He will make recommendations for consultants to help with that. Chase & Chase is willing to update their field survey work Norm will get an updated quote for our next meeting. Michelle Brown made the motion to have Cheryl draft a letter to FEMA, Page 2

have Douglas Newton continue and to have Chase & Chase perform the field survey and Cheryl L. Sargeant seconded. All in favor.



#### Good afternoon Norm,

. . .

Regarding your question posed earlier on the phone regarding reclassification of a class 4 town highway to class 3 and the proper timing of the reclassification process. Typically, the reclassification process is performed following the upgrade of the highway to class 3 standard, which we (VTrans Mapping) use the standard defined in 19 V.S.A. § 302. Classification of town highways:

## 19 V.S.A. § 302. Classification of town highways

(a) For the purposes of this section and receiving state aid, all town highways shall be categorized into one or another of the following classes:

(3) Class 3 town highways:

(A) Class 3 town highways are all traveled town highways other than class 1 or 2 highways. The selectmen, after conference with a representative of the agency shall determine which highways are class 3 town highways.

(B) The minimum standards for class 3 highways are a highway negotiable under normal conditions all seasons of the year by a standard manufactured pleasure car. This would include but not be limited to sufficient surface and base, adequate drainage, and sufficient width capable to provide winter maintenance, except that based on safety considerations for the traveling public and municipal employees, the selectboard shall, by rule adopted under 24 V.S.A. chapter 59, and after following the process for providing notice and hearing in section 709 of this title, have authority to determine whether a class 3 highway, or section of highway, should be plowed and made negotiable during the winter. However, a property owner aggrieved by a decision of the selectboard may appeal to the transportation board pursuant to subdivision 5(d)(9) of this title.

(C) A highway not meeting these standards may be reclassified as a provisional class 3 highway if within five years of the determination, it will meet all class 3 highway standards.

The Town may have also adopted Codes & Standards that have additional requirements for class 3 town highways. I believe the last line of the class 3 classification (19 V.S.A. § 302.(3)(C)) provides the Town with the ability to make the reclassification to class 3 occur before the highway meets the

full standard. It should be noted that there is a timeframe when the class 3 standard needs to be met and the provisional status will be reviewed.

The reclassification to provisional class 3 town highway seems like best approach at this time and can be done at the discretion of the Selectboard, as long as the plan is to bring this highway up to standard within a 5 year time frame.
