

Good morning folks and Happy Holidays,

There has been some construction along VT-17 in New Haven as 1 am sure you are well aware of that has affected the intersections with East St (TH-19 & TH-22) and TH-18 (Sawyer Pd). The configuration in the intersection with TH-22 and TH-19 has changed from a Y to a T, essentially eliminating TH-19 (see image below from Google street view). We have the survey plans for this project and will make updates to the road data and any associated mileage changes in the upcoming Mileage Certificate cycle.

Has the Town gone through the discontinuance process for TH-19 (highlighted in blue in the 2nd image below) to legally change the ROW? We would need that documentation as part of the certificate packet to be processed in 2024





