19 V.S.A. § 305. Measurement and inspection

§ 305. Measurement and inspection

- (a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.
- (b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.
- (c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.
- (d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.
- (e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.
- (f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.
- (g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate.



Below is a table summarizing the information on Legal Trails that is on file in the Mapping Unit. Act 178 of 2006 requires the measurement of trails be included on the sworn statement, the Mileage Certificate. To assist in this, we are providing a summary of the information we have on the trails that are shown on the Town Highway Maps, including mileage and former town highway number. The majority of trails were created by the reclassification of a town highway into a trail, thus the legal trail inherited an official measurement. The former town highway number is included in the FORMER TOWN HIGHWAY NUMBER column, and the former town highway mileage is in the AOTMILES column for each trail. VTrans has assigned a trail number, such as LT-1, to make the trails distinct. If the AOTMILES column is zero, the municipality will need to provide a mileage. The column ARCMILES contains the mileage as generated by the geometry of the trail, as digitized in the Geographic Information System (GIS). The mileages included in this table should be used as approximate mileages and the municipality should measure or verify the mileage of these trails.





We, John Palmer Williams and Olive U. Williams, hereby covenant and agree to vacate the above-described land and premises on or before June 1, 1980, and agree to maintain and pay for all utility services supplied to said premises. It is further understood and agreed that no rental charges will be made for said occupancy.

Excepting and reserving to the Grantors the following described improvements situated on the land conveyed:

A 1 1/4 story wood frame house with a 1 story addition.

It is agreed that such exception and reservation shall be subject to the following specific terms and conditions:

The Grantors agree:

(1) To remove the improvements on or before June 1, 1980, and five (5) days after removal of improvements, to remove all combustible materials and other rubbish including shrubbery and trees which have been cut or uprooted to facilitate moving operations leaving only concrete foundations and concrete flatwork on the premises, provided however, that all mudsill steel tie bolts and reinforcing steel protruding from said remaining concrete foundations shall be removed, bent over or sheared at all exposed surfaces of the concrete foundations and in the event there are basements under any of the buildings upon completion of moving operations, the Grantor shall construct a temporary barricade fence around the basements or other hazards to the satisfaction of the Agency of Transportation for the purpose of protecting pedestrians and animals from falling into such hazards and in all other respects Grantors shall leave premises in a reasonable safe condition or the State shall have the right to complete lot cleaning and to do all other things required in this paragraph at Grantors' expense. In the event any utility service lines to other buildings are disconnected, destroyed or otherwise impaired in any way by reason of the removal of said improvements, the Grantors at their own cost and expense shall provide such other buildings adequate, substitute utility lines in lieu of those affected.

- (2) Grantors shall only have the right to remove the improvements as specified and shall enjoy no other rights upon premises.
- (3) Grantors agree to hold the State harmless from all claims and liability whatsoever, incurred by virtue of the Grantors continued ownership and/or occupancy, including but not limited to personal injuries, and indebtedness for utility and other services furnished at the request of the Grantors.
- (4) In case of default by Grantors in any of their obligations under paragraphs (1), (2), and (3) above, all their rights thereunder shall become forfeit and title to said improvements shall vest in the State without any additional cost or compensation payable to Grantors to dispose of as it sees fit, without recourse by the Grantors.

The State of Vermont makes no guarantee that any building retained will be movable, or that permits will be granted to place them in any specific location.

The Grantors assume all risk and responsibility in wrecking and/or moving operations, including any loss by reason of vandalism.

NOTE: The Grantors shall secure all necessary permits and certificates required in connection with the wrecking or removal of any buildings and shall comply with all pertinent local ordinances.

TO HAVE AND TO HOLD said granted premises, with all the privileges and appurtenances thereof, unto the said State of Vermont, and its assigns, to them and their own use and behoof forever; and we, the said John Palmer Williams and Olive U. Williams, for ourselves and our heirs, executors and administrators, do covenant with the said State of Vermont, and its assigns, that until the ensealing of these presents we are well seized of the premises, as a good indefeasible estate in fee simple, and have good right to grant and convey the same in manner and form as above written and that the same are free from every encumbrance, whatsoever.

AND FURTHERMORE, we, the said John Palmer Williams and Olive U. Williams, do by these presents bind ourselves and our heirs, forever, to WARRANT and DEFEND the above premises to the said State of Vermont and its assigns against all claims and demands whatsoever.

AGREEMENT

THIS AGREEMENT, made by and between the State of Vermont, Agency of Transportation, hereinafter referred to as the STATE, and the Town of Manchester through its Selectboard, in the County of Bennington and State of Vermont, hereinafter referred to as the TOWN.

WITNESSETH:

WHEREAS, the said parties mutually agree that the maintenance and repair of town highways should be under the control of the TOWN, pursuant to 19 V.S.A. § 310 and that the giving over of said maintenance and repair is in the best public interest;

NOW, THEREFORE, in consideration of the agreements of each of them herein contained, they do agree as follows:

(1) The STATE turns over and the TOWN accepts the right and obligation for future maintenance and repair of the following maintenance agreement areas of highways, pursuant to 19 V.S.A. § 310, as above referenced, which areas are more particularly described as follows:

SECTION 1:

MAINTENANCE AGREEMENT AREA #1: (Town Highway #24)

Beginning at a point in Town Highway #24, 18 feet distant northwesterly from approximate survey station 18+25 of the Vermont Route #11 centerline of Highway Project Manchester-Dorset RF 019-2 (14) Section I;

thence continuing 41 feet, more or less, northwesterly along Town Highway #24 to a point at station 10+67 on the revised Town Highway #24 centerline of said Highway Project.

MAINTENANCE AGREEMENT AREA #2: (Town Highway #8)

Beginning at a point in Town Highway #8 at station 13+87 on Town Highway #8 centerline of Highway Project Manchester-Dorset RF 019-2 (14) Section I;



- (2) It is understood and agreed that the Town of Manchester shall not permit any encroachments on the maintenance agreement areas described above without written permission of the Vermont Agency of Transportation.
- (3) The TOWN hereby releases and discharges the STATE from any and all damages or claims of damages now or in the future in connection with the rights and obligations herein contained.

It is also understood and agreed that a bridge located on Beech Ridge Access Road and is a part of Maintenance Agreement Area #1, Section II shall be plowed by the Town of Manchester in a manner which will not allow snow to go over the sides of the bridge and fall on the U.S. Route #7 below and that the State shall be responsible for maintenance of bridge and removal of snow left on the bridge.

In aid of the descriptions herein contained reference is hereby made to plans of Highway Project Manchester-Dorset RF 019-2 (14) Section I and II as filed on the 1st day of June, 1984, in the office of the Clerk of the Town of Manchester and on any revisions thereto subsequently filed therein.


