

#### Good afternoon,

Today I spoke with Manchester Village's Road Foreman (Alan Mowrey) regarding Main St, Union St, and West Union St. Now that I have better understanding of the status of roads in the Village of Manchester, I would like to ask the Village Trustees to add one mileage change to the 2022 Mileage Certificate that was sent out earlier this month.

In VTrans records, and on the Manchester Village Highway Map, the northbound lane of Main St has historically been shown as two "forks" of Union St (CL2 TH-4, see highlighted section in the map excerpt at the bottom of this email). Because this right of way is functioning as the northbound lane of Main St (rather than as part of Union St), we feel that it should be in our records as part of class 1 TH-1 (Main Street). It is therefore also appropriate to re-evaluate the length of Main St using the northbound lane instead of the southbound lane (as has been done previously) and of Union St without the "forks".

In order to determine new mileages of both Main St and Union St within the Village, I determined the current length of both highways using our mapping software. I also considered (for Union St), the length obtained during a VTrans field inventory accompanied by Road Foreman Alan Mowrey done in 1988 (see attached).

#### Main St:

With divided highways, VTrans typically only records the northbound mileage. The northbound lane is about 0.002 mi longer than the southbound lane (about 0.070 and 0.068, respectively), however, the official length of Main St (CL1 TH-1) in Manchester Village was already about 0.002 mi longer than the mapped length (as determined using our mapping software). Therefore the length of CL1-TH-1 does not need to be updated in our records. We might, however, adjust the mileage annotation on the map to more accurately reflect the relative lengths of each segment along Main Street (without changing the total mileage). The total length of Main St in the Village (CL1 TH-1) will remain 2.007 mi in our records.

#### Union St:

The mapped length of Union St (see highlighted segment in the second map excerpt at the bottom of this email) from the southbound lane of Main St to the Village/Town boundary on the eastern side of Bridge 44 is about 0.83 mi (rounded to the nearest 0.01 mi as is VTrans policy for most class 2 town highways). The measure obtained during the 1988 field inventory was also 0.53 mi, so that is the new measure we would like to assign to Union St. Because the milage associated with Union St has been 0.94 mi in our records (as indicated on the Village Highway Map), changing the mileage to 0.53 corresponds to a subtraction of 0.09 mi. This can be written on the 2022 Mileage Certificate in the "Remeasurement" section of PART II as:

-0.09 mi CL2 TH-4 (Union St) remeasured without the "forks" at intersection with Main St (CL1 TH-1).


#### West Union St (unpaved section):

Alan Mowrey said he would discuss the status of this portion of TH-109 with the Board of Trustees, so VTrans will wait to hear what the Village decides to do regarding this highway before addressing the issue of class 3 standards next year (if necessary).



Good afternoon,

Here is some information that might help you determine when the Village may have taken action regarding TH-109 (West Union St).

All of the archived Village Highway Maps that we have are available through our website: <a href="https://vtrans.vermont.gov/content/planning/maps/town-maps/highway-maps">https://vtrans.vermont.gov/content/planning/maps/town-maps/highway-maps</a>

In particular, note copies of the 1978 Village Highway Map (links below) marked up with a change that was processed with the 1979 Mileage Certificate (attached), which also indicates that West Union St was switched from TH-69 to TH-104 in our records at that time:

The 1979 change is described as a "remeasurement", suggesting that there was no legal change in the right of way, and that the existing road was remeasured and our records updated accordingly. At this time our records were still showing the highway was class 3, and this is the last known official change for West Union St that we are aware of.

Pages 19-20 of **Manchester\_Vi\_RoadMeasurementsInventory.pdf** show the portion of West Union St with unclear status, and the portion shown on p. 21 is the section of W Union St where the status is unambiguously class 3. This inventory was conducted in 1988, and Road Foreman Alan Mowrey was present during this inventory. The inventory notes indicate that TH-109 was blocked about 0.10 mi from Prospect St, so the inventory is in two parts (starting from Prospect St, and starting from Seminary Ave). There is no note from this time indicating that we were notified of any change in status of TH-109. Page 2 of **Manchester\_Vi\_RecordOfMileageChanges.pdf** shows that the only Manchester Village Mileage change processed by VTrans since 1979 was in 2018, when TH-110 (Ways Ln) was remeasured.
