

Hi Deborah,

Thank you so much for speaking with me. Here is the mileage certificate for Old Bennington Village for 2024. Note the preloaded change in Part III for a Class 3 road that we have found was not up to standards (or NUTs). This results in a **-0.06 mi reduction in Class 3 miles** and **an addition of 0.06 mi in Class 4 miles**. That is what needs to be entered into Part I of the certificate and what the Trustees should agree upon when they sign. We have attached instructions also for "preloaded changes"

Also make sure to **NOT** check the "No changes" box. Since there is a change, we would really need more than one trustee signature and would need Mary's signature and dated as well.

This Certificate must be completed in order to determine your town's share of state aid for town

highways for Fiscal Year 2025, and to ensure that your Town Highway Map remains current. Please note there will be no additional opportunities to submit town highway changes before the

2024 statutory deadline for mapping all Class 1, 2, 3 and 4 Town Highways and Legal Trails, as specified in 19 V.S.A. § 305(c).

Any changes in mileage or highway classification, such as additions, alterations, or discontinuances

made by your selectboard this past year, should be entered on this certificate. If there are changes that

occurred before this past year that are not shown on the Town Highway Map, please let us know so

Hi Mary,

I just checked your website and think we may have sent your mileage certificate to an old email address: janet.buonanno@gmail.com on 01/04/2024 with Old Bennington Village's 2024 Mileage Certificate attached. To date, we have not yet received this certificate, and therefore want to remind Old Bennington Village to sign and return the Certificate to the Mapping Section as soon as possible. For your convenience we have also attached a copy of the certificate to this email. Certificates can be scanned and returned to us at aot.mileagecertificates@vermont.gov.

There is a change preloaded in Part 3 of the certificate for TH-904, which is currently not up to Class 3 Standards and will therefore be designated as "NUTs" and have its mileage transferred to Class 4 and subtracted from Class 3, until either brought up to standards or reclassified. We have informed Stuart Hurd from the Town of Bennington of this change as well.

Please note that Part 1 of the Mileage Certificate needs be to filled in with this change and signed and returned to the Mapping Section. VTrans uses this certificate to confirm highway mileage for the purpose of allocating state aid for town roads.
