A copy of said Notice was posted in the Ryegate Town Clerk's Office on November 15, 1996 and remained so posted until after December 16, 1996.
(Date of Hearing)

At 7:10 P.M on Monday, the 16th day of December, 1996, the undersigned Selectmen of the Town of Ryegate met at the site of the reclassification on Town Highway #63 and examined the premises. The Selectmen then adjourned the Meeting to the Town Clerk's Office and proceeded to hear all persons present and who indicated that they wished to be heard. In attendance in addition to the undersigned Selectmen and Town Clerk were: Clark Bogie, road commissioner and Thomas Davies.

After examination of the premises and hearing all persons, the Selectmen decided by Motion made, seconded and duly passed, that the public good and the necessity and convenience of individuals require that the portion of Town Highway #63 in question be reclassified as hereinafter specified.

RECLASSIFICATION OF A PORTION OF TOWN HIGHWAY #63

Accordingly, it is hereby ordered that the following described portion of Town Highway #63 in the Town of Ryegate is reclassified from its current status as Class IV road to a Class III Road.

TOWN HIGHWAY #63

Being the portion of Town Highway #63 which is currently designated as a Class IV highway and commencing at the easterly terminus of the existing Class III portion of Town Highway #63 which itself extends easterly from State Aid #5; thence proceeding easterly and southerly along the existing Class IV portion of Town Highway #63 for .39 miles to the turnaround at the southeasterly terminus thereof.


RECORDING OF ORDER AND SURVEY

It is further ordered that the Town Highway maps be altered in accordance with this Order and that a copy of this Order and the above referred to survey description be recorded in the Town Records.


