
19 V.S.A. § 305. Measurement and inspection


§ 305. Measurement and inspection

- (a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.
- (b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.
- (c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.
- (d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.
- (e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.
- (f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description, or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.
- (g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate.

REPORT OF FINDINGS, CONCLUSIONS AND ORDER REGARDING THE CLASSIFICATION OF TOWN HIGHWAY #9 IN HUNTINGTON, VERMONT

The Town of Huntington, having initiated these proceedings by and through its Selectboard pursuant to 19 V.S.A. §§708-709 hereby makes its report regarding the reclassification of Town Highway #9 ("TH #9") and makes the following findings of fact, conclusions of law and order:

1. INITIATION OF RECLASSIFICATION PROCEEDING AND ISSUANCE OF PUBLIC NOTICE

The Town of Huntington Selectboard ("Selectboard") initiated this proceeding by public notice published in The Times Ink!, a local newspaper of general circulation and Huntington's paper of record, (April 2019 issue, page 20), on Front Porch Forum (comprised of over 750 households and 1,300 members), and on the Town's Website. Public notice was also posted on March 26, 2019 at the Town Office, Beaudry's Store and the Huntington Library, and distributed to the Huntington Planning Commission and the extensive Selectboard email distribution list (comprised of members of Town boards, commissions and committees and nearly 40 Huntington residents).1

The Selectboard gave public notice for examining the premises and hearing the persons interested pursuant to 19 V.S.A. §709 and 19 V.S.A. §310(d) and to consider the reclassification of TH #9 and any requests to plow and improve TH #9 as hereinafter stated:

The 0.06 mile length (316.8 feet) of TOWN HIGHWAY #9 (located off Happy Hollow Road) from Class 3 to Class 4 or legal trail, or to improve TH #9 to Class 3 highway standards. For in excess of twenty (20) years, TH #9 has routinely not been provided with winter maintenance or otherwise made negotiable to Class 3 standards for the full 0.06 mile length of TH #9. With the washout of an old boiler tube that served as a culvert and crossing over Johns Brook during the FEMA declared disaster of 2013, a portion of TH #9 has been inaccessible by vehicular traffic.

The Public Hearing for the proposed reclassification and improvement of TH #9 was noticed to be held at the Community Church of Huntington Annex (Huntington Center) beginning at 6:30 pm on Monday, May 13, 2019 and as thereafter reconvened.

Based on the Hearing Record, the testimony received during the hearings held on TH #9 and a public inspection of TH #9, the Selectboard hereby finds as follows:

xviii. Ex. 70, 71, 74a, 74b, 74c: Photographs

a. <u>Background</u>: For over twenty (20) years the Town has treated and maintained the 0.06 mile (316.8 feet) length of TH #9 (located off Happy Hollow Road) as a Class 4 Road. When the Town of Huntington participated in the FEMA declared disaster of July 3, 2013 (FEMA-4140-DR-VT), the Town did not address TH #9 as part of the FEMA recovery efforts because the Town's agents understood that it was a Class 4 road and therefore ineligible for FEMA disaster recovery funds. During that storm, TH #9's five-foot (5') boiler tube structure acting as a conduit for John's Brook at TH #9 washed out the south side of the pipe leaving a 9-foot (9') drop into a large scour hole that bypassed the pipe. As with all Class 3 roads damaged by that storm event, the Town would have addressed repairs to TH #9 had it understood at the time that

 TH #9 was classified on its State Aid Highway Map as a Class 3 highway with a so-called "NUTS" designation. The owners of property accessed by TH #9 did not object to the Town's decision to not repair the stream crossing.

Town staff and officials became aware of a potential discrepancy in the road classification of TH #9 in 2017, when the Town was informed by the Town Assessor that TH #9 was formally classified as a Class 3 road. After considerable research in consultation with the Vermont Agency of Transportation (VTrans) and the Town's attorney, the Selectboard determined to hold formal proceedings according to Vermont Statutes to designate and clarify the classification of the road and to then submit the required paperwork to VTrans in order to ensure the Vermont General Highway Map and Certificate for Highway Mileage for the Town of Huntington correctly reflects the road's classification status. Knowing that the road had not been maintained and did not meet Class 3 highway standards, the Town explicitly requested VTrans note the road as Class 3 "Not Up To Standard" (NUTS), thereby removing its 0.06 miles from eligibility for State Aid. The Town also offered to reimburse the State for the previous aid received, which was declined.

According to VTrans Mapping Section staff, when VTrans determines a road or portion of a road does not meet the standards of the particular class to which it is classified, VTrans will consider it to be functionally "Not Up To Standard" (NUTS). NUTS is not a road classification; it is a designation that means the mileage noted does not meet the standards for the class to which it is assigned. The mileage is deducted from that assigned to the town for the particular class of the road in question unless, within one year, the Town reclassifies or discontinues the portion of the road not up to standard, or develops a schedule acceptable to VTrans for restoring the road to accepted standards.

The Selectboard then initiated this highway proceeding to clarify and designate, for the record, the classification of TH #9 pursuant to Subchapter 2 of Chapter 7 of Title 19 of the Vermont Statutes Annotated.

b. <u>Historical Findings of Fact re Status of TH #9</u>: Per testimony and documentation received at the Public Hearings, the Selectboard hereby makes the following findings outlining the general chronology of public information of record relevant to TH #9:

6. FINDINGS OF FACT AND CONCLUSIONS RE: PUBLIC GOOD, NECESSITY AND CONVENIENCE:

After examining TH #9, hearing testimony from interested parties, and reviewing the documents submitted and admitted as evidence, the Huntington Selectboard unanimously finds the following facts and makes the following conclusions:

a. Facts

- i. It is the intent of the Selectboard of the Town of Huntington to maintain Town roads according to the statutory requirements for the legal classification status of municipal roads and to fully comply with all regulatory standards such as the new Municipal Roads General Permit (MRGP) standards.
- ii. As evidenced on the official State of Vermont Agency of Transportation (VTrans) Highway map from 1941, VTrans has long recognized TH #9 as a Town Highway that begins as a spur off of TH #7 (Happy Hollow Road) and dead-ends after 0.06 miles.
- iii. TH #9 is not currently a through-road and is not used by the general public to access a residence or a structure used for commercial purposes.
- iv. The August 23, 1993 VTrans re-measurement and inspection of Town Highways for the Town of Huntington noted TH #9 as being "Not Up To Standard" (NUTS).
- v. In 1994 the Town was notified by VTrans that if TH #9 was not brought up to Class 3 standard within one (1) year it would be reclassified as functionally Class 4, and therefore be ineligible for Class 3 State Aid.
- vi. The Town has not plowed, made negotiable during winter or maintained TH #9 since before 1993, and there have been no citizen complaints of record made to the Huntington Selectboard about lack of municipal maintenance for TH #9.
- vii. Town officials and staff have assumed, for over 20 years, that TH #9 was classified as a Class 4 road.
- viii. There are no permanent residences or businesses on the three (3) property parcels that are accessed from TH #9.
- ix. Lack of municipal maintenance for TH #9, including there being no stream crossing over Johns Brook, is not impeding the current use of any of the three (3) properties accessed from the road, and has not posed a threat to public safety.

- 254 x. The cost to upgrade the 0.06 miles of TH #9 to Class 3 standard has been 255 estimated by the Road Foreman to be \$33,154.25 plus an additional 256 \$120,000 for a stream crossing, for a total estimated upgrade cost of 257 \$153,154.25.
 - xi. The Road Foreman has estimated that based on current prices, the annual maintenance cost of having TH #9 maintained according to Class 3 standards will cost the Town an additional \$2,813.19 each year.
 - xii. The properties which abut or are accessed by TH #9 are all located within the Rural Residential Zoning District under Huntington's Zoning Regulations (7/9/2012).

b. Conclusions

- i. Classification of TH #9 as a Class 4 road is consistent with the Huntington Town Plan, as the properties that are accessed via TH #9 are not identified as preferable sites for development under the Town Plan and are located within the Rural Residential District or the Woodland District where protection of rural resources by efficient and limited development of land and PUD's is a high priority and the protection of environmentally fragile high elevation areas is of high importance.
- ii. The financial burden and costs required to upgrade TH #9 to Class 3 status (which would require the installation of a significant stream crossing structure), and for the ongoing maintenance required for this Class 3 roadway, would place a significant economic burden on Huntington taxpayers while providing minimal benefit to the inhabitants of Huntington and the general public.
- iii. Only one of the three adjoining landowners on TH #9 supports upgrading TH #9 to Class 3 standards as a means of delineating and defining the location of the public right-of-way for the purposes of preventing parking off of the traveled surface or right-of-way of TH #19; an issue which is not directly germane to this classification proceeding. The remaining property owners which abut TH #9 do not support classifying TH #9 as a Class 3 town highway and wish to see TH #9 classified as Class 4 to reduce unwanted traffic in a remote dead-end location.
- iv. Although TH #9 feeds directly into a private road, neither TH #9 nor the private road are through-roads or connect with other town highways or municipalities.

7. ORDER

Based on the above Findings of Fact and Conclusions of the Huntington Selectboard, it is hereby Moved, Ordered and Adjudged that the public good, necessity, and convenience of the inhabitants of the Town of Huntington requires that the full 0.06 mile length of TH #9 be immediately and formally reclassified as a Class 4 Town Highway, that the Town file such notice in the Town of Huntington Land Records, and that the Town of Huntington provide the required notice to the Vermont Agency of Transportation accordingly so that this is reflected on future Vermont General Highway Maps and in future State aid calculations.

REPORT OF FINDINGS, CONCLUSIONS AND ORDER

REGARDING THE CLASSIFICATION OF TOWN HIGHWAY # 15 IN HUNTINGTON, VERMONT

The Town of Huntington, having initiated these proceedings by and through its Selectboard pursuant to 19 V.S.A. §§708-709, hereby makes its report regarding the reclassification of Town Highway #15, also known as Stagecoach Road ("TH #15"), and makes the following findings of fact, conclusions of law and order:

1. INITIATION OF RECLASSIFICATION PROCEEDING AND ISSUANCE OF PUBLIC NOTICE

The Town of Huntington Selectboard ("Selectboard") initiated this proceeding by public notice published in The Times Inkl, a local newspaper of general circulation and Huntington's paper of record (April 2019 issue, page 20), on Front Porch Forum (comprised of over 750 households and 1,300 members), and on the Town's Website. Public notice was also posted on March 26, 2019 at the Town Office, Beaudry's Store and the Huntington Library, and distributed to the Huntington Planning Commission and the extensive Selectboard email distribution list (comprised of members of Town boards, commissions and committees and nearly 40 Huntington residents).1

The Selectboard gave public notice for examining the premises and hearing the persons interested pursuant to 19 V.S.A. §709 and 19 V.S.A. §310(d) to consider the reclassification of TH #15 and any requests to plow and improve TH #15 as hereinafter stated:

The 0.33 mile length (1,742.4 feet) of TOWN HIGHWAY #15 (also known as Stagecoach Road, located off upper Bert White Road) from Class 3 to Class 4 or legal trail or to improve TH #15 to Class 3 standards. maintained the 0.33 mile (1,742.4 feet) length of TH #15 as a Class 4 road. The Town has not provided any winter maintenance or made the road negotiable to Class 3 standards over that period of time.

Town staff and officials became aware of a potential discrepancy in the road classification of TH #15 in March 2018, when the Town Administrator contacted staff at the Vermont Agency of Transportation (VTrans) to discuss the Town's Certificate of Highway Mileage reporting for TH #9 (one of the other roads identified as having a classification discrepancy). At that time, the Town Administrator was informed that VTrans was looking into discrepancies they had recently uncovered in a number of towns across the state.

As early as 1982, VTrans determined that TH #15 was not being maintained at Class 3 standards. Their report indicated that TH #15 is only 6' wide, is washed out, has neither ditches nor culverts and is grown up in brush. VTrans indicated at that time that they would consider, for the purposes of calculating State Aid, the road to be functionally Class 4.

Minutes from the 12/18/1989 Selectboard meeting refer to TH #15 as a Class 4 road. In 1993, David and Myra Brautigam initiated plans to subdivide a 76 acre parcel adjacent to TH #15. An Agency of Natural Resources & Environmental Board review sheet from 1993 refers to TH #15 as an unimproved Class 4 Town road. It is further noted that any significant upgrading of the Class 4 Town Road by the current or future owners associated with the sale of the subdivided lots—including widening, resurfacing, or drainage improvements—will require a permit pursuant to Environmental Board Rule 2(A)(6). The survey plat submitted for the subdivision, which was approved by the Huntington Planning Commission, states in the notes section: "Town Highway 15, shown hereon, is a class 4 road". This survey is referenced in at least three (3) deeds transferring the subdivided parcels to: John and Sarah Burchard (in 1993); Dean and Lida Douglas (in 2005); and Brett and Kerry Lindemuth (in 2006).

Having discovered classification discrepancy in TH #15 and two other town highways, and after considerable research and consultation with the Vermont Agency of Transportation (VTrans) and the Town's attorney, the Selectboard determined to hold formal proceedings according to Vermont Statutes to determine and clarify the classification of the three (3) Town roads, including TH #15.

According to VTrans Mapping Section staff, when VTrans determines a road or portion of a road does not meet the standards of the particular class to which it is classified, VTrans will consider it to be functionally "Not Up To Standard" (NUTS). NUTS is not a road classification; it is a designation that means the mileage noted does not meet the standards for the class to which it is assigned. The mileage is deducted from that assigned to the town for the particular class of the road in

question unless, within one year, the Town reclassifies or discontinues the portion of the road not up to standard, or develops a schedule acceptable to VTrans for restoring the road to accepted standards.

No portion of TH #15 has been noted as NUTS by VTrans on the official Vermont General Highway Maps. Due to a clerical error by the State, the road mileage for TH #15 was never deducted from the Town's State Aid funding. Knowing that the Town has not maintained the road and that it does not meet Class 3 standards, the Town offered to reimburse the State for the previous aid received; the offer was declined. Vermont Statute does allow for the classification of a road that does not meet standard to a "provisional class 3 highway if within five years of the determination, it will meet all class 3 highway standards". VTrans provided the Town direction that provisional class 3 can only be used when a town shows evidence that there is full intent to bring the road up to class 3 standards. VTrans recommended that Huntington follow the statutory requirements to 1) bring the road up to Class 3 standard; 2) reclassify the road as either Class 4 or as a trail; or 3) discontinue the road.

6. FINDINGS OF FACT and CONCLUSIONS RE: PUBLIC GOOD, NECESSITY AND CONVENIENCE:

After examining TH #15, hearing testimony from interested parties, and reviewing the documents submitted and admitted as evidence, four (4) participating members of the Huntington Selectboard unanimously find the following facts and makes the following conclusions:

a. Facts

- i. It is the intent of the Selectboard of the Town of Huntington to maintain Town roads according to the statutory requirements for the legal classification status of municipal roads and to fully comply with all regulatory standards such as the new Municipal Roads General Permit (MRGP) standards.
- ii. For in excess of twenty-five (25) years, officials and employees of the Town of Huntington have treated and maintained the 0.33 miles of TH #15 as a Class 4 road.
- iii. During at least a 25 year period, TH #15 has never been maintained at Class 3 standards and no winter maintenance has been performed by the Town.
- iv. Through numerous written communications, subdivision plats, deeds, and documents of record, the property owners of the two (2) permanent residences that are accessed from TH #15 were advised that TH #15 was considered a Class 4 road prior to construction of their homes.
- Although TH #15 feeds directly into a private road, neither TH #15 nor the private road are through-roads or connect with other town highways or municipalities.
- vi. The cost to upgrade the 0.33 miles of TH #15 to Class 3 standard including the cost to widen the traveled surface, install surface drainage and ditching and provide a sufficient road base and pull off area for winter maintenance is estimated by the Huntington Road Foreman to be \$88,141.72.

- vii. The Huntington Road Foreman has also estimated that based on current prices, the annual maintenance cost of having TH #15 maintained according to Class 3 standards will cost the Town an additional \$11,085.73 each year.
- viii. Bringing TH #15 up to Class 3 standards will also require significant widening on the down slope side of TH #15 which is vigorously objected to by the adjoining landowner.
- ix. The widening of TH #15 would require the removal of multiple significant shade trees to meet minimum Class 3 road width requirements.
- x. The properties which abut or are accessed by TH #15 are all located within the Rural Residential Zoning District under Huntington's Zoning Regulations (7/9/2012).

b. Conclusions

- i. Classification of TH #15 as a Class 4 road is consistent with the Town Plan, as the properties which are accessed via TH #15 are not identified as preferable sites for development under the Town Plan and are located within the Rural Residential District or the Woodland District where protection of rural resources by efficient and limited development of land and PUD's is a high priority and the protection of environmentally fragile high elevation areas is of high importance.
- ii. Classification of TH #15 as a Class 4 road will not reduce the current access for abutting landowners or the general public abutting TH #15.
- iii. The construction required to upgrade TH #15 to Class 3 standard and the continuing necessity of ongoing winter and annual road maintenance have a high potential to increase erosion and sediment run-off in this area characterized by steep cross slopes.
- iv. The financial burden and costs to upgrade TH #15 to Class 3 status (which would require widening the road) and the ongoing annual and winter maintenance required for Class 3 roadways would place a significant financial burden on Huntington taxpayers with minimum benefit to the two residential properties which currently access their residences using TH #15. The Selectboard believes this cost would exceed any anticipated tax revenue benefit to the Town that might be actualized if upgrading the road led to increased development.
- v. The public good and convenience does not necessitate classifying and upgrading TH #15 to class 3 status and both the environmental impacts and the ongoing increased financial impacts to Huntington residents dictate that the public good is best served by continuing to maintain TH #15 as a class 4 highway and by formally classifying the entire 0.33 miles length of TH #15 as a class 4 highway.

7. ORDER Based on the above Findings of Fact and Conclusions of the Huntington Selectboard, it is hereby Moved, Ordered and Adjudged that the public good, necessity, and convenience of the inhabitants of the Town of Huntington requires that the entire 0.33 mile length of TH #15 be immediately and formally reclassified as a Class 4 Town Highway, that the Town file such notice in the Town of Huntington Land Records, and that the Town of Huntington provide the required notice to the Vermont Agency of Transportation accordingly so that this is reflected on future Vermont General Highway Maps and in future State aid calculations. This Report of Findings of Fact, Conclusions and Orders regarding the classification of TH #15 shall be recorded in the Huntington Town Clerk's Office. REPORT OF FINDINGS, CONCLUSIONS AND ORDER REGARDING THE CLASSIFICATION OF TOWN HIGHWAY # 26 IN HUNTINGTON, VERMONT

The Town of Huntington, having initiated these proceedings by and through its Selectboard pursuant to 19 V.S.A. §§708-709 hereby makes its report regarding the reclassification of 0.75 miles of Town Highway #26, also known as Trapp Road, ("TH #26") and makes the following findings of fact, conclusions of law and order:

1. INITIATION OF RECLASSIFICATION PROCEEDING AND ISSUANCE OF PUBLIC NOTICE

The Town of Huntington Selectboard ("Selectboard") initiated this proceeding, with public notice published in The Times Ink! newspaper (April 2019 issue, page 20), on Front Porch Forum (comprised of over 750 households and 1,300 members), and on the Town's Website. Public notice was also posted on March 26, 2019 at the Town Office, Beaudry's Store and the Huntington Library; and distributed to the Huntington Planning Commission and the extensive Selectboard email distribution list (comprised of members of Town boards, commissions and committees and nearly 40 Huntington residents).1

The Town of Huntington Selectboard gave public notice pursuant to 19 V.S.A. §709 and 19 V.S.A. §310(d) to consider the reclassification of TH #26 and any requests to plow and improve TH #26 as hereinafter stated:

A 0.75 mile portion of TOWN HIGHWAY #26 (also known as Trapp Road, located off of Main Road) from Class 3 to Class 4 or legal trail or to improve TH #26 to Class 3 standards. For in excess of twenty (20) years, the first 1.1 miles (5,808 feet) of TH #26 (from the Main Road to E-911 #1130, to the last residence on Trapp Road) has been maintained by the Town as a Class 3 road. The remaining 0.75 miles (3,960 feet) has, for in excess of twenty (20) years, not been provided with winter maintenance or made negotiable to Class 3 standards by the Town.

5. FINDINGS OF FACT

Based on the Hearing Record, the testimony received during the hearing held on TH #26 and a public inspection of the 0.75 mile section of TH #26, the Selectboard hereby finds as follows:

a. Background: The total length of TH #26 beginning at Main Road is 1.85 miles.

For over twenty (20) years the Town of Huntington has treated and maintained the last 0.75 miles (3,960 feet) of TH #26 as a Class 4 road. The Town has not provided any winter maintenance to that section of TH #26 or made that section of road negotiable under normal conditions all seasons of the year by a standard manufactured pleasure car over that period of time. The Town has maintained the road as a Class 3 road up to the 1.1 mile mark, which is the location of the curb cut to the last year-round residence on Trapp Road (known locally as "the Hoff Farm").

Summer and winter maintenance of the last 0.75 miles of Trapp Road (beginning at the Hoff Farm) as well as a private section of the road beyond the 1.85 mile mark,

has been historically done by members of the Pizzagalli family. According to Remo Pizzagalli, for over 30 years his family has maintained (at their personal expense) Trapp Road from the Hoff Farm to the gates leading to land owned by the State of Vermont and to the Pizzagalli private property.

Town staff and officials became aware of a potential discrepancy in the road classification of TH #26 in March 2018, when a principle of the Foundation for a Sustainable Future (FSF) came to the Town Office to research Trapp Road and informed the Town that Trapp Road is actually classified on its VTrans General Highway Map as Class 3 for a full 1.85 miles, and not the 1.1 miles the Town had assumed. On behalf of FSF, Shawn Smith attended a March 19, 2018 Selectboard meeting to discuss this discrepancy with the Selectboard. At that time the Selectboard indicated that more research was needed, including determining if there were other roadways besides TH #9 with classification discrepancies. On or about March 20, the State notified the Town that there also appeared to be a discrepancy in the classification of TH #15, known as Stagecoach Road.

In consultation with the Vermont Agency of Transportation (VTrans) and the Town's attorney, the Selectboard initiated formal highway proceedings according to Vermont Statutes to determine and clarify the classification of the final 0.75 miles of TH #26 as well as the classification status of two (2) other Town roads.

According to VTrans Mapping Section staff, when VTrans determines a road or portion of a road does not meet the standards of the particular class to which it is classified, VTrans will consider it to be functionally "Not Up To Standard" (NUTS). NUTS is not a road classification; it is a designation that means the mileage noted does not meet the standards for the class to which it is assigned. The mileage is deducted from that assigned to the town for the particular class of the road in question unless, within one year, the Town reclassifies or discontinues the portion of the road not up to standard, or develops a schedule acceptable to VTrans for restoring the road to accepted standards. No portion of TH #26 has, to date, been noted as NUTS by VTrans. Therefore, the full 1.85 miles have been included in the Town's Class 3 State Aid funding, Knowing that the Town has not maintained the last 0.75 miles of TH #26 and that it does not meet Class 3 standards, upon discovering the classification discrepancy, the Town offered to reimburse the State for the previous aid received. The offer was declined. Vermont Statute does allow for the classification of a road that does not meet standard to a "provisional class 3 highway if within five years of the determination, it will meet all class 3 highway standards". VTrans provided the Town direction that provisional class 3 can only be used when a town shows evidence that there is full intent (for example, through resolution or designated funding) to bring the road up to standard. VTrans recommended that Huntington follow the statutory requirements to either: 1) bring the final 0.75 miles of TH #26 up to Class 3 standard; 2) reclassify the final 0.75 miles

of TH #26 as either Class 4 or as a trail; or 3) discontinue the final 0.75 miles of TH #26 as a town highway.

b. <u>Historical Findings of Fact re TH #26</u>: Per testimony and documentation received at the Public Hearings, the Selectboard hereby makes the following findings outlining the general chronology of public information of record relevant to TH #26:

| March 2018 | Shawn Smith, from Foundation for a Sustainable Future (FSF) alerted the Town Administrator of a classification discrepancy for the last 0.75 miles of TH #26. Smith asked to attend a Selectboard meeting, indicating it would be for a preliminary discussion of TH #26's classification. |

6. FINDINGS OF FACT AND CONCLUSIONS RE: PUBLIC GOOD, NECESSITY AND CONVENIENCE:

After examining TH #26 and, specifically, the last 0.75 miles of TH #26, hearing testimony from interested parties, and reviewing the documents submitted and admitted as evidence, the Huntington Selectboard unanimously finds the following facts and makes the following conclusions:

a. Facts

- i. It is the intent of the Selectboard of the Town of Huntington to continue to maintain Town roads according to the statutory requirements for the legal classification status of municipal roads and to fully comply with all regulatory requirements such as the new Municipal Roads General Permit (MRGP) standards.
- ii. For over twenty (20) years (since before 1995), officials and employees of the Town of Huntington have understood and treated the first 1.1 miles of TH #26 as a Class 3 town highway and the final 0.75 miles of TH #26 as a Class 4 town highway. The Town has maintained each of the segments of TH #26 for the duration of that time according to the standards applicable to the classification status as understood by the Town through its agents and employees.
- iii. The section of TH #26 beyond the 1.1 mile mark (beyond the Hoff Farm) has been routinely and voluntarily maintained at the personal expense of the Pizzagalli Family, and not by the Town of Huntington, for over twenty (20) years.
- iv. No permanent or year-round residences and no businesses are currently or actively accessed from TH #26 beyond the 1.1 mile mark.
- v. There have been no reported or known threats to public safety as a result of the manner in which the full 1.85 miles of TH #26 have been maintained.
- vi. The initial cost to upgrade the final 0.75 miles of TH #26 to Class 3 standard was estimated by the Road Foreman to be \$75,501.90. Following a site visit from a Vermont Agency of Natural Resources river engineer and a study conducted by Milone and MacBroom it was determined that significant stream crossing upgrades would be required to bring the road into Class 3 and MRGP compliance. The revised estimate to upgrade the final 0.75 miles of TH #26 to Class 3 standard, based on this new information, is \$467,139.09.
- vii. The Road Foreman has estimated that based on current prices, the annual maintenance cost for the final 0.75 miles of TH #26 will be an additional \$15,283.45 each year.
- viii. The last 0.75 miles of TH #26 are currently used by the Pizzagalli family to access a seasonal camp used for hiking and recreation purposes and by the public for recreational purposes and to access the Camel's Hump State Forest. It has historically not been maintained to provide year round access by a standard manufactured pleasure vehicle nor has it been routinely plowed or made negotiable during the winter by a pleasure vehicle.

b. <u>Public Good, Necessity, and Convenience of the Inhabitants of the Town of</u> Huntington

 Maintaining the final 0.75 miles of TH #26 according to Class 4 standards has not impeded or negatively impacted access to properties accessed via TH #26 or access to public lands for recreational purposes.

- Reclassifying TH #26 for the final 0.75 miles as a Class 4 road will not impede or negatively impact current access to properties accessed via TH #26.
 - iii. Classification of the final 0.75 miles of TH #26 as a Class 4 road is consistent with the Town Plan, as property that could be accessed via TH #26 is not identified as preferable sites for development.
 - iv. Recreational use of the final 0.75 miles of TH #26 has been enhanced for decades because the road has been maintained at the assumed Class 4 status. These recreational uses include public access to the State of Vermont's Camel's Hump State Park, walking, hiking, mountain biking, cross country skiing, snowmobiling, and hunting. Upgrading the final 0.75 miles of TH #26 to Class 3 standard will negatively impact the recreational value of the pertinent 0.75 miles of TH #26, particularly for cross country skiing and snowmobiling.
 - v. Public recreational use, as a result of the current lack of year-round maintenance of the final 0.75 miles of TH #26, draws visitors to the Town which in turn provides economic benefits to Huntington small businesses.
 - vi. Continuing to maintain the last 0.75 miles of TH #26 as a Class 4 road is consistent with recreational goals stated in the Town Plan.
 - vii. Witnesses have expressed concern that upgrading the final 0.75 miles of TH #26 to Class 3 standard will negatively impact natural resources targeted in the Town Plan for protection, such as disturbance to wildlife crossings and wetland encroachment. Construction to widen the road and the annual maintenance required to meet Class 3 standards has the potential to create additional sediment runoff into streams that feed the Huntington River and will necessarily require the removal of old growth shade trees.
 - viii. The financial cost required to upgrade the final 0.75 miles of TH #26 to Class 3 status (which would require widening the road, raising the roadbed height in some sections, and installing culverts and stream crossings) and for the ongoing maintenance required for Class 3 roadways, would place a significant burden on Huntington taxpayers. The Selectboard believes this cost would exceed any anticipated tax revenue for the Town that could potentially be actualized if upgrading the road led to increased development.
 - ix. The only abutting landowner who supports upgrading the final 0.75 miles of TH #26 to Class 3 standards and for maintaining the full 1.85 miles of TH #26 as a Class 3 road does not currently use this section of road as an active access to their residence or other buildings or structures on the property.
 - x. The only landowner who actively and currently uses TH #26 to access a seasonal camp and traditionally maintains this section of TH #26 supports classifying and maintaining the final 0.75 miles of TH #26 as a class 4 road.
 - xi. No permanent or year-round residences and no businesses are currently directly accessed from TH #26 beyond the 1.1 mile mark at the Hoff Farm.

7. ORDER Based on these Findings of Fact and Conclusions of the Huntington Selectboard, it is hereby Ordered and Adjudged that the public good, necessity, and convenience of the inhabitants of the Town of Huntington requires that the final 0.75 mile length of TH #26 from the 1.1 mile mark (at the Hoff Farm) to the end of the Town road at the 1.85 mile mark be immediately and formally reclassified to a Class 4 Town Highway, that the Town file such notice in the Town of Huntington Land Records, and that the Town of Huntington provide required notice the Vermont Agency of Transportation accordingly so that this is reflected on future Vermont General Highway Maps. This Report of Findings of Fact, Conclusions and Orders regarding the classification of TH #26 shall be recorded in the Huntington Town Clerk's Office.
