

# TOWN OF UNDERHILL, VERMONT SELECTBOARD'S RETURN AND ORDER

In Re: Discontinuance/Non-Discontinuance of a portion of Butler Lane also known as Butler Road (Town Highway 11) Right-of-way

The Town of Underhill Selectboard held a duly warned public hearing on July 15, 2021, pursuant to 19 V.S.A. § 708, et seq., for the purpose of hearing all persons interested in the matter of whether the Town of Underhill should discontinue a portion of the town highway right-of-way for Butler Lane, also known as Butler Road and Town Highway 11 (TH 11). Prior to the hearing, on July 14, 2021, the Selectboard held a public examination of the portion of Butler Lane.

The portion being considered for discontinuance is described as follows: "Starting at or near the northeast boundary corner of the property located at #23 Butler Lane, also known as Butler Road, said terminus being approximately 1300 feet northerly of the intersection of Town Highway 4 and Town Highway 11, and then proceeding northerly on Town Highway 11 to the Underhill-Cambridge Town Line."

# Introduction and Procedural Background

- The Notice of Examination of Premises and Public Hearing of Discontinuance of the right-of-way for a portion of Butler Lane, also known as Butler Road (Town Highway 11), was posted at the Town of Underhill Clerk's Office on June 7, 2021. Notice was also posted at the Underhill Center Post Office and Jacobs Family Market and on the Town's website home page.
- 2. On June 10, 2021, the Notice was delivered to the Town of Underhill Planning Commission.
- 3. The Notice was published in the Burlington Free Press on June 30, 2021.
- 4. The Notice was published in the Mountain Gazette, Vol. 21 No.1 on July 1, 2021.
- 5. On June 7, 2021, the Notice was sent by certified mail to the Commissioner of Forest, Parks and Recreation.
- 6. On June 7, 2021, the Notice was sent by certified mail to the Town of Cambridge Selectboard.

- 7. On June 7, 2021, the Notice was sent by certified mail to the persons owning or interested in the lands on that portion which Town Highway 11 passes or abuts.
- 8. On July 14, 2021, the Selectboard conducted an Examination of the Premises at 6:00 PM on the portion of Town Highway 11 being considered for discontinuance. Minutes from the Examination, which include a list of the interested persons, are available at the Underhill Town Clerk's Office as well as on the Town's website.
- 9. On July 15, 2021, at 6:00 PM, the Selectboard convened an in-person public hearing at the Underhill Town Clerk's Office, located at 12 Pleasant Valley Road. Interested persons also participated virtually and by telephone using remote meeting link information provided in the Notice. Detailed minutes from the hearing are available at the Underhill Town Clerk's Office as well as on the Town's website.
- 10. Written testimony was received by hand delivery and by email prior to the hearing.
- 11. Testimony was given by the Underhill Town Administrator, Brad Holden.
- 12. Testimony was given by interested persons as detailed in the hearing minutes.
- 13. At approximately 8:40 PM the Board closed the evidentiary portion of the hearing.

Except as otherwise indicated, all of the written and oral testimony, submittals and other evidence cited above and summarized in the above-referenced hearing minutes (which are, themselves, incorporated herein by reference) were reviewed and considered by the Selectboard in rendering this decision.

## **Findings**

- 1. Based upon the survey of record recorded in Town Meeting Records 1847-1866 Page 35, TH 11 appears to have been originally laid out three rods (49.5 feet) in width and opened to the public on November 28, 1849.
- 2. Based upon the survey of a highway from Underhill Center to Cambridge Burrough recorded in Town Records Volume 4 (1866-1893) Pages 28-29, TH 11 was resurveyed and reestablished as three rods (49.5 feet) in width, said survey received for record on February 29, 1868. In order for the highway to be utilized again a comprehensive re-survey would need to be completed in order to determine the exact location of the right-of-way.
- 3. The portion of TH 11 being considered for discontinuance has two sets of existing stone bridge abutments, where two bridges previously crossed over the Settlement Brook.
- 4. Reputedly the two bridges which previously crossed the Brook were destroyed by flooding sometime during the 1930s and, in order to utilize the highway again, new bridges would need to be engineered, designed, and reconstructed. It is not known whether the historic bridge abutments could be reused or if new abutments would be needed.
- 5. The 1956 Vermont General Highway Map depicts the entire length of TH 11 as untraveled.
- 6. The 1969 Vermont General Highway Map depicts the southern half of TH 11 as a soil surface 2<sup>nd</sup> class gravel road and the northern half as untraveled.
- 7. The 2016 Vermont General Highway Map depicts the entire length of TH 11 as a Class 4 Town Highway with the southern half having a surface of soil or graded and drained earth and the northern half is designated as untraveled. The untraveled portion is heavily vegetated and would require significant rehabilitation even for pedestrian use.
- 8. The entire length of TH 11 is considered to be a Hydrologically Connected Road Segment per the Vermont Natural Resources Atlas.
- The portion of TH 11 being considered for discontinuance is located in a Zone A Special Flood Hazard Area according to 2011 FEMA DFIRM map 50007C.

- 10. Since the presumed right-of-way has been untraveled for the past approximately 80 years significant natural reforestation has occurred. A significant number of trees, some of substantial size, would need to be cleared in order to reopen public access.
- 11. Based upon Findings 7-10, above, any rehabilitation in the right-of-way could only be achieved under stringent environmental oversight, regulation, and permitting, including but not limited to State wetland, floodplain, stormwater and stream alteration review.
- 12. Given the location of the above-referenced bridge abutments, the natural barrier of the stream, and currently unavailable bridge structures, it would be nearly impossible to mobilize necessary equipment onto the right-of-way for improvement purposes without traversing private property.
- 13. The Town of Underhill Selectboard considered all of Town Highway 11 for reclassification or discontinuance at a December 2, 1995 examination of premises and at a public hearing on December 6, 1995. At that time, the Selectboard confirmed that the highway was an "inter-town highway" and therefore subject to a different procedure. The Underhill Selectboard concluded that it should contact the Cambridge Selectboard to set a joint hearing. Said joint hearing was never held.
- 14. Any effort to link the right-of-way of TH 11, which was once part of the original route that connected Underhill Center with Cambridge Borough, is dependent on the commitment of the Town of Cambridge toward the same goal. At the time of this writing, the Town of Cambridge Selectboard as evidenced in correspondence from Cambridge's attorney does not appear interested in pursuing either an independent or collaborative effort to restore the original right-of-way that links the two towns. Therefore, for all practical purposes, any effort of the Town of Underhill to maintain any type of access would come to a dead end at the town boundary.
- 15. While precise estimates are not available, any effort to restore the historic right-of-way for the segment of TH 11 at issue here would involve substantial cost to the Town of Underhill to reestablish a route that has been largely untraveled by the general public for many years, over the objections of the adjoining landowners. Multiple well-established, alternate vehicular routes to Cambridge now exist in the Town, as do other recreational corridors.

#### **DECISION AND ORDER**

The portion of TH 11 under consideration is described as follows: "Starting at or near the northeast boundary corner of the property located at #23 Butler Lane, also known as Butler Road, said terminus being approximately 1300 feet northerly of the intersection of Town Highway 4 and Town Highway 11, and then proceeding northerly on Town Highway 11 to the Underhill-Cambridge Town Line."

On the basis of the foregoing findings, it is clear that the segment of Butler Lane at issue in this proceeding should be discontinued. The segment of Butler Road, described above, has long been largely untraveled and could only be reestablished at substantial cost to and effort by the Town. This work would involve resurveying the right-of-way, engineering, designing and constructing new crossings of Settlement Brook, acquiring new temporary and permanent access rights from adjoining landowners, removing numerous large trees and applying to the State for necessary environmental permits, among other things. Even with this effort and expense, a vehicular right-of-way to the Town of Cambridge would only exist if Cambridge similarly decided to reestablish its right of way on the other side of the municipal boundary. This appears highly unlikely at this time. This route generally has not been used by the public in many years, nor is it needed or convenient in any way. Therefore, after examining the premises, hearing evidence from all interested persons, and reviewing the record, it is the Selectboard's determination that the public good, necessity and convenience of the inhabitants of the Town of Underhill warrants discontinuing the above-described portion of Town Highway 11.

This decision to discontinue the northern portion of TH 11 is based on the condition that the Town of Underhill is able to utilize a reasonable area near the terminus of the southern portion of the discontinued segment for the purpose of turning around town and emergency vehicles. The location of the turn-around will be determined and defined at a later date.

IT IS HEREBY ORDERED: The above-described segment of TH 11 (Butler Lane) is **DISCONTINUED** as a public highway. This Order shall be recorded by the Town Clerk, per 19 V.S.A. § 711.
