## Vermont Statutes Annotated

### 19 V.S.A. § 305. Measurement and inspection

#### § 305. Measurement and inspection

(a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.

(b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.

(c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.

(d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.

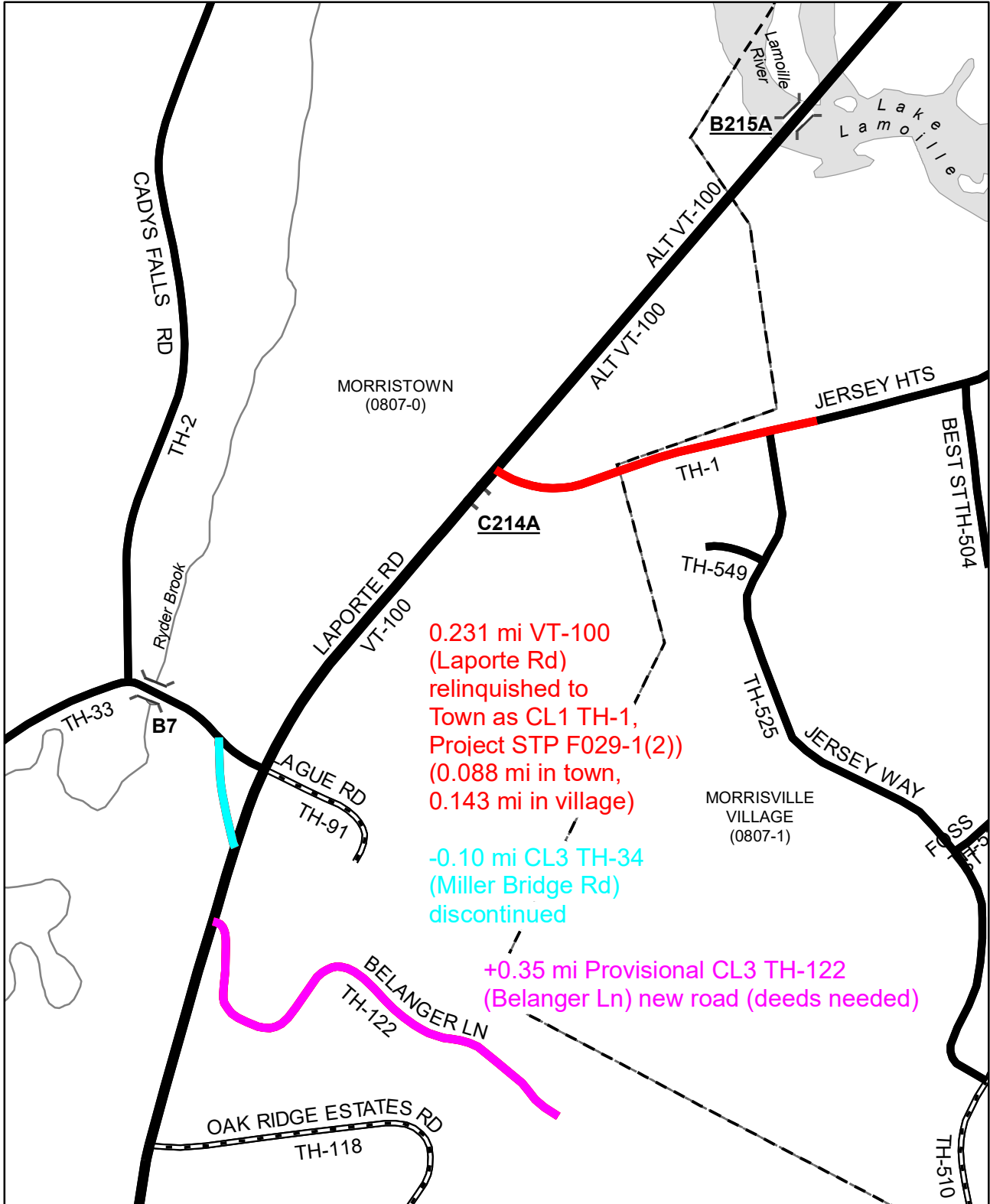
(e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.

(f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description, or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.

(g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate.

## **SELECT BOARD MEETING OF NOVEMBER 18, 2019**

**Department Heads:** Dan Lindley, Town Administrator; Richard Keith, Chief of Police; Bill Mapes, Chief of EMS; Kevin Barrows, Highway Foreman; Tina Sweet, Finance Director; Sara Haskins, Town Clerk/Treasurer; and Denny DiGregorio, Fire Chief

**Guests:** Nancy Pritchard, Sarah Kourkoulis, Peter Kourkoulis, Jude Prashaw, Becky Doherty, Scott Loug, Gary Nolan, and Lucas Peterson

**Bob Beeman called the Select Board Meeting to order at 6:00 PM.**

### **I. AGENDA CHANGES OR ADDITIONS**

2. Move budget discussion to after New Business

### **II. APPROVE MINUTES OF PREVIOUS MEETING**

**Motion made by Chris Towne to approve minutes of November 04, 2019. Motion seconded by Eric Dodge. Motion Carried. (5/0)**

**Minutes of the November 13, 2019 meeting were unavailable for review and approval. Dan will add the November 13, 2019 minute approval to the next meeting agenda.**

### **III. COMMUNITY CONCERNS**

1. A community member shared concerns about a policy that had been changed and asked for clarification as to why the change was made and not shared with the public. Initially the policy stated that an employee was required to provide written notification when engaging in work outside of their Town position. The Select Board explained that the policy had been changed because they felt it was

unnecessary for employees to submit written notification. The Select Board felt that verbal discussion with the Town Administrator was sufficient.

#### **IV. LIQUOR CONTROL**

1. None

#### **V. OLD BUSINESS**

1. **Discuss and Approve Belanger Lane as a Town Road** - Kevin Barrows, Highway Foreman stated that Belanger Lane met the Town requirement for becoming a Town Road. Dan Lindley, Town Administrator shared that the residents on the road would need to deed the road to the Town before it would become an official Town Road.

**Motion made by Chris Towne to approve Belanger Lane as a Town Road. Motion seconded by Brain Kellogg. Further discussion – Eric Dodge wanted to know the effective date that Belanger Lane would become a Town Road. Motion amended by Chris Towne to include an effective date of November 19, 2019 with the understanding that the road would need to be deeded to the Town. Motion carried. (5/0)**

#### **VI. NEW BUSINESS**

1. **Discuss Morristown Pickle Ball League** - Jude Prashaw who is involved with the Pickle Ball group provided information regarding the lack of available places to play and the option that is currently available. The group has been given permission to play in Wolcott. In order to do so the group is required to provide insurance coverage. Jude shared that she contacted VLCT and was told that if the Town recognized the Pickle Ball group as an official league under the Parks and Recreation Department that they would be able to obtain insurance coverage under the Town's insurance umbrella policy. Sara Haskins, Town Clerk/Treasurer shared that the Parks and Recreation committee discussed the needs of the Pickle Ball group but that they were unable to reach a decision and were looking for direction from the Select Board. Dan Lindley, Town Administrator said that a waiver would need to be signed by all group participants and that Tina Sweet, Finance Director would have one available. Dan also indicated that the risk would be minimal and that no additional insurance expense would be incurred for providing coverage for the group. The Select Board had several concerns which were as follows: what this would mean for other possible groups, what the liability Insurance would cover, who the insurance would be extended to in the future, and how the group waivers would be monitored. Sara Haskins, Town Clerk/Treasurer felt that the waiver could be

completed through the Parks and Recreation website but reminded everyone that the Parks and Recreation committee did not have a paid staff member to manage the website. Any work involved in setting up the Pickle Ball group on the website would need to be completed by her. Having time available to do so was a concern.

**Motion made by Chris Towne to allow the Pickle Ball group to be considered an official group under the Parks and Recreation Department for a 7 month trial period with the understanding that waivers would be required for all participants. Motion seconded by Judy Bickford. Motion carried. (5/0)**

**2. Approve Stagecoach Rd. Repairs – Storm Damage –** Dan Lindley, Town Administrator asked for approval to provide a temporary repair to the damage on Stagecoach Road. The section being repaired would need to be repaved in the spring. The repair would be to get us through the winter months only. Judy Bickford, Select Board asked about the approval process for FEMA funding? Dan shared that it would be quite some time before we would have answers on the available FEMA funds. The Select Board reviewed two proposals for the repair: First one from ECI in the amount of \$8,330. and a second proposal from J. Hutchins in the amount of \$17,250.

**Motion made by Brian Kellogg to approve the bid from ECI with a not to exceed limit of \$9,000. and Dan Lindley, Town Administrator to approve full scope of work. Motion seconded by Chris Towne. Motion carried. (5/0)**

**3. Discuss Gallery Lane as a Town Road –** Gary Nolan acting on behalf of Manosh asked that Gallery Lane, from the bypass to the beginning of the buildings, be considered as a Town Road. Eric Dodge, Select Board asked if the road met the Town requirements. Bob Beeman, Select Board asked if there was sufficient room available for snow removal as well as proper drainage. Kevin Barrows, Highway Forman will look at the road to determine that it meets the Town requirements. Site visit will need to be scheduled. The meeting for the site visit will be scheduled and warned.

**4. Approve Change to Personnel Policy Section 20 Educational Travel & Lodging –** Dan Lindley, Town Administrator was asked if a current policy was in place? Dan shared that the only policy currently in place was for the police department. He also shared that the intent of this policy was to make things consistent and employees aware of what are reimbursable expenses. Several recommendations to the draft policy were provided by the Select Board as well as Department

Heads. It was decided that some modification needed to be made to the draft policy. Further review and discussion will take place at a future time.

**VII. BUDGET**

1. **Budget** – Department Heads from EMS, Fire and the Police Departments reviewed their budget with the Select Board. Overall the budgets are level funded. The need for an additional police officer was discussed at length. Discussion took place about upcoming department needs and how we should be thinking ahead about the infrastructure needs for each department. Select Board will approve the budget at a future meeting.

**VIII. APPROVE WARRANTS**

**Motion made by Eric Dodge to approve Warrants through November 17, 2019.  
Motion seconded by Brian Kellogg. Motion carried. (5/0)**

**IX. TA REPORT**

- Thanksgiving gift cards were issued again this year. The amount was \$40. per employee and location options were the same as approved last year by the Select Board.
- Three roads are still closed due to the flood: Cole Hill, Sterling Valley and Mud City Loop. All homes are able to be accessed and are not being considered as isolated areas. We requested a temporary bridge on Mud City Loop. The State owns the temporary bridge and because there isn't any isolated areas they have the right to take the bridge back if deemed necessary. Goeltz road is open. The engineer recognized that head walls needed to be added. There is money in the bridge reserve to complete the work.

Do you have a sense of when you will have the remaining deeds? How likely is it that you might not have them by the end of the month? I'm just trying to determine if I should wait a week or two to process the certificate, or to go ahead and process it now as a provisional class 3. The provisional option is the same as normal class 3 in our records, except that it's a temporary designation noted in our records and on the map... It will be considered class 3 (or removed from the mileage totals) depending on whether or not we get full documentation, preferably within a year. We did this with Hinesburg for part of Mulberry Ln a couple years ago.

Let me know if you have any questions! I have email access today, and will be in my office tomorrow.

Assuming that Old Creamery Rd doesn't extend past parcel #46 as shown on the ROW plans, here are the changes for Part II on this year's certificate:

Hi Dan,

I think I have all the mileage changes calculated, and am working on writing them out for you. In the meantime, I have a few quick/easy questions for you:

I just wanted to double check with you that Old Creamery Rd ends at the parcel boundary you indicated on the marked up plan you sent last week, rather than continuing further north to where the new pavement and painted centerline ends (as visible in the street view image below). I have some notes (outdated or maybe my own hypothesis) from last year suggesting this is the end, so I wanted to clear all doubt from my head. 😊

Does Laporte Rd become Jersey Hts at the intersection with Jersey Way? Or at some other location? That's what E911 shows in their data, but I couldn't find sign confirmation in Street View.

Does Belanger Ln still have a gravel surface?

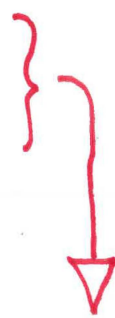

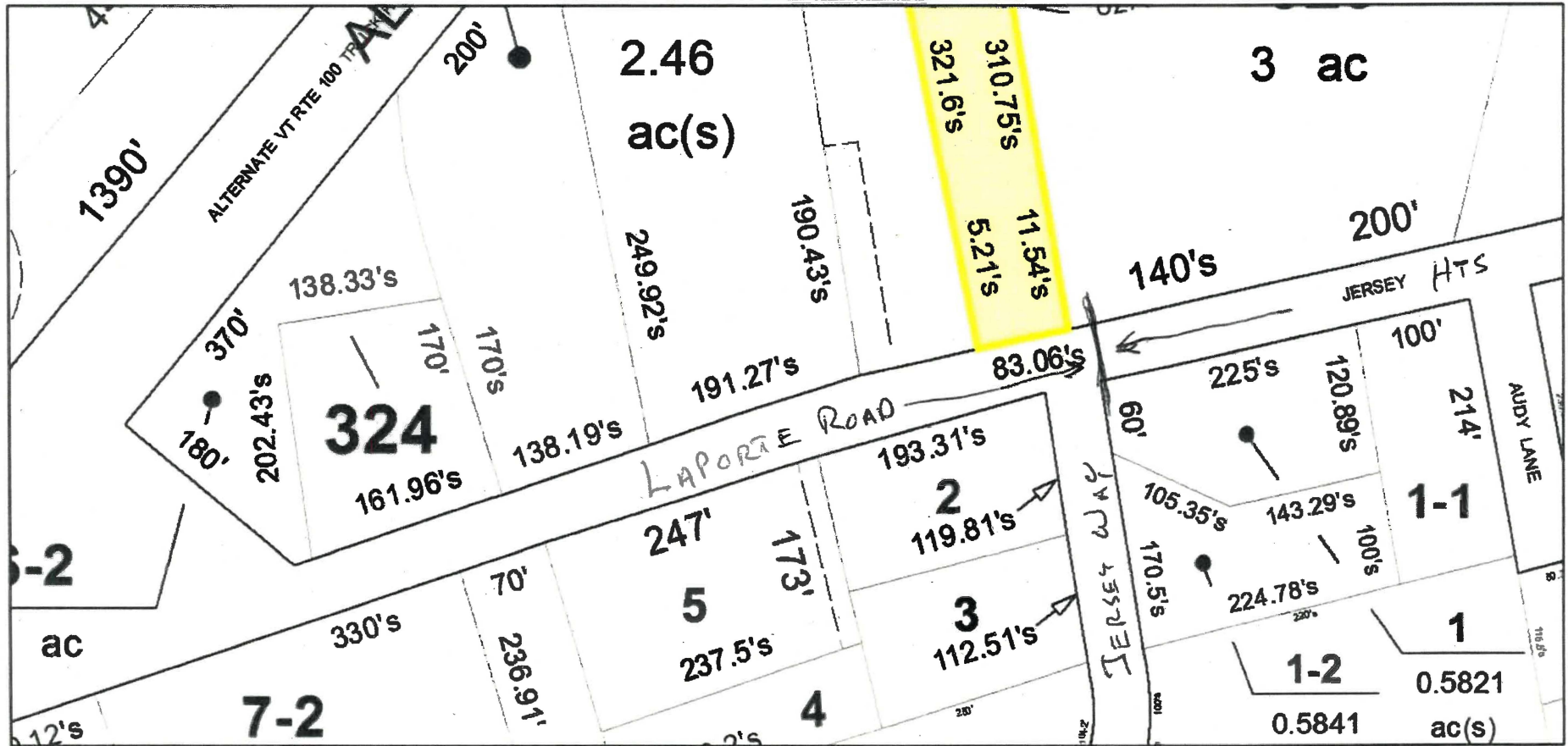

Hi Dan,

Now that I've had a chance to look back over the documentation you sent me last year and our correspondence regarding the Morrystown changes, I realize that things are not as ready-to-go as I remembered! I've attached two maps from my previous email, as well as a map

The tricky issues, if I remember correctly, were all related to highway descriptions being in terms of relinquished (or deeded) parcels that only cover portions of the highways being accepted. Has any progress been made to address the following?:

- a) No documentation for the first 0.143 mi of Laporte Rd *within the Village* (and ~2 ft *before* the village line), because relinquishment #7 only covers 140 meters of VT-100 between Alt 100 and [~2 ft short of] the Village Line. This section is highlighted in yellow on the map excerpt at the bottom of this email.
- b) The deed for parcels of Old Creamery Rd don't fully correspond to the road as visible on the ground.
- c) A gap between Wabun Ave as shown on the Town Highway Map and the relinquished parcel described as Westside Ct.

I've attached copies of the relinquishment documentation and the most relevant pages from the plans (highlighting the relinquishments).

Another issue we probably didn't discuss, but which should be straight forward to work through, is clarification on where VFW St ends after the partial discontinuance. The mileage we have on record is 0.04 mi, but that is the length rounded to the nearest 0.01 mi, and it's unclear whether the length includes the distance extending to the centerline of Pleasant St. Therefore simply subtracting 120 ft might or might not result in an accurate map or new total measure. Could you mark the endpoint of VFW St on the third attached map, or describe it in more detail?

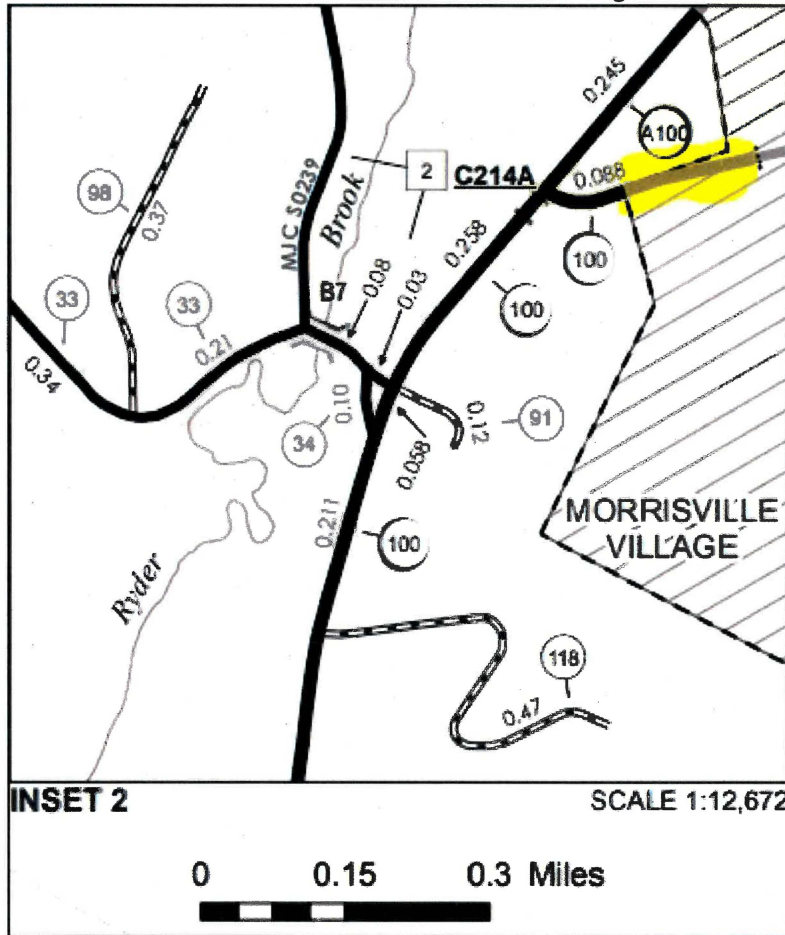

Hi Dan,

The following questions are a lot to process, so I expect we will have to talk on the phone to get things clarified, but hopefully this will give you a head start.

Could you (or whoever wrote up the descriptions) indicate on the attached maps specifically where each section of new highway begins and ends? That will make it easier for me to verify whether the laying out descriptions match what is drawn.

Do you have a description of the Old Creamery Rd? I have the deed, but it only describes parcels, and there appear to be parts of that road that were already town owned, and therefore were not included in the deed.

On the attached maps, the centerlines drawn over the imagery and plans represent our data, so you can also confirm whether our linework matches what the town believes was already public. If it doesn't, then those issues also need to be resolved. There are some existing discrepancies in the measures associated with our data, so I expect there may be differences that need to be resolved once it's clear where the legal preexisting alignments begin/end (e.g. Wabun Ave).

Last but not least, where does Wabun Ave end and Westside Ln begin? Does part of the new laying out belong to Wabun Ave? Or is Wabun Ave longer than we show in the attached map?

The reason I'm asking so many questions is because I didn't realize that the documentation you provided me with hadn't been summarized, the mileages estimated, or the layout marked up on a town highway map... so I don't have enough information to simply verify mileages or to provide simple wording for noting the change on the Certificate (or to feel confident that I'm mapping what is described in the documentation rather than mapping what I see in the imagery). I have plans from the State project, but they don't explicitly show which portions of which highways have (or have not) been accepted. The highway descriptions involve several vague directions (e.g. "Right" or "Southeasterly" as opposed to precise angles), so a lot of assumptions are involved. With a lot of trial and error I might find an alignment that is consistent with the information I have, but it might not rule out other possible interpretations, so I'm reluctant to go further without more information.

**RELINQUISHMENT AND MAINTENANCE AGREEMENT**  
**BETWEEN**

**THIS AGREEMENT**, made by and between the State of Vermont, Agency of Transportation, (“STATE”), and the Town of Morristown, a municipal corporation located in the County of Lamoille and State of Vermont, acting through its Selectboard (“TOWN”).

**WITNESSETH:**

**WHEREAS**, the State recently completed work in connection with Transportation Project Morristown STP F 029-1 (2) (the “Transportation Project”), a project that created an alternative truck route around the Village of Morrisville; and

**WHEREAS**, the parties agree that upon conclusion of construction, it is now appropriate to relinquish certain sections of Highway from STATE control to TOWN control, referred to as “relinquishment”; and that the maintenance and repair of a certain portion of Town Highway #91 (Lague Road), Town Highway #33 (Morristown Corners Road), Town Highway #5 (Bridge Street), Access Road West (n/k/a Old Creamery Road), Town Highway #83 (Stafford Avenue), Town Highway #12 (Silver Ridge Road), and Town Highway #11 (Needles Eye Road), referred to as “maintenance agreement zones,” should be under the control of the TOWN pursuant to 19 V.S.A. § 310 and that the relinquishment and assignment of maintenance and repair to the Town is in the best public interest;

**NOW, THEREFORE**, the parties, intending to be legally bound, hereby agree as follows:

**1. Relinquishment.** The State hereby relinquishes and the Town hereby accepts control of the following:

**2. Control of Junkyards.** No junkyards as defined in 23 U.S.C. § 136 and 24 V.S. A. § 2241, shall be established or maintained on the relinquishment areas.

**3. Control of Outdoor Advertising.** Any outdoor advertising structures erected on the relinquishment areas herein described shall comply with 23 U.S. C. § 131 and 10 V.S. A. Chapter 21.

**4. Future Maintenance and Repairs.** The Town will be responsible for all future maintenance and repairs in connection with the relinquishment areas described above.

**5. Encroachments.** The Town will not permit any encroachments on the relinquishment areas without written permission of the State.

**6. Maintenance Agreement Zone.** In certain areas, hereinafter referred to as "maintenance agreement zones", the operation and maintenance of certain portions of Town Highways should be under control of the Town.

**7. Description of Maintenance Agreement Zones.** The STATE turns over and the TOWN accepts the right and obligation for future maintenance and repairs on the sections of Highway located within the maintenance agreement zones. The maintenance agreement zones are described as follows:

**MAINTENANCE AGREEMENT ZONE #1: (Town Highway #91 [Lague Road])**

Beginning at a point in Town Highway #91 (Lague Road), at station 2+003.601 on the Town Highway #91 centerline of the Transportation Project;

thence 11.642 meters (38.20 feet), more or less, southeasterly along the Town Highway 91 centerline to a point at station 2+015.243 on the Town Highway #91 centerline of the Transportation Project.
