

Good afternoon Carolyn,

We have not received any changes from the Town of Thetford regarding TH-26 (Jackson Brook Road) and have not changed the mileage or classification on the town highway map. There were no changes submitted by the Town on the 2023 mileage certificate

(https://vtransmaps.vermont.gov/Maps/Publications/MileageCertificates/ArchivedMile ageCertificates/Orange_Co/THETFORD/THETFORD_MILEAGECERT_2023.pdf), which is the catalyst for changes to the town highway map.

Any changes that Town of Thetford may have made since February 10th, 2023, will be submitted with the next mileage certificate in 2024 and subsequent updates to the town highway map will be made based on the changes. We haven't received any correspondence from the Town of Thetford since the 2023 mileage certificate was submitted to us, so we do not have any details of what changes might have occurred to TH-26 (Jackson Brook Road) in the last few months.

The last town highway map that was produced for Thetford was in 2022 and has TH-26 listed as 0.24 miles of class 3 town highway and 0.28 miles of class 4. Here is a link to this map:

Acting on the advice of the Thetford Town Attorney, the Selectboard is asking for a correction to its mileage certificate be made. The Town has determined that Jackson Brook (TH #26) is incorrectly listed as being 0.28 miles of Class IV and 0.24 miles of Class III road. Given that the road was discontinued in 1858, only a portion of that historic road can be considered a town road. That being the 0.34 miles of actively maintained Class III road.

The Selectboard affirmed this interpretation in its regular meeting on Monday, April 17th 2023.

Brian Story Thetford Town Manager Lawyer Monaghan has mistaken impression. From day one we said we would work with the Manis to insure access.

These are the actions we need from the Selectboard Rescind vote of November 7 Make the class 4 portion of the road disappear forever Notify VTrans of this change

We have contacted the Hertzenberg heirs and they stated their intent was to quit claim the land to the abutters Hack and Watts.

Quote from Hertzenberg heir"

"I do remember that the road going up the hill just past cemetery was a town road because of the cemetery. To the best of my knowledge, the road bed continuing straight now servicing Hack and Watts was always considered by us a farm or logging road to access agricultural fields, woodlands and the upper pond. I never knew nor was told it was a class 4 road but in selling the land on behalf of my mother recognized it could be used as frontage for these two properties."

We will not accept that there ever was a town highway running this property without proper documentation —Survey, Acceptance Discontinuance

We want to sit down with the Manis and Watts to negotiate terms of access.

Sharon Harkay called the meeting to order at 7:00 PM.

1. Agenda Review

Sharon said by accident the agenda item for public comment ended up as #11 and she would like to move it to after the Town Manager comments. Sharon said that she would like to add in an Executive Session after minutes and warrants as she received information this afternoon that should be discussed.

2. Notes from the Selectboard Chair

Sharon said that there will be an agenda item for the May 1st meeting about "No Mow May". The Agency of Agriculture is pushing the movement and there have been requests for Thetford to participate.

Sharon said the Selectboard had Town Manager candidate interviews on Saturday which went really well.

3. Town Manager Report – Bryan Gazda

Bryan said he found out on Friday from the NH DOT that the Thetford-Lyme bridge is scheduled to close on April 27th.

There will be a Public Tax Sale on Thursday, April 20th at 10:00 AM at Town Hall for 2 delinquent properties.

Bryan attended a meeting with West Fairlee Selectboard chair regarding the Route 113 culvert replacement project at the West Fairlee and Thetford town lines. As of now, that section of the road is scheduled to be closed on the weekend of June 10th and 11th, and there are plans for a public informational meeting.

Bryan said the town has joined the Vermont 457 Retirement Plan, which is an employee only retirement plan. There is no cost to the residents.

Bryan has received the general release forms from people who reported tire damage. There is approximately \$3,300.00 in damages.

All of the HVAC units have been installed, as well as the condensers, and head units. The new furnace and the air recovery system will not be installed until sometime in July when the units come in. Town Hall will be without power on Friday, April 21st. There are concerns about

snowfall from the roof with some of the exterior units and Bryan will be discussing this on Friday. Selectboard member David Goodrich will join him for that meeting.

Bryan asked DPW foreman Dale Lewis to give an update on the town roads.

Dale Lewis said that right now the south end of town has been graded, with a little left to do on Mud Pond Road. They are working in the Route 132 area right now. They should be done grading once around the first or second week of May, assuming there is not a lot of rainfall. Mud season has been good, and they may pull the weight limit posters in the south end of town sometime this week.

Sharon asked about the driver feedback signs.

Dale said two signs with the solar panels have been put up, and the rest will be installed by the summer. Bryan said the budget allowed for 4 signs, which have been ordered.

4. Public Comment

Dale Lewis commented that it has been a pleasure working with Bryan.

5. Presentation on Gender Pay Equity

Bryan Gazda, Mary Bryant and resident Hannah Payson worked on this project and Bryan asked Hannah to start the discussion with the compact strategy. Hannah explained that a group called Community Action Thetford (CAT), formed to support the town in best practices, and they thought it would be helpful to look at gender pay gaps. They utilized the LEAP toolkit from the state of Vermont, which is a free audit tool. Hannah said if the Selectboard decided to go forward with this, they should commit to the equal pay compact. One next step would be to decide what the pay philosophy is, such as rewarding for performance, loyalty and seniority. Bryan reviewed information by showing a slide presentation.

Hannah pointed out that the higher paid positions in Thetford just happen to be held by men; the higher pay is because of the position, not the gender of the person holding the position. Sharon noted that this is for salaries only and does not include benefits.

6. Potential Hiring of a Company to Assist with the Town-Wide Reappraisal

The Selectboard discussed two bids received by the Listers with Sean Boyce and Barbara Harrington.

Motion by David Goodrich to accept the bid from Appraisal Resource Group in the amount of \$41,700.00 to do a town wide reappraisal. <u>VOTE</u>: All in favor (5-0-0), **motion passed**.

7. Local Emergency Management Plan (LEMP) – Due by May 1

Motion by Sharon Harkay to accept the 2023 Local Emergency Management Plan as amended. <u>VOTE</u>: All in favor (5-0-0), **motion passed**.

Motion by Sharon Harkay to authorize Bryan Gazda, and David Goodrich as Selectboard representative, to sign the plan. <u>VOTE</u>: All in favor (5-0-0), **motion passed**.

8. Appointment of Thetford Health Officer – Mariah Whitcomb

Motion by Sharon Harkay to reappoint Mariah Whitcomb to continue to be our town health officer for 3 years ending in 2026. <u>VOTE</u>: All in favor (5-0-0), **motion passed**.

9. Jackson Brook Road Findings and Resulting Action

Sharon said they received the memorandum from town attorney Brian Monaghan and attorney Kristen Shamis which concluded that "it is not clear who presently owns the portion of Jackson Brook Road past the turnaround" and "while the entirety of Jackson Brook Road appears to have been discontinued in 1858, the Selectboard may now consider the lower portion to be a Town Road through the process of dedication and acceptance." The conclusion also recommended that "the Selectboard rescind its November 7, 2022, vote, because the portion of Jackson Brook Road previously considered to be Class 4 is likely no longer a Town road."

Motion by Sharon Harkay that the Selectboard rescind their permission to upgrade and improve the Class 4 portion of the road that had been put in place on November 7, 2022, because they didn't have the right to give that permission. <u>VOTE</u>: All in favor (5-0-0), **motion passed**. Sharon said the town is now out of this situation and this shouldn't have any impact on the Manis right to use that road or improve it because of state statute 19 V.S.A. § 717(c) and cited court cases. Any other agreement going forward in terms of how that road is utilized is up to the three sets of property owners.

Sharon referred to a study conducted by Dartmouth students that supports no one can claim ownership.

D.R. Mani said he understands what has been decided.

Carolyn Hack handed out a statement to the Selectboard, and Garrett Hack read the statement which said they were willing to work with the Manis to ensure access and stated the actions they need from the Selectboard. These included rescinding the November 7, 2022 vote, removing the Class 4 portion of the road and notifying VTrans of this change. The statement included a quote from the Hertzenberg heir and noted that they will not accept that there was ever a town highway through the property without a survey, acceptance and discontinuance. The statement said they will sit down with the Manis and Watts to work out access.

Carolyn Hack added that Sharon didn't provide the information about the Dartmouth study prior to the meeting and that the town has not provided proper documentation to support claims of a legal town highway.

D. R. Mani said it is unfortunate that it has come to this. When they purchased the property, the town said they would have access, but now it looks like that access is being constrained. Now the Town is out of it so we will figure out how to proceed.

Introduction

You asked that we research whether Jackson Brook Road is a Town Highway from Route 132 to the property line of the property owned by Denkanikota Rajan Mani and Lakshmi Kaja ("Mani"), and that we provide a memo that the Selectboard can share with the public. We understand the property owners on each side of Jackson Brook Road ("Hacks and Watts") claim that any portion of the road beyond .52 miles from Route 132 has been discontinued, that they each own a portion of that road, and they believe they can confer or withhold the Manis' access to the property. We also understand the Selectboard voted on November 7, 2022 to approve the Mani's request to improve approximately 1,400 linear feet of the Class 4 section of road from the current turnaround to the Mani property boundary.

Whether Hacks and Watts Jointly Own Jackson Brook Road

First, we should dispel the theory that Hacks and Watts share joint ownership of a portion of Jackson Brook Road. They do not. Moreover, it is not clear who presently owns the portion of Jackson Brook Road past the turnaround. We believe any discontinuance of Jackson Brook Road likely occurred in 1858, well before the Hacks and Watts properties were subdivided in 1979. The Hacks and Watts each purchased a lot from a three-lot subdivision, and the property lines depicted on the August 29, 1979 Janice Herzenberg subdivision plat ("Plat") clearly depict each property ending at the outer edge of the road right-of-way. The Plat also indicates the road is a Town road. If the road is not a Town highway, the state of title for the road is that it is likely owned by Janice Herzenberg, or her heirs, as none of the three deeds for the subdivided property include the road. Meaning, Herzenberg subdivided the properties, but never conveyed any rights in the property that comprised the road. So, she or her heirs likely still own any portion of the road that is not a Town road.

Is A Survey Necessary

We reviewed the June 19, 1829 highway layout, and the January 4, 1858 discontinuance recorded in the Thetford Land Records to determine which portion of Jackson Brook Road was discontinued. It appears the discontinuance may have acted to discontinue the entirety of Jackson Brook Road. The discontinuance states that the road is



discontinued "from Thomas Colby Jr. in said Thetford to Rice's Mill so called in Thetford." The 1858 H.F. Walling map depicts a "T. Colby" at the north end of what is now "Jackson Brook Road." Jackson Brook Road starting at T. Colby's property on the map headed south to Rice's Mills constitutes the entirety of the Road as it appears on the map.

Given that it appears the whole road was discontinued, we don't see it as necessary to engage a surveyor to determine the exact point to which Jackson Brook Road may have been discontinued. Whether or not Jackson Brook Road is a Town Road to the Mani property or not, the Manis appear to have a right of access over Jackson Brook Road, and may maintain that access.

Access to Mani Property

If the Town did, in fact, discontinue the road prior to where it meets the Mani property line, the Manis likely still have the right to use the discontinued road for access. 19 V.S.A. § 717(c) provides that, "[a] person whose sole means of access to a parcel of land or portion thereof is by way of a town highway or unidentified corridor that is subsequently discontinued shall retain a private right-of-way over the former town highway or unidentified corridor for any necessary access to the parcel of land or portion thereof and maintenance of his or her right-of-way." Here, it appears the only means of access to the Mani parcel is via Jackson Brook Road. If the road was discontinued, pursuant to 19 V.S.A. § 717(c), the Mani property retained a right of access, as well as the ability to maintain that access.

The Vermont Supreme Court has also held that, "when a public road is discontinued or abandoned, the abutting landowner retains the private right of access." <u>Okemo</u> <u>Mountain, Inc. v. Town of Ludlow</u>, 171 Vt. 201 (2000). This right begins at the time the road is discontinued, and "that right of access passed to landowner through the chain of title." <u>Daiello v. Town of Vernon</u>, 2022 VT 32 ¶ 75 (2022). This right is not contingent on the access being the only means of access to the property. Therefore, if Jackson Brook Road was previously discontinued to where it meets the Mani property line, the Manis would still benefit from the right of access that took effect upon any discontinuance.

Possible Dedication and Acceptance

Although discontinued, it is possible the road, or a portion thereof, has become a town road through the legal doctrine of "dedication and acceptance." If a property owner dedicates her property to public use, and this dedication can be proven through historical evidence, and the Town has accepted that dedication through an effort to maintain a highway and treat it as public, it may have become a de facto public highway. The subdivision plat depicts Jackson Brook Road as "Town Road #26" to the Mani property line. If any portion of this road was previously discontinued, this subdivision plat may serve as a presumptive offer of dedication to the Town. "A valid common-law



dedication and acceptance requires proof of intent to dedicate on behalf of the landowner and proof of acceptance on behalf of the town." <u>Kirkland v. Kolodziej</u>, 2015 VT 90, ¶ 35. If this matter went to court, it is possible the court could consider the Town's approval of the subdivision with this area of Jackson Brook Road listed as a Town road as an acceptance. By their purchase of lots within the subdivision, the Hacks and Watts agreed to this apparent Town road located between their properties. "[T]he function of a subdivision permit is to approve 'plats of land,' 24 V.S.A. §§ 4401(b)(2), 4415, and such plats must be duly filed or recorded in the office of the clerk of the municipality. *Id.* § 4416. Thus …recorded plats necessarily become subdivision permit conditions." In re Stowe Club Highlands, 164 Vt. 272, 276 (1995).

While the Plat may be considered evidence of presumptive dedication, for the road to become a Town road, there must also be proof that the Town accepted the road. Here, the Town has maintained the portion of the road to the turnaround for many years. This portion of Jackson Brook Road to the turnaround appear to have sufficient evidence of dedication and acceptance so that it can now be considered a Town road. The portion beyond the turnaround does not appear to have been maintained, and we see no other evidence indicating the Town has accepted this portion as a Town road.

November 7, 2022 Vote

At the Manis' request, the Selectboard voted on November 7, 2022 to allow the Manis to improve the portion of Jackson Brook Road beyond the turnaround. At the time, the Selectboard believed the road to be a Town road to the Mani property line. The Selectboard has since learned that the entire road appears to have been discontinued in 1858, and only a portion of the road – to the existing turnaround – may now be considered a Town highway through dedication and acceptance. Therefore, we recommend the Selectboard rescind its November 7, 2022 vote.

We note that a vote recission will likely have no impact on the Manis' rights to improve and use the road. As detailed above, because their only access is via a discontinued Town highway, or portion thereof, we understand they have common law and statutory rights to use and maintain the discontinued road.

Conclusion

While the entirety of Jackson Brook Road appears to have been discontinued in 1858, the Selectboard may now consider the lower portion to be a Town Road through the process of dedication and acceptance. We understand the Town intends to continue maintenance of this Class 3 section of Jackson Brook Road. We believe the Manis may still maintain the upper portion of Jackson Brook Road pursuant to 19 V.S.A. § 717(c) or <u>Okemo Mountain, Inc. v. Town of Ludlow</u>. Ultimately, for the portion of the road the Town does not own, it is up to the property owners to work out their respective rights to use and maintain the road. Additionally, we recommend the Selectboard rescind its



November 7, 2022 vote, because the portion of Jackson Brook Road previously considered to be Class 4 is likely no longer a Town road.

We are happy to discuss this issue further with the Selectboard if need be.

Call to Order

Sharon called the meeting to order at 7:15 pm and introduced Chris Brimmer who is Fairlee's Zoning, Planning, and Economic Development Administrator.

1. Chris presented his talk which he entitled "Fairlee–Decades in the Making". Town Highway #26 - Jackson Brook Road respectfully submitted by Garrett and Carolyn Hack

Without legally valid documentation that the logging road attached to Town Highway #26 (Jackson Brook Road) has ever been part of the Thetford town highway system or proof of any maintenance by the town, the town has taken our land to extend the existing class 4 road through our private property to the boundary of parcel #05-01-76. Before the town took this action, we offered the owners of parcel 05-01-76 a private right of way across our land to access their property but received no reply.

The town of Thetford has violated Vermont Highway Statutes subsections 708 and 709, the Petitioning, Notice and Hearing Statutes, and therefore may have also violated Vermont open meeting laws by knowingly and intentionally wrongfully excluding stakeholders from knowledge of or participating in this process.

Timeline

Logging on several parcels beyond Town Highway #26 (Jackson Brook Road) has taken place intermittently over the years and all of the logging companies widened and upgraded the road for their own purposes, sometimes illegally. This logging road went from an impassable track in 2000 to a road that enabled 18 wheeler chip trucks to drive deep into the woods.

Summer 2022 - Carolyn and Garrett Hack alerted the buyer's real estate agent to the uncertainty around the status of access to the parcel. Once the property changed hands the Hack's offered to work with the new owners to understand the issue and assure them at minimum a legal private right of way.

Fall 2022 - Before verification of access, the town granted a building permit for a structure based on the opinion of a former tax assessor.

At no time did the town of Thetford warn, notify, or consult with affected property owners or the public about the proposed changes to Town Highway #26 (Jackson Brook Road).

The town manager worked with the new property owner's lawyer to justify an extension of the town highway along the existing logging road by claiming that Town Highway #26 (Jackson Brook Road) was mis-measured and should extend to the boundary of her client's property, parcel 05-01-76.

Select Board members did not follow standard VTrans process for making changes to a town road, did not verify the status of the logging road or investigate the legitimacy of the case for lengthening the existing town highway.

November 2022 - Affected property owners found out **by accident** a few days before the November 7th Select Board meeting that proposed changes to Town Highway #26 (Jackson Brook Road) were to be discussed.

November 7, 2022 - In a virtual meeting, the Thetford Select Board received two documents from the town manager as evidence that the logging road in question was historically part of Town Highway #26 (Jackson Brook Road). In spite of the existence of a transcription in town records, a hand-written, unreadable 1858 Discontinuance was submitted. This document has subsequently been proven to be for an unrelated road far from the disputed area. The second document submitted was the land survey of properties on Town Highway #26 (Jackson Brook Road) that references the road as a boundary.

The Thetford Select Board lacked the expertise to handle this issue and without an understanding of VTrans statutes for establishing new roads and without thorough examination of the documents presented by the town manager, voted to approve the measure, with one abstention, at the November 7th meeting. Two of the SB members admitted at the meeting that they hadn't seen the documents and none of the affected property owners were provided the documentation.

November 8, 2022 - Construction began on the upgrade to the class 4 section of Town Highway #26 (Jackson Brook Road) and the logging road. Underground utility conduit was installed leading to a junction box at the end of the utility right of way and then continuing through approximately .10 mile of private property without permission from the property owners and into parcel #05-01-76

December - Affected property owners engaged attorney Paul Gillies, an expert on old roads, as a consultant on Vermont law and guide for researching the status of the logging road. Garrett Hack spent days at the Thetford Town offices researching all leads and consulting with council Gilles on the information.

December 19, 2022 - Affected property owners presented their findings to the Thetford Select Board. No Survey, no Discontinuance, no Acceptance by the Town Clerk, and no record of Maintenance and Acceptance were found in town records for Town Highway #26 (Jackson Brook Road). Evidence was given that the 1858 Discontinuance was not part of Jackson Brook Road. That road had been laid out by the town in 1829 and discontinued in 1858 with the Survey and Discontinuance using exactly the same language to describe a road of approximately .3 miles in length near the end of Colby Road. This old road is far to the north and did not provide access to parcel #05-01-76.

We presented evidence from an 1831 Survey that suggests that Town Highway #26 (Jackson Brook Road) is a fragment of the old (1700's) highway linking Thetford to Strafford retained after the creation of the current roadbed for Route 132. This document grants payment for land along the Ompompanoosuc River but also acknowledges rights to .3 miles of the old road, a segment long enough to ensure access to the publicly maintained Jackman Cemetery. The 1931 VTrans map shows Town Highway #26 (Jackson Brook Road) at .3 miles which was lengthened to the current length of .52 miles on the 1941 map as class 4 to serve a long-gone building.

As of today, the town has not brought forth any evidence supporting the idea that Town Highway #26 (Jackson Brook Road) was mis-measured or that the logging road was ever part of the town highway system. As affected property owners, we can personally attest that town has not done any maintenance of Jackson Brook Road beyond the class 3 section for over 40 years.

This appears to be a land grab of .10 mile of private property by the town of Thetford at the expense of property owners Hack and Watts on either side of the logging road beyond the end of Town Highway #26 (Jackson Brook Road).

Road Discontinument from Thomas Colby's to Rices Mills

HH Niles and Others in the Town of Thetford to the Hon County Court for the County of Orange, the undersigned Commissioners appointed by the Hon County Court of the County of Orange agreeably to a petition of HH Niles and other freeholders of the Town of Thetford in Orange County of aforesaid presented to the Schst(?) Court at the June term Adress setting forth that a public highway from Thomas Colby's ^to Rices Mills so called in Thetford in said Thetford laid out in part by commissioners appointed by the county court, from ^changes circumstanced is not necessary or required by the public good or individual convenience and praying said court to appoint commissioners to examine and report in the premises according to the statute in such cases provided having searched our commission from said Court - and having been sworn, proceded in the discharge of our duties. The Selectmen of Thetford were notified to answer to the petition (and also those individuals owning & interested in the land through which the road was laid) on the 28th day of Oct 1857 at Thomas Colby's Jr dwelling house & on the highway aforesaid Wherefore after hearing the parties and inspecting said highway & considering the facts and circumstances in the code it is considered by us that the prayer of the petitioners should be granted. The public good not requiring the road & street, that part of the highway aforesaid laid out and surveyed May 27, 1829, by Commissioners of roads for said county, described as follows; - "Beginning at a stake in the side of the road near the North line of John Fressell Land, thence N, 27° E, 18 rods to the said North line, the same course and rods thence N. 15° E 14 rods to a birch tree, thence N, 12° E 18 rods, thence N 22° E 25, North 14 W, 10 rods to a stake, thence N, 23 1/2°, W 6(?) rods to the old road there N, 8° E, 37 rods in Augustus Howard's land to an apple tree in the N.E. corner by the South side of the Jewett road near Stephen Godfrys Barn". Should be discontinued meaning to discontinue all the highway leading from near the house of Thomas Colbys Jr to 18 rods beyond or Southerly of the North line of land now owned by H.H. Niles, S.J Heaton.(?) but formerly owned by when said road was laid out by John Fressell aforesaid to which point (to wit 18 rods South of the North line of land formerly owned by John Fressell) from Sylvester Downer dwelling house said road has been discontinued by the Selectman of said town of Thetford being that part of the highway aforesaid Credibly. County commissioner aforesaid Recorded in the Records of the town of Thetford Libro 12, Folio 156 & 157,
