Please find the enclosed copy of the 2020 Certificate of Highway Mileage for the Town of Westmore. We have placed the original certificate in the VTrans Mapping records, but we were unable to process the addition of class 4 mileage to Old Cottage Lane (TH-30). A review of our records suggests that the mileage correction for Old Cottage Ln might be more appropriately addressed by increasing the class 3 mileage rather than the class 4 mileage, as detailed below.

Based on documentation of the 2007 class 3 to class 4 partial reclassification, the class 3 portion of the highway ends at the turnaround near 492 Old Cottage Ln, and the class 4 portion ends at the row of mailboxes near 584 Old Cottage Ln. Our current mapped representation of the class 3 portion of this road corresponds to a measure of 0.50 mi. However, we currently map the class 3 portion as ending before the turnaround. It is possible that the class 3 portion is closer to 0.51 mi or 0.52 mi, depending whether the measurement extends to the near, middle, or far side of the turn-around area. If the class 3 measure requires an update in our records, that would affect how the class 4 portion is measured. The 1984 field inventory conducted by VTrans, accompanied by Mr. Gosnell of Westmore, obtained a measure of 0.58 mi for the public portion of Old Cottage Lane, which is consistent with adding 0.01 or 0.02 miles to the total public (combined class 3 and class 4) mileage. Please refer to the attached map that illustrates the above descriptions.


VTrans confirms highway measurements by field inventory, identifying clearly visible roadways and landmarks, and distances determined using our mapping software. It would be beneficial to meet with the Town and discuss this in more detail and measure the segments to get the proper mileage. Please let me know if this would be a possibility this fall, in advance to the upcoming mileage certificates.

I can preload updates onto the 2021 Certificate if this matter is cleared up before we mail next year's certificates on January 1, 2021. If you have any questions regarding the information above, please don't hesitate to reach out to me or someone else in the Mapping Section.




Hi

I hope this gives you what you need.



Hello Missy,

I'm sorry to drag this out, but this remeasurement is more complicated (but only slightly) than I expected. Can you have someone describe for me exactly where the class 3 portion of Old Cottage Ln ends, and where the class 4 portion ends? Ideally the descriptions should reference drive ways with E911 address, or a distinctive turn-around area, a sharp bend, etc. I've attached a map of the end of Old Cottage Ln with addresses, color-infrared imagery (so roads stand out more than with standard color imagery), and contour shading that might help someone pinpoint these locations for me. Marking up the map in addition to describing the locations would also be helpful.

One important reason to really nail down these locations is because there is a possibility that the error is in the class 3 mileage instead of the class 4 mileage, and that could mean an increase in class 3 mileage. Either type of error could have caused Old Cottage Ln's total mileage to fall short of the expected landmarks.

Thanks again, and I apologize for dragging this out!

Hello Missy,

We do have your mileage certificate. Normally we send copies of certificates submitted with changes back to Towns along with Town Highway Maps reflecting those changes, but Westmore is in a doubly unique situation this year. We produced a 2019 Westmore map before receiving and processing the mileage certificate, which is why you've received one but not the other. A 2019 map was generated because of the minor correction to how LT-4 is shown (without a mileage change), but we were unable to include the change submitted on the 2019 Certificate (as per email conversations with Chris Evans earlier this month).

We haven't yet sent out copies of any unsigned Mileage Certificates to towns (certificates with submitted changes that could not be processed, but hope to finish up that part of the process in the next week. If you have need of a copy before that, or want clarification on anything I've written above, please let me know!
