## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS THAT we, HOWARD W. TURNER and FLORENCE P. TURNER, MICHAEL PIWOWARSKI and SHARON PIWOWARSKI, GREGORY A. LEWIS and DIANE L. LEWIS and DAVID W. CLEMONS and DEBORAH L. CLEMONS, all of Middlesex, Vermont, Grantors, in consideration of One Dollar and other good and valuable consideration, paid to our full satisfaction by TOWN OF MORETOWN, a municipal corporation with its situs within the County of Washington and State of Vermont, Grantee, by these presents, do freely GIVE, GRANT, SELL, CONVEY AND CONFIRM unto the said Grantee, TOWN OF MORETOWN, and its successors and assigns forever, a certain piece of land in Moretown, Vermont, described as follows, viz:
