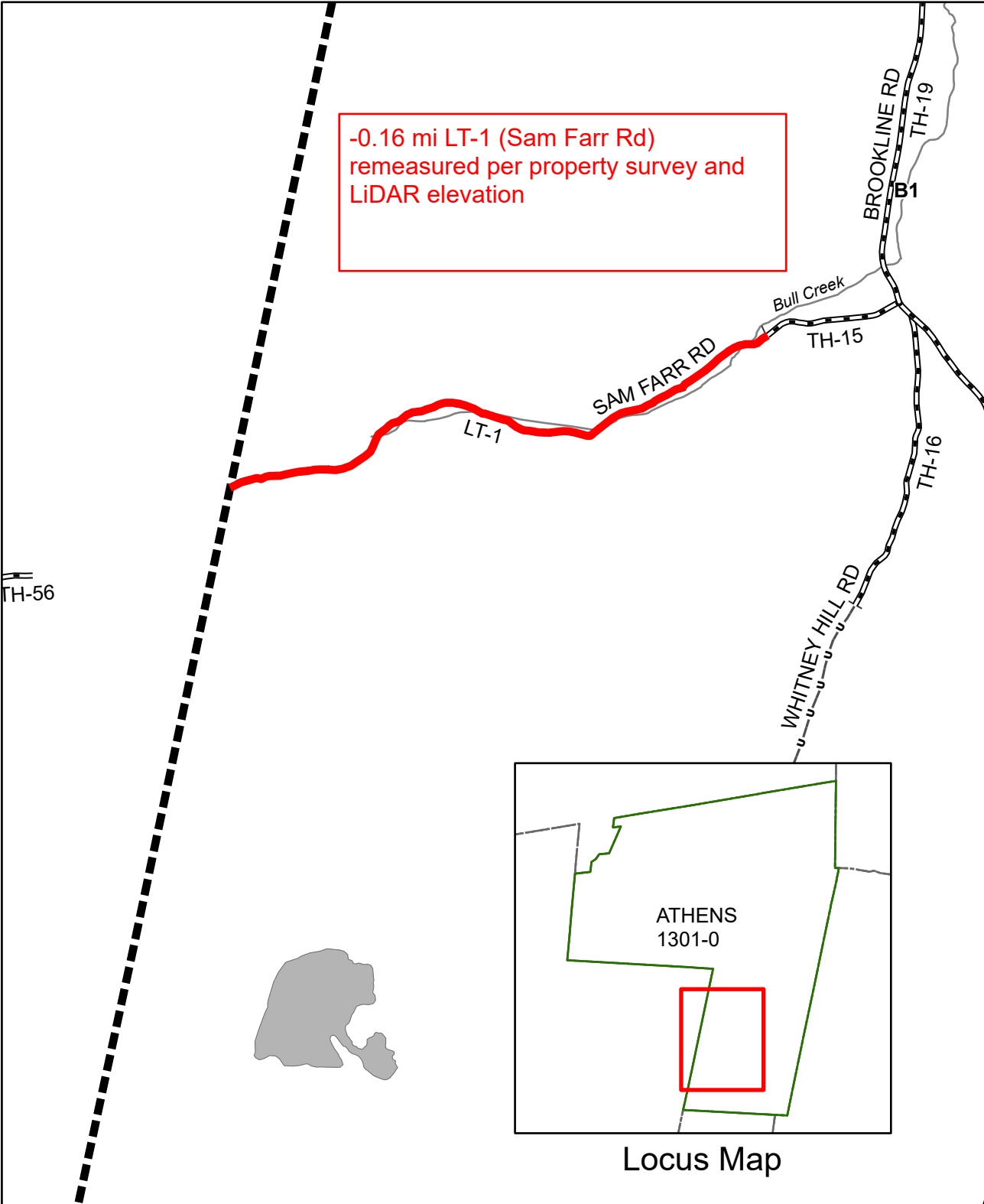

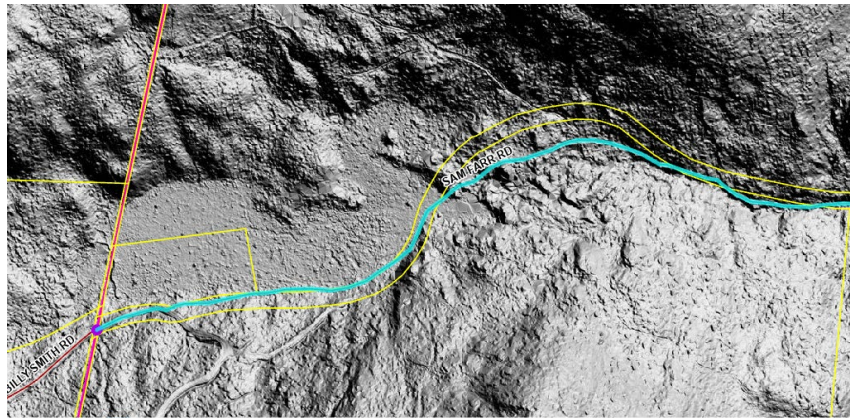

Thank you so much Hannah and Tyler,

I have adjusted our line work to follow the LiDAR and more in agreement with the survey and E911 lines except for the red circle that Tyler pointed out where we are following the LiDAR elevation (See image below). The mileage I have calculated is now 0.80 miles, not 0.96, so for the next mileage certificate, I can preload a change of -0.16 miles for Legal trails.

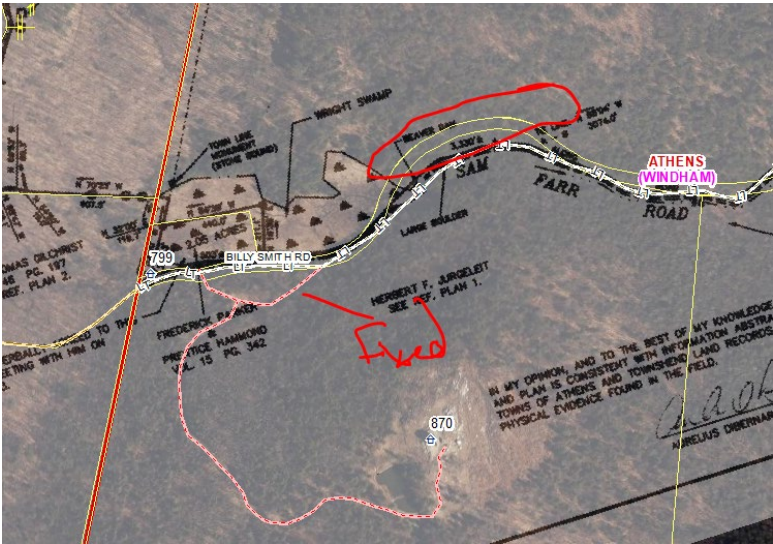
Hannah,

This is merely in this case just getting it right. The road location I have moved, but when we move roads it can impact the addressing, and so the address isn't measured correctly for where the road layout actually is supposed to be. Vtrans cares as they certify the mileage and reimburse towns to those mileages.

In summary here, I fixed where the LT goes, I made that weird loop which acts more like a road, but is a pvt driveway. His number may be slightly off now, but that's fine in this case for how remote it is. The survey helped a ton, I referenced it and it confirmed that other leg I thought was fine was indeed fine. It did however confirm that your tax map has error in the ROW location as the survey matches the road location we have which matches the survey. So, long story short, for data accuracy and the good of the data for Athens, you may want to sent this survey to your parcel mapper and have the circles portion adjusted for the actual LT location. Other than that, we should be all set.

Side note, if you have down time or others, I've been telling towns to help post surveys they have on file as part of the state library. Surveyors are required to post their work here, however that mandate is not enforced or penalized. This acts a good repository for the town and public for various needs, like this. Some towns like Londonderry or Mount Holly have like 95% of their parcels mapped with a survey. It takes about 30ish seconds to post one so long as the file is digitized. Currently there are 3 surveys in Athens posted.

Your white dotted line is a private drive on an old logging road. Sam Farr Rd. / legal trail is where the tax map shows it. I'm happy to go out with you and walk the old roadbed along the south side of the wetland, show you where it used to cross, and follow it down the north side of the brook. I'm attaching a survey that shows it as well.

I know this land intimately, as the land trust for which I am the chair of the board is in the process of conserving it.

I don't see why any of this matters to the 911 board as the legal trail is not accessible by motorized vehicles.

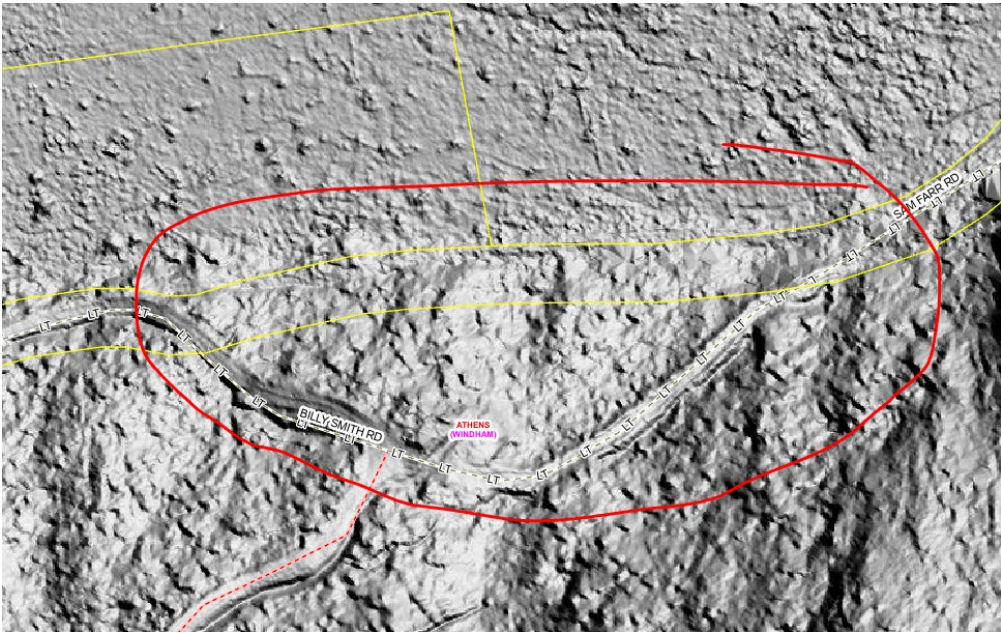
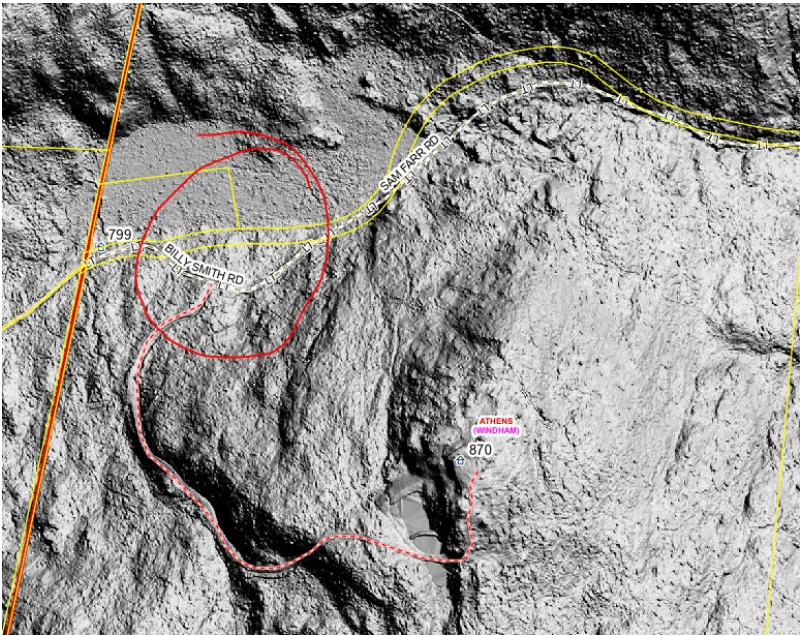

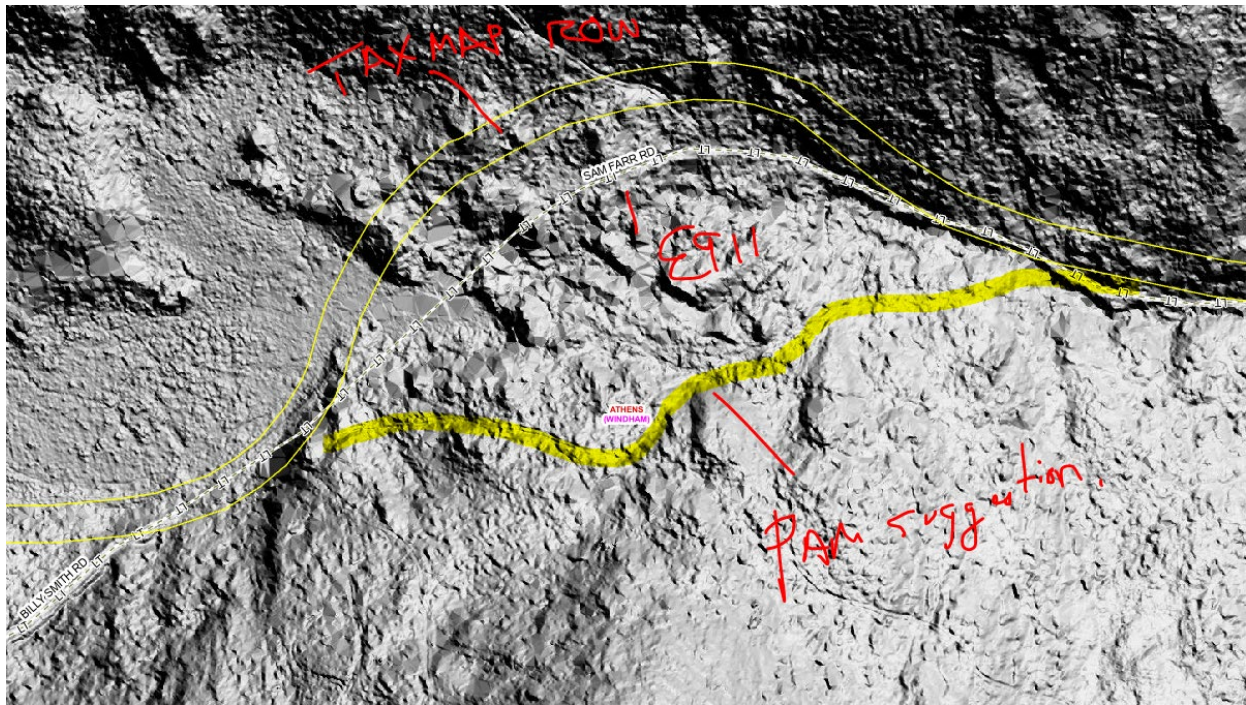

Hi Hannah,

I think some of this got overlooked/misunderstood. Specifically I was mentioning this area adjacent to the 799 and 870 camp. I also think your tax map is slightly off on the ROW. Both VTRANS and E911 has this as the road here which is visible on the elevations. I think Pam was suggesting the road is lower, but I think that section is fine, except the tax map may be off say 100 ft or so more north than what's there.

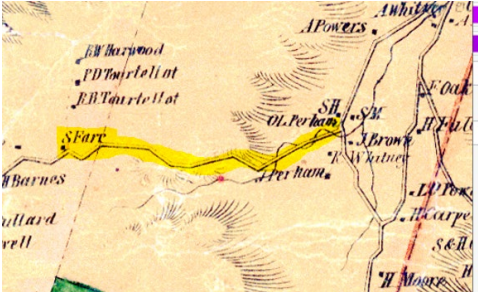
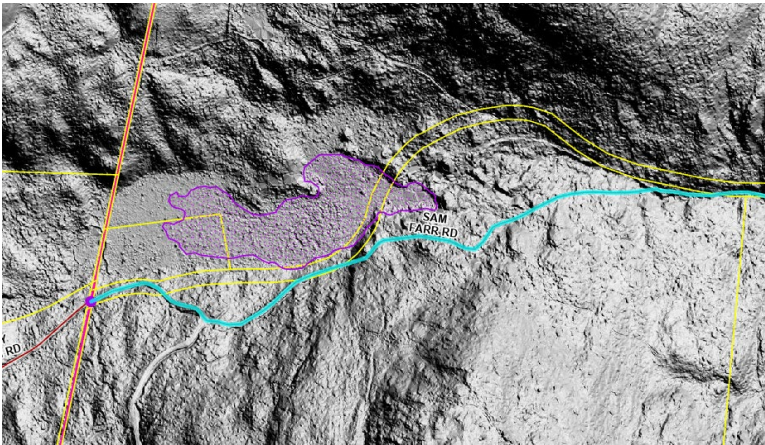

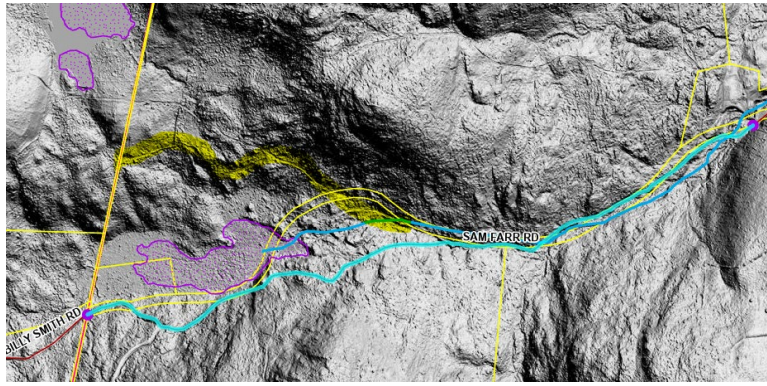

Good afternoon Hannah,

Tyler Hermanson alerted to is that we may have a Legal Trail, LT-1, (Sam Farr Rd) mapped inaccurately (see image below) as revealed by more detailed recent elevation data. Looking at historic maps and the elevation data, I am not sure how the original layout of the road went. On the western side, did it go north or south of the wetland? From the elevation data, it appears that the road may go below the wetland (dotted in purple in the image below) and not through it as the parcel for the ROW suggests (yellow lines) and connect to Billy Smith Road in Townshend (see second image below). However, looking at the historic Walling map (3<sup>rd</sup> image below), which shows the road to Sam Farr's in Townshend and the stream to the south of it, I wonder if the road is actually what I have highlighted in yellow in the 4<sup>th</sup> image.

Let me know what the Town thinks and if you may have a historic survey for the trail. I can preload any mileage update to the trail on the 2025 Mileage Certificate and update the Town Highway map next summer. Thank you so much and let me know if there is anyone at the Town level that may have more information on the ROW of the trail.

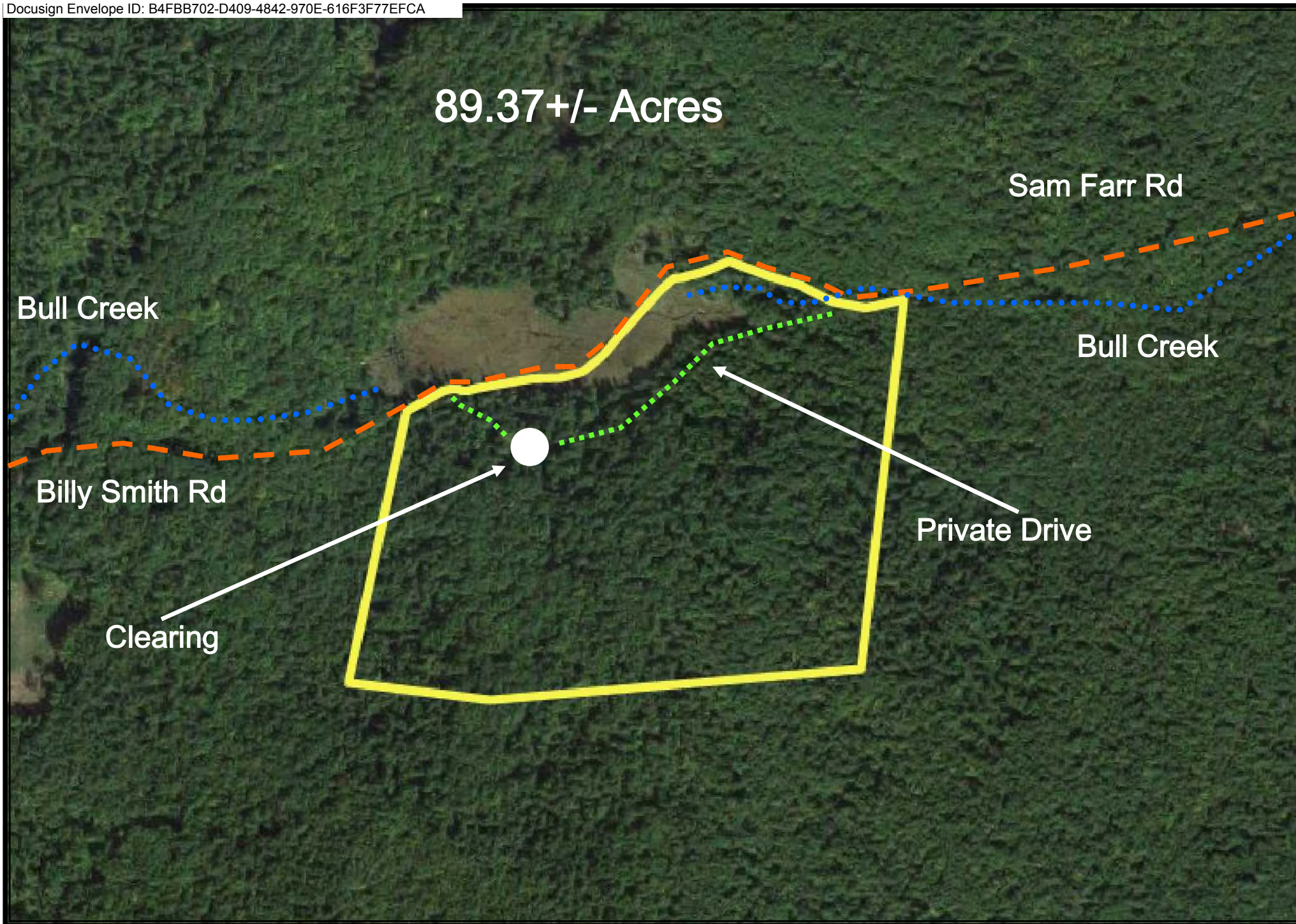

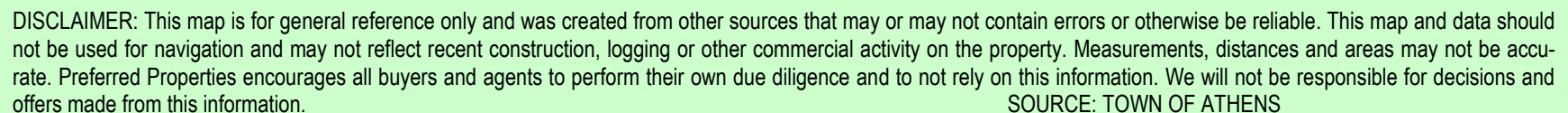

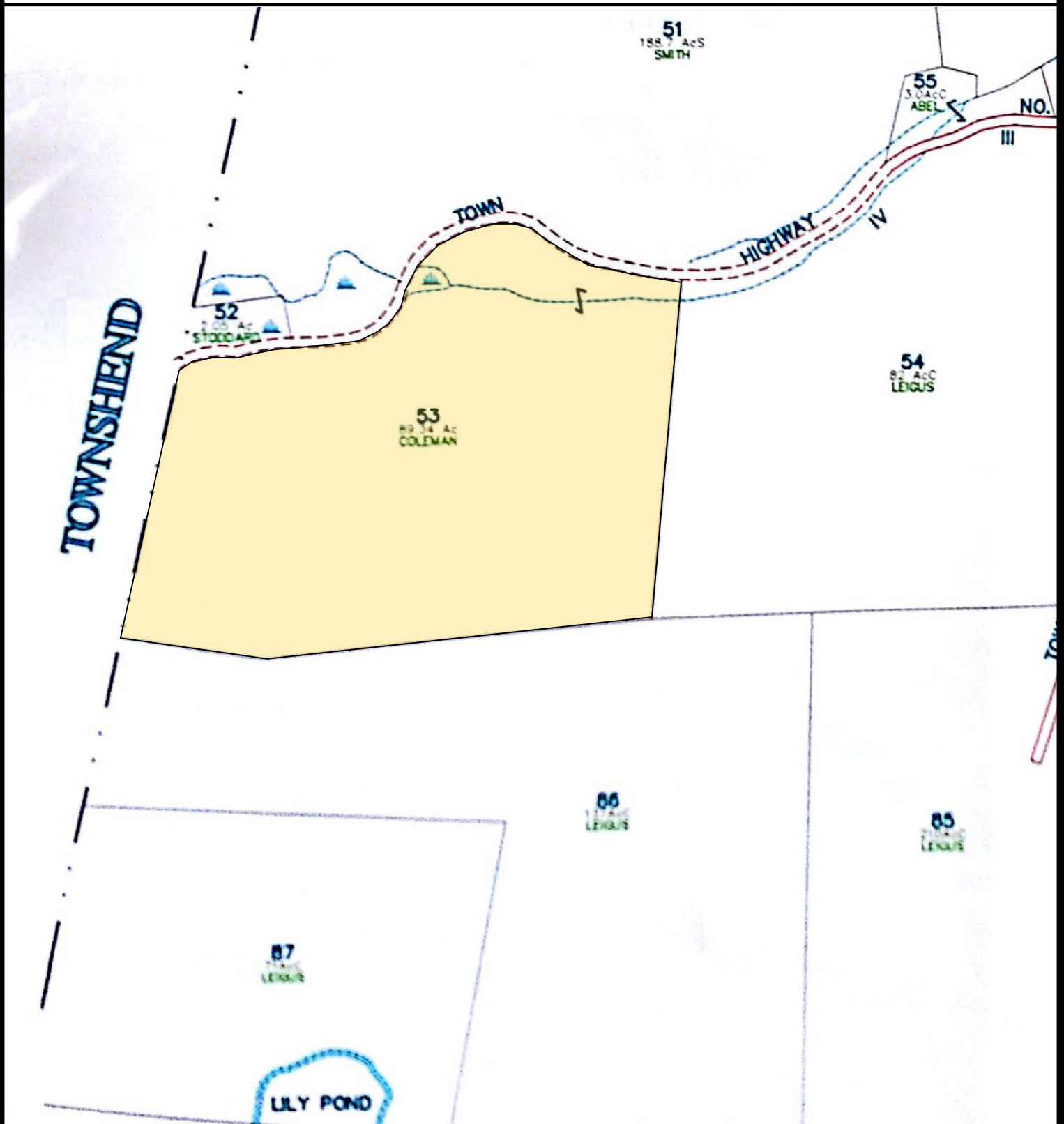
