

Vermont Statutes Annotated

19 V.S.A. § 305. Measurement and inspection

§ 305. Measurement and inspection

(a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.

(b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.

(c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.

(d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.


(e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.

(f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.

(g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate.

WHEREAS, at Brattleboro, Vermont, on the 13th day of April, 2004, the Selectboard of the Town of Brattleboro, on their own Motion, did vote to propose that pursuant to Title 19 Vermont Statutes Annotated, Chapter 7, as amended, that the following public highway in the Town of Brattleboro be layed out in part and discontinued in part as follows:

The Highway to be DISCONTINUED is described as follows: Being all of the so-called roadway of Paul's Road beyond the proposed turnaround area at the entrance to lands of Delta Industries, LLC:

Beginning at a 1/2" rebar pin set 15" up on the westerly side of Paul's Road, said pin being at the boundary between lands of Freeman and lands of Delta Industries, LLC; thence N 79° 26' 06" E a distance of 35 feet to a point on the easterly side of Paul's Road; thence N 10° 33' 54" W a distance of 210.18 feet to a point; thence along an arc a distance of 112.24 feet, the radius of which is 293.98 in a northeasterly direction; thence N° 11 18' 36"E a distance of 306.83 feet to a point; hence N° 09 21' 01" E a distance of 272.41 feet to a point; thence along a curve a distance of 43.12 feet, the radius of which is 52.62 feet (tie line being N 14° 01' 31" W a distance of 41.92 feet); thence along a curve a distance of 43.12 feet, the radius of which is 52.62 feet (tie line being N 60° 58' 35" W a distance of 41.92 feet); thence N 84° 27' 08" W a distance of 38.24 feet; thence S 05° 32' 52" W a distance of 33 feet to a point marking the terminus of the road; thence S 84° 27' 08" E a distance of 38.24 feet to a point; thence along a curve a distance of 32.15 feet, the radius of which is 19.62 feet (tie line being S 37° 30' 03" E a distance of 28.67 feet); thence S 09° 27' 01" W a distance of 271.88 feet to a point; thence S 11° 18' 36" W a distance of 306.10 feet; thence along a curve a distance of 124.84 feet, the radius of which is 326.98 feet (tie line being S 00° 22' 21" W a distance of 124.08 feet); thence S 10° 33' 54" E a distance of 210.18 feet to the point and place of beginning.

The roadway acreage being discontinued is approximately 0.76 acres.

The Highway to be LAID OUT AND ALTERED is described as follows:

Beginning at a point at the intersection of the Brattleboro-Guilford town line, said point being N 83° 58' 14" W. 239.88 feet, more or less, along said town line from a monument on the westerly side of Route 5; Thence N 73° 58' 14" E. 46.80 feet, more or less, along said town line to a point, said point being the intersection of the easterly side of Paul's Road in Guilford and said town line; thence N 73° 58' 14" E. 67.35 feet, more or less, along said town line to a point on the westerly side of Paul's Road; thence N 19° 38' 42" W. 124.59 feet, more or less, along the westerly side of Paul's Road to a point; thence

And,

Beginning at a point on the southerly boundary of land of Delta Industries, LLC and the northerly boundary of land of Dana A. Holby, said point being the southwesterly corner of the parcel herein described; thence N 10° 31' 57" W, a distance of 68.35 feet, more or less, along land of Delta Industries, LLC to a point; thence N 79° 28' 03" E, a distance of 115.63 feet, more or less, along land of Delta Industries, LLC to a point; thence S 09° 25' 34" E, a distance of 94.70 feet, more or less, along land of Delta Industries, LLC to a point at the northeasterly corner of Tract 1, land of Jeremy G. Freeman, Jr. and Douglas L. Freeman, said point being the southeasterly corner of the parcel herein described; thence N 67° 59' 23" W, a distance of 51.95 feet, more or less, along said Trace 1 to a point at the easterly side of existing Paul's Road; thence S 77° 26' 06" W, a distance of 33.00 feet, more or less, to a point at the westerly side of existing Paul's Road and the northeasterly corner of Tract 2; thence S 77° 00' 12" W, a distance of 12.27 feet, more or less, along said Trace 2 to a point; thence S 77° 00' 12" W, a distance of 24.78 feet, more or less, along land of Dana A. Holby to the point of beginning.

The roadway acreage being considered for laying out and altering is approximately 2.27 acres, or 98,976 square feet.

Said roadway to be discontinued being referenced in the "Boundary Survey, Road Discontinuance & Merger - Paul's Road, Bratt. VT" prepared for Delta Industries, LLC by Eric Morse, Land Surveyor, Job #2096 dated February 1, 2002, and recorded at Slide #A115,4 of the Brattleboro, Vermont Land Records.

Said roadway to be laid out and altered being referenced in the "Proposed Right-of-Way and Easement Plan – Paul's Road, Brattleboro & Guilford, Vermont" prepared for Delta Industries, LLC by Eric Morse, Land Surveyor, Job #2096 dated January 6, 2004, and recorded at Slide #A121.4 of the Brattleboro, Vermont Land Records.

WHEREFORE, the Selectboard did order and appoint that on the 18th day of May, 2004, at 4:30 p.m. they would meet at the site and then at 6:15 p.m. they would meet at the Brattleboro Selectboard Meeting Room in Brattleboro, Vermont for the purpose of hearing all persons interested in said public highway and its alteration, discontinuance and new layout and for the purpose of examining the premises affected thereby, and did give notice thereof to the statutory parties and to those set forth in Exhibit "A" attached hereto all being persons who own or are interested in the lands on which said proposed road now lies or abutting on said roadway at their last known addresses; and did give notice thereof to the voters of the Town of Brattleboro by posting notices thereon on April 19, 2004 in the public places within the Town, and did give notice to the voters of the Town of Brattleboro by causing a notice to be published in the Brattleboro Daily Reformer, a newspaper with a circulation in Brattleboro, Vermont on May 8, 2004, and did leave a copy of such notice with the Brattleboro Town Clerk

AND, afterwards, on or before May 18, 2004 all of the Selectmen did examine said premises, and did hold a public hearing on May 18, 2004, at 6:15 p.m. at the Brattleboro Selectboard Meeting Room at which time individuals were given the opportunity to appear and give testimony regarding said road. There were no claims for damages. There were no individuals who gave testimony.

AND, the Selectboard determined that the present status of the public highway is as follows:

1. That the roadway is a public highway;
2. That the roadway is being discontinued in part and layed out in part as part of the development of the Delta Business Park and corresponding residential development;

3. That the laying out of the road widens the highway along the hill and creates a T-shaped turn around for vehicles at the end of the public section of the road;
4. That the road laying out and discontinuance is in the best interest of the Town.

AND, after due discussion and deliberation with those in attendance and after review of the premises with the adjoining landowners, the Selectboard were of the opinion and did so vote that the necessity and convenience of the inhabitants and the public good requires that the road as previously laid out be discontinued in part and layed out in part and maintained as a public road up to the T-shaped turn-around.

AND, the said Selectboard did determine and vote that no damage was sustained by any person owning or interested in lands through which said proposed highway runs or abuts.

THEREFORE, it is ORDERED by the Selectboard that (1) the roadway as above first described be discontinued and (2) the roadway as above second described be layed out a sa public road.




