

Dear Ms. O'Connor.

As a result of a review of our road centerline data, the VTrans Mapping Section will be adding 0.068 miles of Interstate ramp mileage to the total of mileage recorded on the Certificate of Highway Mileage for the Town of Brattleboro. The mileage is associated with two spur ramps on I-91 Exit 2. The ramps have been in existence for many years, but their mileage was not identified and accounted for separately.

I-91 Exit 2 Ramp E spur mileage increased by 0.034 from 0.000 to 0.034 I-91 Exit 2 Ramp F spur mileage increased by 0.034 from 0.000 to 0.034.

A map has been included to provide context of the mileage changes.

These changes will be reflected as remeasurements and preloaded on the 2018 Certificate of Highway Mileage for Brattleboro. The Certificate is expected to be mailed to the town in early January and returned to VTrans by February 20.
