PUTNEY BOARD OF SELECTPEOPLE

Minutes of the Meeting of February 27, 1995

Members Present: Jeffrey Shumlin, and Jeanette White, David Rothschild was absent due to medical reasons.

Others Present: Town Manager Shane O'Keefe, Residents Gregory Wilson and Gene Litch of the Putney Sno-Cruisers Club, Inc., food vendor Bert Wilkins, Attorney Jean Giddings, and property owners David Richards and Sam Mundel.

The Meeting was called to order at 7:10 pm.

White, Shumlin, O'Keefe and Giddings traveled to, viewed and examined Town Highways #34 and #35, which were proposed for discontinuance. At 7:40 pm, the Board returned to Town Hall and immediately voted to open up a Public Hearing on the matter of discontinuance of the Town Highways. Giddings, representing a property owner affected by the proposed discontinuance, stated that her client's property had a deeded right of way to TH #34 (Book 32, Page 473) and wished to negotiate with the Putney School, Inc., the surrounding property owner, on behalf of her client to clarify access rights. Giddings requested that the Public Hearing be continued to Monday, April 3, 1995, so that unresolved issues could be worked out. The Board voted to continue the hearing to that date. Giddings left the meeting at 7:48 pm.

Wilkins asked about the status of the vendor permit application he had filed with the Town on January 27, 1995 and which was reviewed by the Board on January 30th. It was explained that the Board wished to postpone its decision pending enactment of a new vendor ordinance. The Board indicated that it wished to revise its fee structure to create a more equitable system. It was noted that the ordinance had not been revised yet, and due to State ordinance adoption statutes, would not be effective for 60 days from adoption. As Wilkins' proposed permit start date is April 1, 1995, the new ordinance could not be adopted in time for his opening. The Board voted to grant Wilkins a Vendor Permit as specified in his application.

Mundel explained that his family owned a 90 acre parcel of land (Lot No. 01-01-03) at the end of Banning Road which they wish to subdivide and build upon. To do so, they would need access over the Class 4 section of Banning Road. Richards asked if the Town would be willing to take over maintenance of the road, or at least allow his family to maintain the road. The Board stated that the Town would be unwilling to maintain the road at this time and anticipated that allowing Mundel and Richards to maintain it would likely be permitted. Shumlin indicated an interest in contacting neighbors to gauge their sentiments on the proposal. The Board decided to hold off further discussion on allowing Mundel and Richards to maintain the Class 4 portion of Banning Road until the March 13, 1995 meeting.

Mundel raised the idea of his deeding a portion of their property, that containing a rock mound site popular with residents, to the Town or other organization for preservation purposes. After Mundel stated that the parcel would be less than 20 acres, O'Keefe noted that creation of such a lot would not be permitted under the current zoning regulations and that granting of a variance by the Zoning Board of Adjustment would be unlikely. Richards asked if the Selectboard would be amenable to accepting the parcel if the zoning issue could be overcome. Shumlin stated that he would bring up the issue under "Other Business" at the upcoming Town Meeting to get feedback from the voters on the issue. It was suggested that an abutting owner may wish to incorporate the parcel into their land to avoid creating an undersized lot, or that development rights could be donated to a land trust. Mundel will speak to abutting landowner on the issue.

Wilson and Litch presented a proposed revised permit for the Putney Sno-Cruisers Club, Inc. to cross Town roads with snowmobiles. Shumlin stated that it may not be necessary to change the permit already on record. Wilson stated that the club wished to expand the road coverage of the permit in order to ensure the legality of the club member's proposed use of Town roads. He stated that the club was growing and wished to formalize its network of trails and to work with other recreational trail users. O'Keefe suggested that the group could formalize their trail system by including it in the transportation or recreation sections of the Town Plan now being written. Wilson stated that the reason for the permit was to allow snowmobiles to cross Town roads and to ride closer to, or within, the plowed sections of roads where necessary. It was decided that some new language should be added to the permit to indicate that other recreational users use the Club's trails, and to better specify the road sections needed for travel. Wilson, Litch and Wilkins left the meeting at 9:05 pm. O'Keefe expressed reservations about approving a new permit without reviewing the proposed changes in greater detail to ensure that the new permit is in the best interest of the Town.

The minutes of the February 23, 1995 meeting were reviewed and approved by the Board.

The Board discussed the Windham Solid Waste Management District roadside cleanup program, which was established as part of an Assurance of Discontinuance issued to the WSWMD as a result of landfill violations. The Board decided that sites to be suggested for cleanup were the Vivian property on Old Route 5 South, the Town-owned property (former Hume property) on Hi-Lo-Biddy Road, and land adjacent to Germon's Trailer Park on Hi-Lo-Biddy Road. O'Keefe will contact property owners for permission and forward suggested sites to the WSWMD.

There was a brief discussion on sale of the Town-owned McCarthy property to Arnold and Carol Kathan. White will contact the Kathan's to see if they are on track with steps they need to take to effectuate the sale.

At 9:40 pm Wilson and Litch returned to the meeting and presented a newly revised permit for the Putney Sno-Cruisers Club, Inc. to use Town roads for snowmobiling. It was explained to them that he Town wished to evaluate the permit and would consider it at the next meeting. O'Keefe will work on the evaluation.

O'Keefe explained that the Putney Historical Society wished to re-establish its 1964 agreement with the Town which allows the PHS to use part of the first floor of Town Hall as a museum, work and storage space until such time as the area is needed for Town purposes. The PHS needs to show the Internal Revenue Service such a written authorization in order to allow for its not-for-profit status. O'Keefe was authorized to write a letter on behalf of the Town which spells out the PHS's permitted use of part of the Town Hall.

It was noted that Landmark College had donated \$4,000 to the Town in lieu of taxes. O'Keefe was asked to write a letter of thanks on behalf of the Board.

O'Keefe informed the Board of a Windham Regional Commission meeting scheduled for February 28th with local elected officials scheduled to discuss property tax legislative proposals.

O'Keefe informed the Board of the State Agency of Transportation's continued effort to eliminate the Route 5 crosswalk near the Public Library. O'Keefe was asked to write a letter to the AOT indicating the Board's wish to retain the crosswalk.

There was further discussion on the proposed sale of the McCarthy property.

There was a brief discussion on the upcoming Town Meeting.

Warrants were reviewed and signed by the Board.

The meeting was adjourned at 10:20 pm. The next meeting is scheduled for March 6, 1995.


