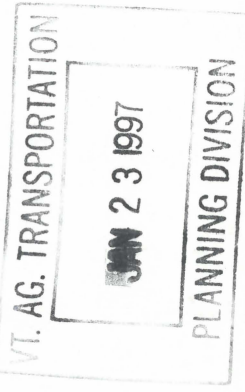

**Report and Order of the Putney Board of Selectpeople
Regarding Discontinuance of
a 240' Portion of Aplin Way (Town Highway #51)**

WHEREAS, on April 6, 1996, the Putney Board of Selectpeople (hereinafter, "Selectpeople") received a petition dated March 13, 1996, signed by William Graham, Phyllis Graham, and Marilyn Loomis to discontinue a 240' portion of Town Highway #51 (also known as "Aplin Way"), and

WHEREAS, on May 6, 1996, the Selectpeople voted to initiate proceedings to discontinue a 240' portion of Aplin Way, and

WHEREAS, on May 15, 1996, the Selectpeople posted notice of their intent to view and examine the property proposed for discontinuance, including publication of the notice in the Brattleboro Reformer on May 20, 1996, mailing of the notice by certified mail to petitioners and to persons owning or interested in lands through which the highway may pass or abut, and notifying the Putney Planning Commission, and

WHEREAS, on June 17th, 1996, the Selectpeople conducted a site visit to the 240' portion of Aplin Way petitioned for discontinuance, and

WHEREAS, the Selectpeople conducted public hearings on the request for discontinuance on July 15 and August 19, 1996, and

WHEREAS, no objection was raised by any person to the requested discontinuance, and

WHEREAS, the Selectpeople judge that the public good, necessity and convenience of the inhabitants of Putney require the 240' portion of Town Highway #51 to be discontinued as petitioned,

NOW THEREFORE, the Selectpeople hereby order the discontinuance of a 240' portion of Town Highway #51 more particularly described as follows:


Being a 240' portion of Town Highway #51 (also known as "Aplin Way") lying immediately easterly of the common lot line (marked 160.4', N 13 degrees 30'00") between lands of Marilyn Loomis and lands of William and Phyllis Graham as shown on a survey entitled "Land of William & Phyllis Graham, Putney, Vermont, Proj. No. 95-284 by William Fitzgerald, dated June 8, 1995."

The Selectpeople further hereby relinquish and convey to William & Phyllis Graham any and all


rights, title or ownership which the Town of Putney may have to the 240' highway premises described above.

Dated at Putney, Windham County, Vermont, this 19th day of August, 1996.


