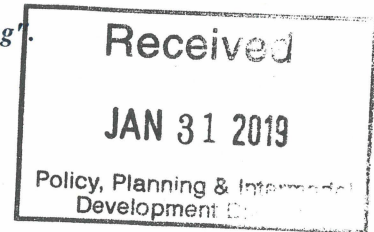

I am returning the signed annual highway mileage certificate but have a question about the bridges that were noted on the general highway map enclosed with the certificate information.

Last year we sent our paperwork in with the highway mileage certificate for the discontinuance of Ayers Road – Town Highway #40. This highway included Bridge #24 and the discontinuance included giving up town ownership of the bridge. The new map has been corrected to remove the town highway but the town bridge designation still shows.
