Acting on a petition from the residents of Westminster West, Vermont, the Selectmen of the Town of Westminster met at a public hearing at the Westminster Town Hall on October 11, 1983 at 8:00 P. M. to hear testimony from any person owning or interested in land abutting Town Highway #62 and at the same time consider damages if said highway was to be discontinued.

Legal notice of said meeting was published in the Brattleboro Reformer on September 9, 1983 and notices were published in the Town Hall, Shattuck's Store, North Westminster Community House, and Seymour's Store in Westminster West.

Present at the meeting were Selectmen, John F. H. Cook, Chairman, G. Preston James, and John P. Bittner. Also present were William E. O'Connor, Town Manager, Joan R. Sumner, Clerk to the Board, Steve Holmes, W. R. P. & D., Executive Director, Marilyn Jackson, Reporter/Brattleboro Reformer, Ella LeFevre, Town Treasurer, Steve Heavener, Bellows Falls Community Director, and Elizabeth Simonds and Julian Nickerson, Westminster West residents and property abutters.

TESTIMONY: Elizabeth Simonds inquired about culvert and drainage (West Road/down) under portion to be discontinued. Who's responsibility if section of road discontinued.

More discussion followed with Board, Town Manager, Elizabeth Simonds, and Julian Nickerson.

MOTION: John P. Bittner, seconded by G. Preston James, moved the Town of Westminster discontinue the easterly portion of Town Highway #62 which measures .06 miles. This would include the portion of that road that extends from Church Street to the exit opposite the Nickerson house on the South Road. Julian Nickerson to deed his portion of the road to the Town of Westminster (at the Town's expense) for the purpose of maintaining the culverts. So moved.

Following this motion Mr. Nickerson left and the hearing was adjourned.

At a special Selectmen's meeting on January 5, 1984 the Westminster Board of Selectmen met and reviewed the survey maps requested by the Board to designate the area on Town Highway #62 that was voted to be discontinued at their October 11, 1983 meeting.

Present at the meeting were Selectmen, John F. H. Cook, Chairman, G. Preston James, and John P. Bittner, William E. O'Connor, Town Manager, Joan R. Sumner, Clerk, Marilyn Jackson, Reporter/Brattleboro Reformer, Ella LeFevre, Town Treasurer and Larry Martin, 1st. Constable.

MOTION: G. Preston James, seconded by John P. Bittner, to accept the survey by Heman Chase, surveyor, Alstead, N. H. (#311-Vt.) re closing of portion of Town Highway #62.

'The easterly portion of Town Highway #62 which consists of 270'+ (A-B) on survey map dated December 8, 1983 - File No. 2837-1. So moved.

It was also agreed that barriers would be erected in the spring at each end of the discontinued portion of the road.

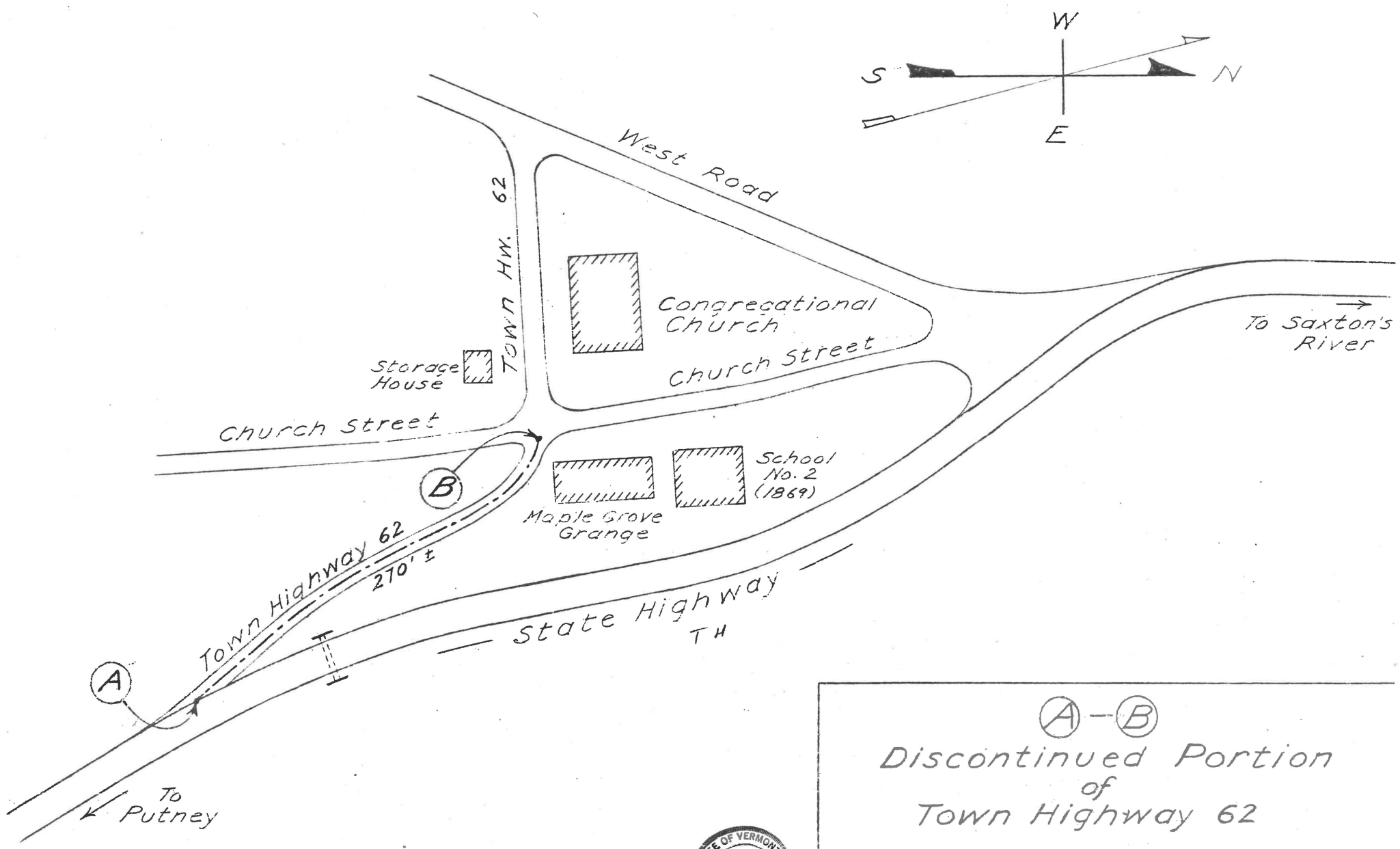

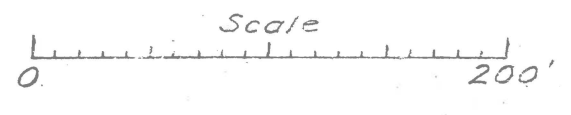

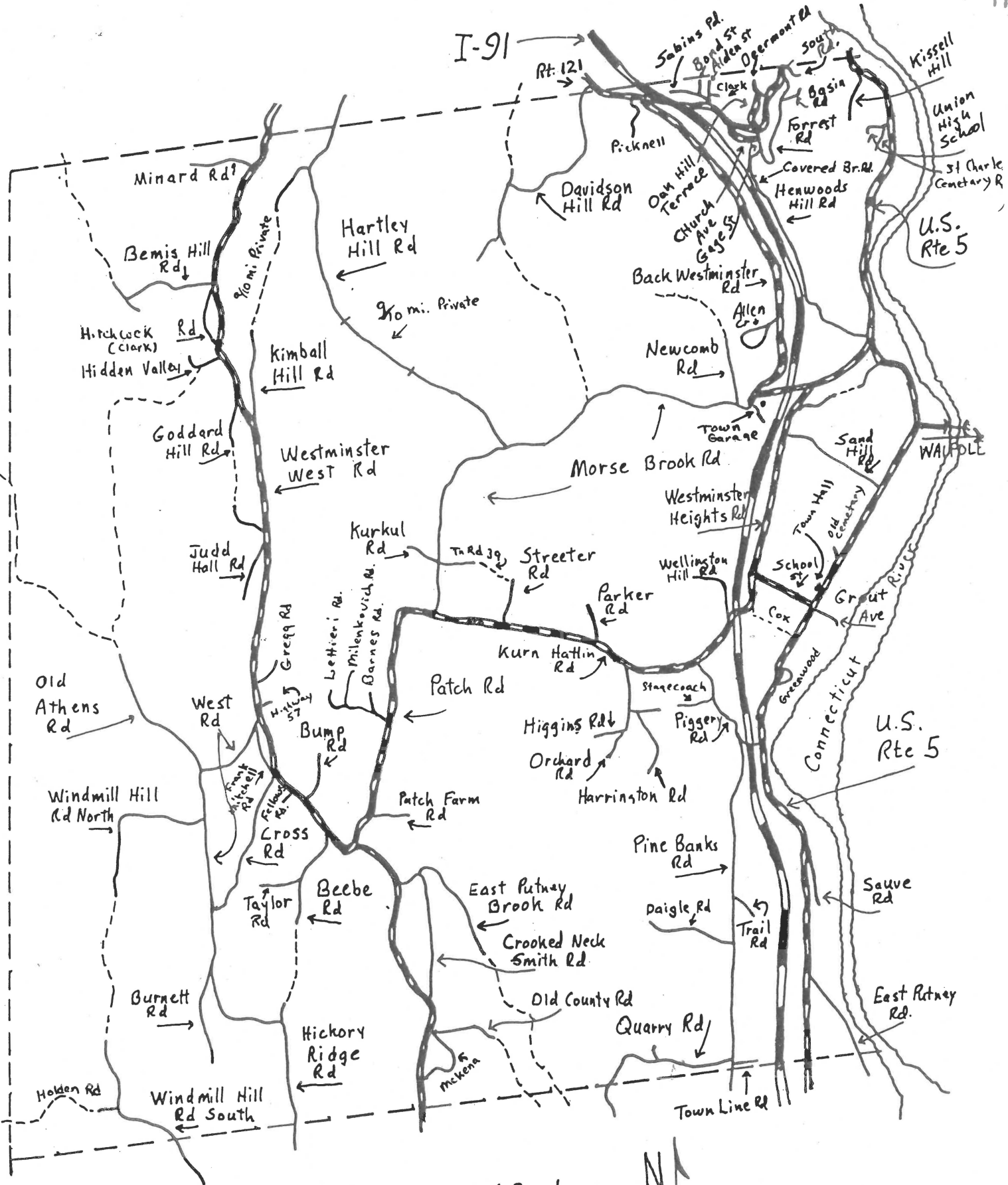


(A)-(B)

 (See Vote of October, 1983.)

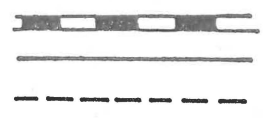
