WHEREAS, Windham Superior Court, in the matter of Chimney Hill Owners Association, Inc., et al, v. Town of Wilmington, Civil Action Docket No: S461-12-96 Wm cv, Honorable John P. Meaker, presiding, issued a Judgment dated 23 December 1998;

WHEREAS, Chimney Hill Owners Association, Inc., gave notice to the Board of Selectmen for the Town of Wilmington it would prepare the following road for acceptance by the Town of Wilmington during 2002: Big Bend Loop.


WHEREAS, Big Bend Loop has been surveyed by William R. Creamer, a Vermont-licensed professional surveyor (No. 681) of Dauchy-Creamer Associates, LLC, and survey thereof (entitled "Survey of "Big Bend Loop" at Chimney Hill, Wilmington, Windham County, Vermont" dated 12/03/02, Drawing No. DC-0169), has been prepared in accord with the standards set forth in 27 V.S.A. § 1403, mylar of which has been delivered by Chimney Hill Owners Association, Inc., to the Town of Wilmington for recording in the public records;

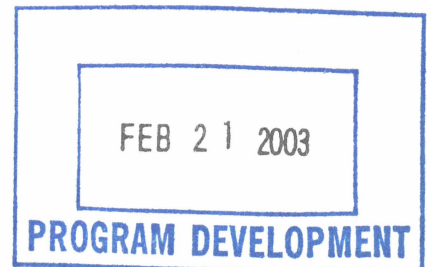
WHEREAS, Edward H. Floyd, P.E., a Vermont Registered Professional Engineer, has certified that he inspected all work as it progressed and has certified to the Town of Wilmington that all work has been accomplished in accord with the terms of the Judgment; and

WHEREAS, the graveled width of the traveled portions of the road identified below have been constructed in accord with the provisions of III(c), (d) and (e) of the aforesaid Judgment;

WHEREAS, Chimney Hill Owners Association, Inc., has caused to be executed Warranty Deed (together with the required accompanying Vermont Property Transfer Tax Return) conveying to the Town of Wilmington fee title in and to the following road: BIG BEND LOOP;

WHEREAS, such Warranty Deed (together with the required accompanying Vermont Property Transfer Tax Return) has been delivered to the Town of Wilmington for recording in the Land Records, to which Deed reference may be had for more particular description of the fee title conveyed;
