DISCONTINUANCE OF LAMERE AVENUE

WHEREAS, in accordance with the authority granted to them under 19 V.S.A. §771, the Trustees of Village of Ludlow deem it feasible to discontinue the highway called Lamere Avenue, commencing at Pond Street and continuing southeast for about 211 feet to the Jewell Brook. That said highway is wholly within the Village of Ludlow.

WHEREUPON, pursuant to 19 V.S.A. §709, the said Trustees did order and appoint that on November 6, 1995, they would examine the said premises and hear the parties interested; and did give notice to David H. Mitchell and Ellen E. Mitchell, as tenants in common, residing, at the time of this writing, at 23 Glen Avon Drive, Riverside, Connecticut, they being the only persons owning or interested in the lands through which said highway passes or abuts, by written notice by certified mail, at least thirty (30) days prior to the time fixed for hearing. Further, pursuant to 19 V.S.A. §709, at least ten (10) days prior to the time set for the hearing, said Trustees gave notice to the local municipal planning commission, posted a copy of the notice in the office of the Town Clerk, and caused the publication of notice in The Black River Tribune, a local newspaper of general circulation.

After performing said procedures, pursuant to 19 V.S.A. §710, on November 6, 1995, said Trustees did examine said premises, and, after hearing the parties interested, were of the opinion, and so judged, that the public good required that the aforesaid public highway be discontinued.

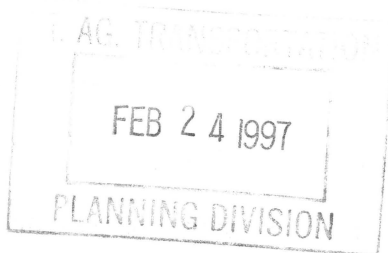
As no claim for damages by the interested party exists it is not necessary for said Trustees to award damages under 19 V.S.A. §712.

Whereupon, it is ordered by said Trustees that said highway, above described and referred, be discontinued, and that it shall be set and belong to David H. Mitchell and Ellen E. Mitchell. Further, said Trustees order that this report of discontinuance of highway be recorded in the public land records of Village of Ludlow.

The foregoing Report and Discontinuance of Highway is hereby adopted by the Trustees of the Village of Ludlow, Vermont, this 12 day of February, A.D., 1996.
