TO: TOWN CLERK and SELECTBOARD

As part of the Ancient Roads legislation, municipalities have the option of mass discontinuing their town highways that are not included on their town highway map by February 10, 2010.

The Mapping Unit has formalized documentation for a mass discontinuance with the creation of a document similar to the Certificate of Highway Mileage. This new document, the Certificate of Mass Discontinuance of Town Highways, provides a check list of the items required by Vermont Statutes Annotated, Title 19, Section 305(h). This document has been enclosed.

If a municipality decides to avail itself of the mass discontinuance provisions in Section 305(h), we request the Town fill out this document and return the original to VTTrans, and file a copy with the Town Clerk. Please note that the decision to mass discontinue town highways as provided by V.S.A. Title 19, Section 305(h) is optional.
